Rector's Annual Report

Dear Friends

'You did not choose me, but I chose you and appointed you that you might go and bear fruit, fruit that will last.' These are Jesus' words in John 15.16. This annual report is packed with signs of life, friendship, spiritual growth and community service. My thanks go to the huge team of parishioners and friends who enable us to continue to serve Hook and our surrounding villages of Heckfield, Mattingley and Rotherwick. Many hours are unseen by most of us, with flower arranging, music rehearsals, administration, study preparations, prayer in the Chapel, serving vast numbers of cups of coffee and tea, cooked lunches and sorting out the drains! Thank you for the faithfulness of all our teams, our Church Wardens, Holy Dusters, Flower, Fabric, Finance and Safeguarding teams, Musicians, Choir and the Director of Music, Band, both PCCs, Benefice Administrator, children's workers, website and Facebook managers, pastoral care visitors, Bible group leaders and sidespeople. What fun we had with Wednesday morning coffees, our games evening, slideshows, gardening party, harvest supper, quiz, and festival services with astonishing music. Thank you to our Ministry team for your reflective ministry, spiritual guidance and service, in leading, in pastoral care, in inspirational preaching, and prayer together and alone.

During 2019 we offered two Ukulele events for our elderly and carers with great joy, and established the weekly Friendship café. In Winchester Cathedral our choir was commended for its high standard in the Royal School of Church Music festival, with award-giving to our singers. We have developed our all age worship band with guitars, flute and voices. We have continued our ministry to children and families with monthly Messy Church, weekly Fingerprints, many child and infant baptisms in Hook, Junior church on three weeks in four, teen Youth Emmaus fortnightly, festival services plus school assemblies and 'Open the Book' Bible storytelling in our preschools and schools across the Benefice, school RE lessons, a Saturday fun day and a Light Party in October. It has been so rewarding to see our young people grow in faith and participation. For our senior members, our home visits and home communions continue, with regular devoted ministry in Old Raven, Geffery's House, and newly Berry Court, plus bereavement care and befriending. We have felt deeply the loss of much loved members of our church family and own families, even as we hold onto our hope of glory in the Lord.

We are unusual amongst parishes in our regular updating of our 'living' Parish Mission Action Plan (pMAP), that enables us to keep moving forward in our vision to grow disciples of Jesus Christ: to enable our worship ('up'), our pastoral care ('in'), our ministry beyond our church ('out') and with other churches ('across' the Benefice and Deanery). With the guidance of our Finance team we structure our financial planning along these lines. It is a privilege to support the mission of Jesus in a variety of places such as Hart Food Bank, local and international charities, and the breadth of Winchester Diocese ministry enabled by our Common Mission Fund contribution. We humbly acknowledge the unseen hard work and sacrificial loving offered from the gifts of individual and family lives.

During 2019 in worship and discussion groups we have explored the ways we live out our everyday faith in Jesus from Monday to Saturday. Now we move into 2020, into a season of appreciating God's grace for each of us and for his world. Let us each individually and as a church family, eagerly seek His grace again, that we be transformed by His love, and grow in radiating that love in our life and witness. He has saved us by His grace alone. May the grace of our Lord Jesus Christ, the love of God, and the fellowship of the Holy Spirit be with us all in 2020.

Statement of Aims

The Parochial Church Council [PCC] is to co-operate with the Ministry in promoting within Hook parish the whole mission of the Church – pastoral, evangelical, social and ecumenical.

The PCC meets generally every other month, with the Standing and Finance Committees in alternate months.

Membership

Members of the PCC are either ex-officio or elected by the Annual Parochial Church Meeting (APCM) in accordance with Church Representation Rules.

PCC Training & Induction

There is a short induction programme for new PCC members.

Committees and Teams

The PCC operates through committees which meet between full meetings of the PCC, their deliberations are received by the full PCC and discussed accordingly.

Standing Committee

This is the only committee required by law. It has the power to transact business of the PCC between meetings, subject to any directions given by the PCC.

Finance Committee

This oversees the general financial work of St John's by monitoring income and expenditure, budgeting, maintaining appropriate financial controls and co-ordinating a review of Christian stewardship of money, including planned giving.

Administrative Information

St John the Evangelist Church is situated on London Road, Hook and is part of the Whitewater Benefice of Hook and HMR (Heckfield and Mattingley with Rotherwick). It is in the Deanery of Odiham under the Diocese of Winchester within the Church of England. The correspondence address is:

During the year, the PCC were required to register with the Charity Commission. This was completed in June 2019 in the legal name which is "THE PAROCHIAL CHURCH COUNCIL OF THE ECCLESIASTICAL PARISH OF ST JOHN THE EVANGELIST, HOOK" and the PCC was allocated the registration number 1183688. The PCC is a corporate body established by the Church of England. The PCC operates under the Parochial Church Council Powers Measure.

Electoral Roll

The Electoral Roll records the names and addresses of all those who consider their spiritual home to be St John the Evangelist, Hook. It is used for a variety of purposes including parish and diocesan communications, and it also determines the number of representatives the church has on the Deanery Synod. Having your name on the Electoral Roll allows you to vote at the APCM. A new Electoral Roll was prepared in 2019 in accordance with the Church Representation rules under which previous roll members had to apply for enrolment.

As at 31st December 2019, the number of people enrolled for St John's was 124. This represents a net increase of 6 since 31st December 2018. Of the 124 persons enrolled as at 31st December 2019, 107 are resident in the parish and 17 outside the parish. The composition of St John's Electoral Roll is 65% women and 35% men. The PCC appreciates the help and support that roll members give to St John's through their prayers, offerings and participation in church life.

Building & Fabric Report

This report was made to the Parochial Church Council [PCC] under section 5 of the Care of Churches and Ecclesiastical Jurisdiction Measure 1991 by Richard Morley and Liz Wilson as churchwardens in March 2020; and is also made by them to the annual parochial church meeting on behalf of the PCC.

The Quinquennial Inspection, which happens every five years, was performed in the summer by Ryan Bunce, a local surveyor. The key aspects requiring future attention are: the pointing on the west wall and the tower, maintenance of the north windows, gutter and area by the vestry door, drainage works. A schedule of these works will be created with work covering the next five years.

In the summer we replaced the flooring in the Narthex and the entrance area of the centre. This has made cleaning and maintenance easier as the covering can be swept, vacuumed and mopped. It has generally met with the approval of users.

Following a generous donation, we commissioned the reinstatement of the gold lettering inscription above the porch. The work has been done as a memorial to the 66 years of service that Gordon Crowder gave to the parish.

In the summer a trial period was arranged for two extra speakers in the chancel to aid the sound as the current speakers only covered the main body of the church. The trial was a great success, and just before Christmas these speakers were installed.

A dead tree and some dying trees and brambles were removed from the grounds at the front of the church. The area between the church and the garage still needs further tidying up, and a decision will need to be made as to the best screening, to aid nature and reduce the view of the garage.

Drainage continues to be a problem, although we have managed to clean the connecting drains in the car park so that water does flow, but not as quickly as we would like. More work is required as we try to cope with increased heavy rain.

Unfortunately, the heavy rain and strong winds is affecting the West window again. Work is ongoing to identify where it is coming in and this will be added to the Fabric Committee's schedule for 2020. Our thanks go to the Fabric Team of Martin, Angelo, Carol-Anne, Kevin and Richard and our gardeners Helen and Terry, whose time and experience ensure that the building and grounds are kept in good order.

Diocesan Synod Report

We had three meetings of Winchester Diocesan Synod in 2019, one of which was within the four-day Diocesan Synod Conference in Swanwick, Derbyshire, October 2019. During the year we approved the Cathedral Vision Document, the Annual Report and Financial Statement, and the Three-Year Financial Plan.

It was noted that the Diocese is dependent on £30,854,000 Common Mission Fund contributions from the parishes over the period 2020-2022. The Common Mission Fund (CMF) reflection group have considered CMF effectiveness and future options. The rising cost of clergy housing is being reviewed. The Deployment Working Group have explored ways to most effectively deploy stipendiary (paid) clergy. The encouragement of Benefice Ministry Teams and Lay leadership training are two areas of focus going forward.

During Synod Conference we benefitted from Professor David Ford's theological lectures on John's Gospel, creative input around the Understanding Christianity Course from the Diocesan Schools' Team, and workshops (one of which I led with the Setting God's People Free [SGPF] team). My role in Winchester Diocese Synod is as a representative of Odiham Deanery, a member of the SGPF Winchester team, and an elected member of the Joint Diocesan Board of Education.

Odiham Deanery Synod Report

The Parish is part of the Odiham Deanery and is represented at the Deanery Synod by Canon Marion de Quidt and Rev'd Shona Hoad (clergy) Martin Rudd, Kim Foster and Jennifer Martin (lay)

Canon Marion de Quidt is the Area Dean. Rev'd John Lenton (Bramley) was the Assistant Area Dean until June 2019 and was succeeded by Rev'd Lerys Campbell (Eversley). Richard Elphick (Sherfield-on-Loddon) continues as the lay chair of the Synod.

There were three meetings of the Deanery Synod in 2019. During the year, the main points of interest were as follows.

- The Odiham Deanery has joined with the Southampton Deanery to build on links The Church of the Province of Myanmar (Burma) in the Anglican Communion.
- A session was held in April at a separate meeting exploring 'Setting Gods People Free'. This is to enable all people – lay as well as ordained - to be involved in ministry.
- Work is being undertaken on a Diocesan Deployment Plan. This is focused on creating viable Benefice Ministry Teams and considering new types of rural ministry.
- The Deanery participated in the *Thy Kingdom Come* prayer initiative during the nine days between Ascension Day and Pentecost.
- Synod members shared with each other progress made on Parish Mission Action Plans (pMAPS)

Whitewater Benefice Ministry Team

It is a special joy to lead our Whitewater Parishes with the whole Ministry Team. Meeting monthly after Morning Prayer together in Hook Chapel, we bring to the table a range of topics alongside our regular worship service planning. During 2019 we were deeply saddened by the illness of Shona's brother Timothy, and by his passing in October, and did all we could to support her through this year.

Within the pattern of Hook worship services, we have maintained our commitment to the Wednesday mid-week Holy Communion and reflective services which are much loved and well attended; and on Sundays our monthly 8.30am Said Holy Communion service, and the weekly 10am main service. On first Sundays we are developing our All Age worship with renewed music band, use of projector and screen, and interactive teaching. On second and fourth Sundays in Hook we celebrate the choral ministry, with full choir and sung responses for the Communion service. On third Sundays the Communion service is shorter, more informal, and we sing some more contemporary hymns, followed in the evening by a wholly Contemporary service with band led music. During the year we have had regular story-telling from our own lives, Monday to Saturday. Members of the Hook family also support the Parish Communion and traditional Evensong in Heckfield, Mattingley and Rotherwick. Hook Church family are faithful supporters of Benefice services, wherever they are held!

We celebrate the ministry of our lay leaders and have supported Brigitte Maynes and Alan Instone to train in Winchester Diocese as Bishop's Commission for Mission (BCM), Pastoral, alongside Richard Blackmore and Rosie Mandry from HMR Parish as BCM Worship. We are sorry to see Alan Instone move to Yorkshire after his magnificent work setting up the Whitewater bi-monthly men's breakfast, and all that he and Joan gave to pastoral ministry in the village and Basingstoke. Thank you to Richard Morley for taking on the men's breakfast in 2020.

I want to say thank you so much for the gifts, generosity of heart and dedication of each of our licensed Ministry team: to Shona Hoad, Peter Hewlett-Smith, Jennifer Martin, Jonathan Bushman, Martin Hoad, and to the two Church Wardens James Trumpeter and Liz Wilson, for all they have given through the year to the monthly Ministry team reflections. Thank you to Tim Maynes for continuing his training as Licensed Lay Minister (LLM), and to Alan Mabey (LLM retired) for his support. The Rev'd Mark Lewis moved back to Yateley in Sept 2018, although the Diocese has continued his licence to the Whitewater Benefice until July 2020.

Ecumenical Ministry

We meet as a group of ministers for lunch and prayer, sharing ideas and supporting one another. Our churches are from Odiham: All Saints and The Vine; Hook: Life Church, Sacred Heart, St John's and those in Heckfield, Mattingley and Rotherwick (HMR). In January 2019 we gathered for a united service in the Elizabeth Hall, Hook during the Week of Prayer for Christian Unity, the theme "Only Justice", materials prepared by the Church in Indonesia. In Hook the Life Church coordinates our advertising at Easter and Christmas, with a village card detailing our services.

The Hook Infant School 'Open the Book' team has members from our three Hook churches. An ecumenical group, including St John's Hook and HMR, lead the annual 'Women's World Day of Prayer' using international resources. Jennifer Martin continues to lead the Tuesday afternoon Bible group in St John's with members from all local churches. Messy Church attracts Christian families from Hook, Rotherwick, and around, each month on Friday after school.

Children, Youth and Family Ministry

The Youth and Families team have worked together to further reach out to the community in Hook. The team consists of adult representatives from the main youth activities in church including Messy Church, Open the Book, Junior Church, Youth Emmaus and Fingerprints. As a team we ran a stall at Hook schools Summer fete making stained glass decorations using laminating pouches and coloured tissue paper and handing out cards for the church. At the end of the summer holidays we had a Friends of Jesus morning celebrating the fact that Jesus calls each of us His friend where 13 people came along.

On October 31st we organised a Light Party to remember Jesus the light of the world, we had games, craft, decorated pumpkins and worship, we attracted over 30 people both from within the church family and also some from outside the church. At the Christmas Cracker the team ran some children's stalls on the Christmas story. At Christmas we repeated the Jesus Rocks campaign, by painting and distributing rocks painted with the baby Jesus, helping spread the message that Christmas is about Christ, the Jesus rocks were then brought to the Crib and Jesus Rocks service for a blessing. Recently in February 2020 we held the Pancake party looking at Lent and Jesus' journey to the cross including craft, games and of course pancakes, 13 children came plus associated adults.

Going forward in 2020 the team will again run a stall at the Hook School Summer Fete, a summer holiday activity the details of which are to be worked out and plan to repeat the Light Party and Pancake party. For Christmas 2020 something different to Jesus Rocks will be planned but will have the same aim of engaging the community with the good news of Christ's Birth. Many Thanks to all those who support the youth and family work across the church, it has been encouraging to meet so many families and young people and to help them move forward in their faith journey.

Junior Church

This now has on average 10 children on a normal Sunday. We have divided into 2 groups most weeks: infants

and pre-schoolers from 3 to 8 year olds and a senior group 9 - 14 year olds. We continue to follow the Light programme by Scripture Union, which is full of good resources. We are grateful for the adult help we receive with most volunteers only committed once a month but are still on the look out for volunteers to help.

We would also like to encourage more young people to come particularly infants and pre-schoolers. Junior Church will continue to meet every Sunday morning, apart from Sundays with all age worship.

Youth Emmaus

The Youth Emmaus group is run for young people aged 13 to University age. In 2019 the Youth Emmaus group continued twice a month on 1st and 3rd Sundays. In 2020 the group will be following a course called Building Blocks For Faith which explores the basic tenets of Christian Faith and the young people will then be offered a chance to be confirmed into the church family. It is a joy to journey with the young people as they grow in faith.

All Age Worship

An All Age Worship team was set up in 2019 with the aim of developing the All Age Worship Service on the first Sunday of each month and attracting families to a more informal service. As part of this, a worship band started in early 2019 and has since grown both in number and in capability. All Age Worship explores new ways of coming to worship and is interactive and aims to have something for all ages and stages of faith. In 2020 we are exploring greater use of Audio Visual equipment and trying to encourage new people to take part in organising and leading the worship in different ways. We are grateful for the hard work of the the All Age Age team, band, sound desk (who have lots of extra work that Sunday!) and sides people. We are encouraged by the support of the congregation and look forward to further developing the service in 2020.

Vocations and Ministry

As a Benefice, we are so grateful for a large team and individuals who are seeking the Lord's guidance for their place of service. Tim Maynes continues to train for Licensed Lay Ministry (LLM) on the Winchester pathway on a bespoke 2 year course. Tim regularly leads Evensong in HMR now, and will be licensed in October 2020 to serve across the Benefice.

Bishop's Commission for Mission (BCM) are Winchester Diocese 'School of Mission' courses which develop reflective theological practice in addition to practical and liturgical training. This last year, Alan Instone and Brigitte Maynes trained as BCM Pastoral missionaries for Hook, and Rosie Mandry with Richard Blackmore as BCM Worship leaders for HMR, all during 2018-9. The commissioning service in Winchester Cathedral on 12th October 2019 was a great joy. Martin Hoad was also Licensed to Whitewater Benefice as LLM (transferring from Salisbury Diocese) in the same service. Thank you to members of our church family for your support. As a Benefice we have supported the training of eight BCM lay ministers, one LLM, and one ordained minister in curacy, plus placement students from the Diocese.

Thank you too for the church family who step forward to lead prayers, study groups, prayer groups, home communions, children's ministry, our music, our welcome, be chalice assistants, readers, lead reflective services, speak about their personal 'This Time Tomorrow', so that we experience the Lord with us in many different ways, and we share as the body of Christ.

Ministry to Old Raven House and Geffery's House

It is a privilege to be invited in to visit residents, lead services and take Communion to many people who would otherwise be unable to go out.

A team of three take Communion to residents of Old Raven every month and the staff and residents alike welcome our visits. For some residents it is the familiarity of the words of the hymn and the service that helps them to remember and it is so profound to be part of this.

Geffery's House is visited usually fortnightly where I am invited to the coffee mornings held weekly as well as visiting residents in their own flats. We have had some Services joined by Stephen and some choir members which the residents help plan and participate. Spring, Harvest Remembrance and Christmas.

Aim for 2020 to restart a Communion service and continue to minister in this place.

Benefice Safeguarding Team

Martin Rudd and James Trumpeter are our Safeguarding officers who work closely with the Rector to ensure that we safeguard children, young people and vulnerable adults in our parishes. This includes our team members as well as our parishioners. We have a dedicated safeguarding email address: safewhitewater@gmail.com. We are in regular contact with the Winchester Diocesan Safeguarding team to ensure all our pastoral workers and trustees are fully trained, and appropriate checks have been undertaken. Martin Rudd is the administrator for the Disclosure and Barring Service checks required during safer recruitment of volunteer and paid workers. During 2019 the stories of the National Church's failure to follow safeguarding procedures have been highlighted in the news. These have shocked and disappointed us all. We would invite any of our parishioners who has a concern to speak to one of us, or the priests in our Ministry Team.

Pastoral Care Team

The Hook Pastoral Care team have met formally just once in January 2019. Pastoral care is supervised by the Rector and in the small group ministries mentioned below. Individual members of the team are dedicated carers for people in our church family, and feedback to Marion and Jennifer Martin (LLM) when needed.

Pastoral care continues within the Holy Communion group and fellowship on Wednesday mornings, within our small groups that meet to read the Bible, and within the Choir. Brigitte Maynes has prepared to be a pastoral assistant (BCM) within 2019, and serves with Jennifer Martin and Joyce Baldock in the nursing homes. Felicity Rudd prepares cards on behalf of the team for those in hospital or sick at home. Carol-Anne Morris and Shirley Clancy (pastoral assistants, BCM) care for visitors to the Friendship Café, Coffee Shop and Chapel. Alan Instone was trained as a pastoral assistant (BCM) but has now moved to Yorkshire. He was dedicated to the Men's Breakfast and midweek meetings. We discuss any matters of concern with regard to vulnerable adults with James Trumpeter or Martin Rudd, Safeguarding officers.

Much pastoral care happens informally after our main services in Hook, and with the fun events planned and led, much by Richard and Gill Morley. I would like to give my thanks also to Mel Lovegrove, who has helped me with pastoral care by being available in the Benefice office, and keeping me up to date when needed. Many members of our church family are friends and listeners, assist informally with shopping and hospital appointments, for which we are so thankful. We have offered two fantastic events for elderly and carers with the Ukulele band. The True Living Centre in Heckfield will be a place of ongoing ministry in 2020.

Committees and Teams

Communications Team

Throughout 2019 the PCC has discussed our communications at regular intervals within the context of our Benefice and pMAPs (both Parishes). An informal social media group, Anna Shergold (website), Caroline Bushman (Facebook) and myself (Twitter) have met nearly monthly to expand our digital communications. In the next year, we are using the software promoted by the Church of England, 'i-Know' to manage rotas and other aspects of Church administration. We continue to appreciate Church Wardens notices', the Pew sheet and Whitewater Magazine. We are now concentrating on formulating processes for ensuring consistency of communication across all the different methods, whether verbal, visual on posters and banners or electronically.

Finance

The Finance Committee met periodically during 2019. Meetings were held to review the financial position, set budget recommendations and discuss the financial matters relating to St John's church activities.

The terms of reference are as follows:

- To manage the day to day financial affairs of the church, including the preparation of accounts and budgets.
- To ensure proper stewardship of finance.
- To review ways of promoting regular giving and Gift Aid.
- To consider longer term financial commitments, as directed by the PCC, and how to arrange financing of these projects if required.
- To ensure compliance with all applicable law and regulations relating to finance matters.

The committee works in conjunction with all other Committees and Teams at St John's and reports to PCC who review and approve recommendations as appropriate.

Parish Mission Action Plan (pMAP)

2019 was a further successful year for pMAP at St John's. We continued with the the actions and objectives set out in our original plan, which was reviewed by our PCC in early 2019 and again later that year. This meant that during 2019, we had some further positive outcomes including: a further increase in numbers of Bishop's Commission for Mission (BCM) lay people being licensed, continued updating of the Benefice/Parish Safeguarding Policies and processes, an expanding ministry in care homes and the introduction of 'Welcome Packs' for new houses in our Parish's. The next review of the pMAP document will be in early 2020.

Other Groups and Activities

School Assemblies

A team of three of us lead worship in Hook Junior School each month. We work with the teaching programme given to us by the School. Notes to the Financial Statements

For the year ended 31 December 2019

1. ACCOUNTING POLICIES

The financial statements have been prepared under the Charities Act 2011 and in accordance with the Church Accounting Regulations 2006 governing the individual accounts of PCCs, together with applicable accounting standards and the Statement of Recommended Practice for accounting and reporting applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) on the accruals basis. The PCC is registered with the Charity Commission with registration number 1183688. The Church is a public benefit entity.

The financial statements have been prepared under the historical cost convention except for the valuation of investment assets, which are shown at market value. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body, nor those that are informal gatherings of church members.

Funds

Unrestricted funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC. **Funds designated** for a particular purpose by the PCC are also unrestricted.

Restricted funds are those funds that must be spent on restricted purposes and details of the funds held and restrictions are provided in note 7.

Incoming Resources

Voluntary income and capital sources

Collections are recognized when received by or on behalf of the PCC.

Planned giving receivable under Gift Aid is recognized only when received. Tax recoverable on Gift Aid donations is recognized when the donation is recognized.

Grants and legacies to the PCC are accounted for as soon as the PCC is notified of its legal entitlement, the amount due is quantifiable and its ultimate receipt by the PCC is reasonably certain.

Funds raised by the fête, garden party and similar events are accounted for gross.

Sales of books and magazines from the church bookstall are accounted for gross.

Other income

Rental income from the letting of church premises is recognized when the rental is due.

Income from investments

Dividends are accounted for when due and payable, and interest entitlements are accounted for as they accrue. Tax recoverable on such income is recognized in the same accounting year.

Gains and losses on investments

Realized gains or losses are recognized when investments are sold.

Unrealized gains or losses are accounted for on revaluation of investments at 31 December.

Grants & Donations

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding obligation on the PCC. Amounts received specifically for Mission are dealt with as restricted funds. All other expenditure is generally recognised when it is incurred and accounted for gross.

Activities directly relating to the work of the Church

The contribution to the Diocesan Common Mission Fund (previously Parish Share) is accounted for when due. Any contribution unpaid at 31 December would be provided for in these financial statements as an operational (though not a legal) liability and would be shown as a creditor in the balance sheet [2019 – Nil]

Fixed assets

Consecrated property and movable church furnishings

Consecrated and beneficed property of any kind is excluded from the financial statements by Section 10(2) (a) and (c) of the Charities Act 2011.

Movable church furnishings held by the vicar and churchwardens on special trust for the PCC and which require a faculty for disposal are accounted for as inalienable property unless consecrated. They are listed in the Church's inventory, which can be inspected (at any reasonable time). For inalienable property acquired prior to 2000 there is insufficient cost information available and therefore such assets are not valued in the financial statements. Items acquired since 1 January 2000 have been capitalized and depreciated in the financial statements over their currently anticipated useful economic life on a straight-line basis.

All expenditure incurred in the year on consecrated or beneficed buildings, individual items under £3,000 or on the repair of movable church furnishings acquired before 1 January 2000 is written off.

Other fixtures, fittings and office equipment

Equipment used within the church premises is depreciated on a straight-line basis over four years. Individual items of equipment with a purchase price of £3,000 or less are written off when the asset is acquired.

Investments

Investments are valued at market value at 31 December.

Current assets

Amounts owing to the PCC at 31 December in respect of fees, rents or other income are shown as debtors less provision for amounts that may prove uncollectable.

The average number of staff employed during the year was two. No employee received employee benefits greater than £60,000. None of the PCC Members were remunerated as employees during 2019 or 2018. The Benefice Administrator is employed by the PCC of Hook Parish but 75% of the cost is recharged to Heckfield, Mattingley and Rotherwick PCC. The amounts shown above include the PCC of Hook Parish's share of the costs.

Three PCC members had travel expenses reimbursed totalling £2,072 [2018 three members - £1,701].

PENSIONS

The PCC of Hook Parish participates in the Pension Builder Scheme section of Church Workers Pension Fund (CWPF) for lay staff. The Scheme is administered by the Church of England Pensions Board, which holds the assets of the schemes separately from those of the Employer and the other participating employers.

The CWPF has a section known as the Defined Benefits Scheme, a deferred annuity section known as Pension Builder Classic and a cash balance section known as Pension Builder 2014, in which the PCC of Hook Parish participates.

Pension Builder Scheme

The Pension Builder Scheme of the Church Workers Pension Fund is made up of two sections, Pension Builder Classic and Pension Builder 2014, both of which are classed as defined benefit schemes.

Pension Builder 2014 is a cash balance scheme that provides a lump sum that members use to provide benefits at retirement. Pension contributions are recorded in an account for each member. This account may have bonuses added by the Board before retirement. The bonuses depend on investment experience and other factors. There is no requirement for the Board to grant any bonuses. The account, plus any bonuses declared, is payable from members' Normal Pension Age.

There is no sub-division of assets between employers in each section of the Pension Builder Scheme.

The scheme is considered to be a multi-employer scheme as described in Section 28 of FRS 102. This is because it is not possible to attribute the Pension Builder Scheme's assets and liabilities to specific employers. This means that contributions are accounted for as if the Scheme were a defined contribution scheme. The pensions costs charged to the SoFA in the year are contributions payable (2019: £51, 2018: £47)

A valuation of the Pension Builder Scheme is carried out once every three years. The most recent was carried out as at 31 December 2016. For the Pension Builder 2014 section, the valuation revealed a surplus of £1.8m on the ongoing assumptions used. There is no requirement for deficit payments at the current time.

The legal structure of the scheme is such that if another employer fails, The PCC of Hook Parish could become responsible for paying a share of that employer’s pension liabilities.

8. RESERVES

The PCC considers that it is appropriate to hold reserves equal to three months expenditure, including the PCC's contribution to the Diocese's Common Mission Fund, to cover the running costs – this equates to £24,367 based on the 2019 expenditure levels.

In addition, a designated reserve was created in 2013 which was originally established to cover the expected costs of redecoration over a 5 year period. In 2019 the reserve was reduced by £5,625 to cover part of the cost of work carried out on the flooring in the Narthex. This fund has a balance of £201, which is part of the Unrestricted Funds.
