ASF is keen to offer a range of support to people in Pakistan living in poverty. For young people, we aim to provide hope by supporting the cost of education for those who come within our scope and are identified as coming from poor backgrounds who cannot afford educational provisions. The need in Pakistan and we wish we could do more, and we plan to do more.

For people of working age and able bodied, we aim to offer support in the attaining a livelihood, with the simple principle of *teach* a man to fish and he can feed himself.

The last year has been extraordinary with the impact of covid 19 over the past two months overshadowing everything ASF did in the first half. This cannot be ignored, many needy people in Pakistan benefited from the Chair's visit in the summer of 2019 where the impact of ASF was felt by many families through the donations and purchases made by ASF in accordance with its charitable objectives.
