Structure, governance and management

The charity is a charitable incorporated organisation (CIO) and was formed on 21st April 2015 and was entered on the Charity Commission register on 13th May 2015 (CIO No: 1161661). It is governed by a constitution of Charitable Incorporated Organisation. There is no liability of the trustee in the event of the charity being wound up.

Objects of the organisation

The charity's objects are:

- 1) to help young people, especially but not exclusively through leisure time activities, so as to develop their capabilities that they may grow to full maturity as individuals and members of society;
- 2) To preserve and protect the environment;
- 3) To relieve sickness and to preserve and protect good health;
- 4) To advance education; and
- 5) To promote for the benefit of the inhabitants in Thornton Lodge and surrounding areas of Huddersfield without distinction of sex, sexual orientation, race or of political, religious or other opinions, by associating together the said inhabitants and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and other leisure time occupations with the objects of improving the conditions of life of the said inhabitants and in furtherance of this to establish or secure the establishment of a community centre (hereinafter called 'the centre') and to maintain and manage the same (whether alone or in co-operation with any local authority or person or body) in furtherance of these objects."

Change of structure

The Association changed it legal structure by resolution on 21st April 2015 from an association to a charitable incorporated organisation (CIO). on this date the Association assets comprising of a laptops, sewing machines and sport equipment were transferred.

Financial review

The net receipts for the year were £120,303.00 including net receipts of £10,088.00 on unrestricted funds and net receipts of £120,303.00 on restricted funds.

Reserves policy

The charity's free cash reserves at the year end were £39,772.00

The trustees have adopted a formal reserves policy of 6 months running costs

Thornton Lodge Action Group Trustees Report

Chairperson Report - 2019-2020

I am delighted to present this year's Annual Report after a busy year at the Thornton Lodge Action Group, with some highs and some lows.

Our 2019/2020 year was in its final quarter when Coronavirus (COVID-19) burst open the world- the first modern pandemic. Since January 2020 there has been, in the UK and elsewhere, business destruction like we've never seen, despite government intervention. Entire sectors of the economy have shut down. The implications for funding for the environment and for charities like Thornton Lodge Action Group are stark.

The Group had a successful year leading to the end of December 2019. True to form, the Charity has developed outstanding projects to address gaps in services across our 4 key themes

Education & Training.

This strand supported over 600 participants over the financial year. We supported 120 participations to improve English language and supported social integration into our communities. We also supported unemployed residents to move closer to the labour market. Women into Enterprise is one example, funded by the ESF and distributed by Groundworks UK. The project set out to nurture hidden talent in BAME women in our community and build capacity so they can move towards self-employment.

Health and Wellbeing:

Our successful Mix and Fit project came to a close this year, but the local residents continue to meet and benefit from the weekly social and fitness sessions. Staff are working with residents to reflect on the current project and aim to drawdown new funds and continue the project. I am optimistic the team will secure funds to make this happen.

Sports and recreation:

This strand was hardest hit last financial year with the closure of all youth funded activities and services. Staff and trustees have worked extremely hard on this strand to bring inward investment of just under £30,000 to address youth services, holiday hunger and knife crime which is infiltrating our community.

Environment:

Developing low carbon communities has been a priority for Thornton Lodge Action Group. We have worked with the local community over the year to educate them on waste reduction, home energy reduction and looking at renewable energy. Our E-Click has been a success seeing over 60 households take up small workshops to learn how to reduce energy, reduce utility bills and at the same time gaining value transferable IT skills. Many who joined the project did not swap energy suppliers in the last 10 years nor heard about price comparison websites.

We aim to build on our successes but know 2020/21 is likely to be a deeply disrupted year for the Action Group as projects and funding are delayed, postponed or cancelled. Thornton Lodge Action Group has reasonable financial reserves which, along with some operational restructuring, will allow us to continue to serve the community of Thornton Lodge. I need hardly stress the community of Thornton Lodge need our support more then ever. It is now well documented BAME community are disproportionally affected by the virus, we will strive to serve them in this time of hardship.

I would like to express my heartfelt thanks to all the staff at Thornton Lodge Action Group. In these grim times, with the encouragement of and direction from TAG trustees, staff and volunteers have demonstrated their affection for and commitment to serving the local community, as well as an ability to refocus priorities and adapt to challenging new circumstances. Finally, may I thank my fellow trustees for their support and for their encouragement in helping me fulfil my role as Chair of Trustees.
