Elistree and Borehamwood Museum

April saw the opening of the first of our two successful exhibitions this year, with a look back to the 1960s and the



Lynx Club in Borehamwood. This was picked up by Three Counties Radio on their Treasure Quest Programme who sent their 'Treasure Quest' reporter, Danny Fullbrook, to the Museum on Saturday 18th May. Because the Museum was the final answer (i.e. The Treasure!), he only just made it before the midday deadline. He even tried on one of the Beatle wigs and moustaches and played the guitar on the Lynx stage.

The Reminiscence group meetings continued to be a great success with a regular, steady group of attendees of around 20-26 members. Dave set a new theme; 'It's My Life' which involves individual members of the group providing him with 30 photos of their life in Elstree and Borehamwood and he creates them a slide show, which they then present to the group. This has proved to be very popular.

Richard Hardy sent a donation of £100 from Canada in acknowledgement of the Museum continuing to be custodian of the family's archive collection. He thanked the Friends for regularly sending the Newsletter and praised its content. His donation was put towards digitising a collection of 8mm movie footage of Borehamwood in the 1960s, which had been given to the Museum's collection.

As mentioned, the Newsletter continues to be an excellent read and well put together by volunteer Simon Gee.

HertfordShire

October saw the preparations put in place for the forthcoming Year of Culture in 2020. Dave Armitage attended a special forum meeting of Hertsmere groups, on behalf of the Museum, to discuss ideas and plans for

involvement in the exciting activities.



October was also when the launch of the second successful exhibition of the year took place: Holby City at 20: Go Behind the Surgical Mask. One of the popular programme's cast, Bob Barrett (aka Sacha Levy), came to open the exhibition and his endorsement on Facebook set off an avalanche of new members and interest in the Museum.

Bob appeared again in December for the annual Christmas Lights Switch On. The Museum opened specially for the occasion and received 83 visitors in an hour!



Year of Culture

At the beginning of December, Dave Armitage joined Trustees Elaine and Clive Butchins in Peterborough for a new event organised by SHARE Museums East for Trustee Training. This was attended by a range of Museums from around the region. Elstree and Borehamwood Museum was ahead of the crowd in terms of good practice and achievement. Well done all.

3. Exhibitions



Good Vibrations! A look back at the 1960s in Borehamwood.

May – October 2019

Instigated and led by Simon Gee, the volunteers excelled themselves in transforming the Museum into a recreation of the 1960s

local youth club and music venue called The Lynx. Original artwork and designs from the Club were used to reproduce the Lynx. A large screen showing footage of bands playing at the time, added to the atmosphere. Not content with this, the volunteers built a record shop complete with a record player, racks of vinyl and a listening booth. This was a fantastic exhibition and linked with some fun school visits and a Lynx reunion event in September.

October 2019 - April 2020

Following over a year of discussions and planning with the BBC, the exhibition finally became a reality in October. A team of BBC production members from Holby came over and installed the exhibition over two weeks. As agreed, the exhibition took over the entire museum with a view to recreating one of the

show's actual operating theatres. A few gory lifelike

exhibits were included but detail is all; even down to the costumes, the instruments and the surgical masks.

The exhibition proved immensely popular, with visitors coming from far and wide and fans even coming to spend their birthdays at the



Museum. Museum volunteers John Woolston and Simon Gee co-ordinated making up some birthday cards to mark the occasion, which were then presented to these guests when they arrived.

4. Events

The Museum participated in the Town Festival Flower Festival with a display called Good Vibrations for the 'Celebrations' theme.



The Annual History Walk took place on a hot Sunday in June around Elstree.



Dave Armitage led the walk, assisted by John Woolston and the pair had carried out much research on the village. They were joined by 29 walkers who learned about the fascinating history on their two-hour walk.

Families Day in Meadow Park took place on the hottest day of the year! The Museum's theme was the 1960s, in line with the Good Vibrations exhibition. A few

people turned up to play Twister, but it was too hot to dress up in the 60s clothes provided.

The Lynx Club reunion evening was held on a Saturday night in September, in conjunction with the Good Vibrations exhibition. It promised a look back at the 60s with an evening of sixties clothes, sixties food and sixties sounds. It wasn't a disappointment. The event was so popular with those who spent time at the Lynx in the 60s (and also those who didn't!) that we were asked if this could be a regular event. The event raised £218 and there are plans for a repeat in 2020.



Dave Armitage gave a talk to the Borehamwood W.I. and one other to the Radlett U3A History Group.



In November, the Museum remembered the men of Elstree and Borehamwood in All Saints Church with a display commemorating the 75th anniversary of the D Day Landings. The panels contained details researched from materials provided by the British Legion.

The wreath was laid on Armistice Day by Paul Welsh on behalf of the Museum.

Saturday January 25th – A Year in Photos display at All Saints Church. This was the first of this year's regular coffee mornings, organised by Elstree and Borehamwood Town Council and an Exhibition of community organisations presenting 2019 A Year in Photographs.



5. Learning and Outreach

In October 2019, Parkside School visited bringing Thirty-five 7 year olds. They enjoyed Sixties themed activities, including designing their own record sleeve.

The Jewish Primary School were given a presentation in early February 2020 to 60 children.

The following month, St Teresa's school was back again, this time for two visits with a total of 59 children.

6. Friends and Volunteers



At the beginning of December, the Friends of the Museum held a special Evening to celebrate the exhibition, Holby City At 20. The guest speaker was the chief medical adviser to the programme, Dr Shyam Kolvekar. His main 'job' is being the Consultant Cardiothoracic Surgeon at St Barts Hospital, but he has been the Holby adviser since the show began, making sure that all the medical terms and scenarios are completely accurate. He has also worked on medical documentaries and wherever his expertise is called for.

On Monday 27th January, Communities First held a Volunteering Exhibition at which all the local charities prepared stalls to advertise their organisations and try to attract new volunteers. In the rear hall of 96 Shenley Road the Museum valiantly displayed our recent activities for the last year hoping to gain a few new helpers. Unfortunately, the flow-through of interested viewers was rather slow.

Volunteer meetings

These were held on six occasions during the year and gave the volunteers a chance to ask questions about museum operations and inform them of forthcoming events. 1 Accounting policies

Basis of preparation

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts. The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014, and with the Charities Act 2011.

Recognition of income

Income is included in the Statement of Financial Activities (SoFA) when the charity becomes entitled to the resources, it is more likely than not the trustees will receive the resources and the monetary value can be measured with sufficient reliability.

Grants and donations are only included in the SoFA when the general income recognition criteria are met.

Income from membership subscriptions

Membership subscriptions received in the nature of a gift are recognised in Donations. Membership subscriptions which gives a member the right to buy services or other benefits are recognised as income from charitable activities.

Income from interest

This is included in the accounts when receipt is probable and the amount receivable can be measured reliably.

Volunteer help

The value of any voluntary help received is not included in the accounts but is described in the trustees' annual report.

Stocks

Goods provided as part of a charitable activity are measured at net realisable value based on the service potential provided by items of stock.

Liability recognition

Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

Provisions for liabilities

A liability is measured on recognition at its historical cost and then subsequently measured at the best estimate of the amount required to settle the obligation at the reporting date
