Objectives and activities	

Summary of the purposes of the charity set out in its governing document

Tang Hall Community Centre (THCC) delivers its objectives through the provision of a good quality, welcoming and vibrant community facility. The achievements of THCC over the past year of operation are highlighted in this report

The Objects of the charity as included in the Constitution are:

To promote the benefit of the inhabitants of Tang Hall by associating with the inhabitants, statutory authorities, voluntary and other organisations in a common effort to advance education and provide facilities for social welfare, recreation and leisure in order to improve the conditions of life for the inhabitants.

To maintain and manage the Community Centre in furtherance of the object above.

The Constitution obliges the Trustees to apply the Charity income to such charities and for such charitable purposes and in such proportions and in such manner and subject to such terms and conditions as they may determine

The Board members bring a wealth of experience to the organisation and a varied mixture of skills and backgrounds. Local residents, education, business, community, charitable and finance backgrounds equip the board with the necessary resources required during discussions regarding strategic plans and decision making.

The Board undertakes processes that ensure our charitable activities are based on a sound governance ground. Such processes include DBS checks on staff as necessary, development of relevant policies and ensuring that appropriate indemnities are in place to protect the liabilities of the charity.

Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts

1. To promote the benefit of the inhabitants of Tang Hall without distinction of sex, sexual orientation, age, disability, nationality, race or of political, religious or other opinions, by associating together the said inhabitants and the statutory authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and leisure time occupation with the object of improving the conditions of life for the said inhabitants.

2. To maintain and manage the Community Centre (whether alone or in co-operation with any statutory authority or other person or body) in furtherance of the objects.

The Trustees confirm that they have complied with the duty in Section 17(5) of the 2011 Charities Act to have due regard to guidance published by the Charity Commission in respect of public benefit. That guidance outlines the need for all charities aims to be demonstrably for the public benefit. In planning the activities for the year, the Trustees have kept in mind the Charity Commission's guidance on public benefit at the Trustee meetings.

Our Mission: Tang Hall Community Centre provides and maintains facilities at the heart of Tang Hall. We bring local residents together for advice services, leisure and recreation. All with the aim of providing access to learning experiences and improving the quality of life for the local community.

Our Social Objectives: To provide a welcoming and vibrant meeting place for local residents. To provide facilities for services covering social and welfare advice, leisure and recreation for everyone.

What we do: Manage, maintain and enhance the fabric of the Community Centre. Act as a landlord providing good quality office space to local voluntary organisations.

Encourage a wide range of groups to run from the Centre. Providing learning experiences and a good quality of life for local residents.

Achievements and performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.

Message from the Chair

This has been another hugely successful and rewarding year for Tang Hall Community Centre with significant successes with winning grant funding to support projects delivered with our partners and our amazing community members. Eight days before the financial year came to an end, we were faced with forced closure of the centre due to the COVID-19 pandemic and the need to reconfigure our services as we re-opened on Saturday 27th March as the Tang Hall Food Distribution Hub on behalf of the City of York Council. I'd like to thank my fellow trustees, the Centre's staff, volunteers, our tenants and the Centre's users for their tremendous work, support, commitment and fortitude as we've all moved into a very uncertain future. I will talk about the period from April 2019 to 23rd March 2020 below and return to the COVID-19 pandemic in our outlook for the future.

Over the year our major projects were the continued development of the Tang Hall Food Coop and delivery of community based nutritious food focused projects.

We would like to thank our funders who made the projects possible and thank them for their continued support in numerous ways at the centre. These include Awards for All, Morrisons, People's Health Trust, Two Ridings Community Foundation, The Joseph Rowntree Housing Trust and Tang Hall Big Local.

Our Treasurer, Ian Purcell, has continued to work with our Centre Manager and administrative staff to work to a series of strong financial controls and processes. Ian, Stephen Collins and Kim Hill have done a fantastic job. Thanks to this hard work the Centre's accounts are in an excellent position. We continue to build a secure and sustainable financial position for the centre for the long-term. The outlook as I was able to say last year is tremendously positive.

We have also worked hard as a staff and trustee team to build an effective and successful funding strategy. Due to a successful grant award in 2019 we have been able to employ a part time fundraiser. Her successes have allowed us to grow our staff numbers and the range of activities running from the centre and to provide a physical environment that people want to visit and use. Our team is always looking at how to best serve the needs and aspirations of our community and I'd like to thank them for doing such an excellent job.

The fantastic teamwork that is taking place amongst all groups running, using and supporting the centre has allowed the number of organisations and local residents using the Centre to continue to grow. The Centre is at the heart of our community. People of all ages, backgrounds, needs and interests attend regularly and actively want to join in. Many people have found support, learning opportunities and fun activities. The centre has a wonderful sense of friendship, fun, acceptance and openness. I couldn't be prouder to be involved with Tang Hall Community Centre and everyone associated with it.

The continued growth of the Centre is in large part due to the welcoming, inviting and inclusive environment the Centre's manager, Stephen Collins, has created. Stephen has been managing the Centre for four years and the positive change, innovation and welcoming environment he's created have had a huge impact. I would like to thank him for the skills, energy, time and passion for developing the Centre that he brings to I also wish to record my thanks to the rest of the staff team: Kim Hill who works in the office and brings significant skill to the Centre's finances, bookings and dealing with enquiries. To John Wilson who keeps the Centre clean, Beena Box, Joanne Lamb and Elizabeth Deighton who have continued to develop the activities run from the Tang Hall Food Co-op. Diane Hall has been an extremely valuable addition to the team bringing external fundraising expertise to our team allowing further extension of projects and ongoing improvements to the building.

We have a stable board of trustees. The team is working exceptionally well together and is focused, efficient, open and supportive.

The building is in need of constant care and attention but significant improvements to the fabric have been made. It was built in 1992 and will always need significant investment particularly if we are to reach our environmental targets for making it a sustainable building. We continue to focus on bringing renewable energy sources to the centre potentially including solar panels and ground source heating. These will provide greater financial and environmental sustainability for the Centre. We will need significant financial support from funders to be able to achieve this.

I would like to thank everyone who has brought so much time, vitality, joy and skill to the Centre. It really couldn't run without the tremendous input of commitment, energy and passion that so many of my colleagues, friends and our community bring. We are all tremendously proud of what continues to be achieved at the centre and the community bonds we are building on a daily basis but we are acutely aware of the challenges we face as an organisation due to the ongoing pandemic and the health and economic impacts it leaves in our community. The centre will be instrumental in supporting the needs of the people and families who live around us over the coming months and years. We feel the financial probity we've embedded over the past couple of years and the shared sense of community attachment will bring us through this tremendously challenging period but only time will tell.

Over the past twelve months, the range and number of activities and services running from the Centre have continued to increase. The number of Centre users has also continued to grow.

We measure our benefit to the community from the number of residents attending the broad range of activities available to them and through their positive feedback concerning their experiences of using the Centre.

Plans for Future Periods

The year 2020-21 will be a period of building on the successes of 2019-20 and responding to the COVID-19 pandemic, its effects on our community members and our organisation's finances. We will continue to develop the facilities and activities available to the community and make sure they are provided with the resources and services they will need to weather the storm caused by the COVID-19 outbreak. We will consult with local residents, asking them what services and activities they would like to see offered at the centre. We aim to make the Centre increasingly welcoming and accessible to all our community while still working within safe operating procedures outlined by government COVID-19 guidelines. There will be a strong drive to improve the environmental sustainability of the Centre. The trustees will consider installing renewable energy sources in order to reduce the carbon footprint of the Centre and to reduce recurring running costs.

We will further review and develop our funding and marketing strategy with a focus on the long-term financial sustainability of the Centre. We will need to focus efforts on plugging the income gap we are likely to suffer over the coming months. We will continue to consider and investigate alternative funding streams including regular giving by individuals and corporate sponsorship but are aware the opportunities within these areas may be limited due to the financial impacts of the COVID-19 outbreak.

Financial review

Review of the charity's financial position at the end of the period

The centre had a successful year recording its highest recent unrestricted surplus of £6,644 (18/19 £2,015) which was £4,781 above budget. This surplus was primarily due to increased income of £1,500 from tenant TCV in lieu of them no longer carrying out ground maintenance works, Grants of £1,000 each from Albert Hunt and Persimmon Homes together with £681 from Aviva staff crowd funding/payroll giving.

The Charity's principal source of funding came from office rental and room hire income. During this time the Charity received support from a number of grant-giving bodies to support maintenance work to the building and project work. Grants were received from Tang Hall Big Local, Joseph Rowntree Housing Trust, The People's Health Trust, Two Ridings Community Foundation, Awards for all and Morrisons.

The charity's total income for the year was £125,086 This was split between Charitable Trusts and Foundations and office and room rental

43% - Charitable Trusts and Foundations57% - Office and room rentalMoney was spent on building maintenance and running costs, staff employment costs and project work.

27% - Building maintenance and running costs47% - Staff employment costs26% - Project work

There are no concerns about the charity continuing as a going concern.

Further financial review details

The centre closed for normal activities on the evening of 23rd March with some of its core staff being furloughed and reopened on the 24th March as a food distribution hub on behalf of CYC. To the end of March, we received £500 in rent which is included in Hall room hire resulting in our hall hire income being £31 above budget.

Our Balance Sheet looks healthy but as cash flow is critical in todays climate it is important that we stay on top of our debt collection

At 31st March our general reserves were £32,980 which will give us in excess of 5 months working capital. This together with the Government Job Retention Scheme, Rental of the Centre by CYC and Business Rate Grants and also income from Rents as against Room Hire Charges will hopefully see us through the Covid-19 crisis but like other organisations a lot will depend on how quickly life returns to normal after the lockdown restrictions are eased/lifted.

Once again the treasurer would like to express his appreciation to Stephen and Kim for the diligent way they have kept the financial records and their efforts in assisting him in preparing the accounts.

The Centre operates a reserves policy in which we carry four months running costs for the community centre in general reserve.

1 Basis of preparation

1.1 Basis of accounting

The financial statements are prepared under the historical cost convention and the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (Charities SORP (FRS 102)).

1.2 Change of basis of accounting

2 Accounting policies

Income and endowments

Recognition of income

These are included in the Statement of Financial Activities (SoFA) when:

Incoming resources with related expenditure

Where incoming resources have related expenditure, the incoming resources and related expenditure are reported gross in the SoFA.

Grants and donations

Grants and donations are only included in the SoFA when the charity has evidence of entitlement to the resources and receipt is probable.

Volunteer help

The value of any voluntary help received is not included in the accounts but is described in the trustees' annual report.

Investment income

This is included in the accounts when receivable.

Expenditure and Liabilities

Expenditure

Raising funds

Cost of raising funds comprise those costs associated with attracting voluntary income.

Charitable activities

Charitable activities expenditure comprises those costs incurred by the charity in the delivery of its activities and services. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Liability recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

Fund accounting

Unrestricted funds are funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Restricted funds are funds which can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor.

THBL (Food Coop)

A capital grant to increase the provision of the Tang Hall Coop

Awards for All

Bringing the local community together to learn how to grow organic fruits & vegetables at the community centre. **Morrisons**

A capital grant to replace the front doors of the centre with automatic doors , making the centre more accessible **Two Ridings**

Funding to employ a grants officer for one day a week for one year, with the aim of increasing the number of grants the centre can apply for
