TRUSTEES' REPORT

The Trustees present their report and accounts for the year ended 30 June 2020.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Whisper's trust deed, the Charities Act 2011 and the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (Charities SORP FRS 102) issued on 16 July 2014.

Structure, governance and management

Whisper was established by a charitable trust deed on 19 June 2010. The trust deed was revised in March 2020 to reflect the charity's current activities more closely.

The Trustees who served during the year were:

Veronika Cejpkova and Antonio Genco founded Whisper and the additional trustees were recruited by word of mouth or through the Charity's online presence. They were appointed after face to face interview and letters of appointment are in place. Veronika Cejpkova is Whisper's Chairperson, Antonio Genco is Treasurer and Eugenia Barnett is Secretary.

The Trustees have assessed the major risks to which the Charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

Objectives and activities

Whisper's objects are to advance healthcare, to advance education, relieve financial hardship and promote the good health of children in Uganda. The policies adopted in furtherance of these objects are the provision of medical care, community services and schools in Uganda.

The Trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities Whisper should undertake.

Total patient numbers were down this year because of the transport disruptions and economic hardship from the COVID-19 lockdown between April and June 2020. The maternity unit remains very popular. The 2018-19 treatment cost figures in the above table have been adjusted to include donations made to Whisper's Ugandan branch.

The hospital is open 24 hours a day, 7 days a week and its specialties are emergency medicine, blood transfusions, malnutrition and burns. As with most charity hospitals in Uganda, patients pay a subsidised fee for medical services, but the fees for treating children are set at a level that most families can afford, they are set at a flat rate so that charges do not accumulate even for lengthy treatments, and children are not turned away. Around 20% of the patients are seen at no charge. The hospital's good reputation means that many patients travel long distances, some even coming from beyond Uganda's capital Kampala which is 3 hours away by road.

Many of the emergency cases that Whisper sees need blood transfusions on admission. This is a problem in the local area because blood stocks are erratic and the nearest blood bank is 3 hours away by road. By ensuring adequate blood stocks, Whisper has been able to save many lives that would likely otherwise have been lost.

Whisper's impact

During Whisper's financial year 2019-2020, a patient was treated for every £20.48 in donated funds, or £24.13 if the hospital's startup costs are included, amortised over 5 years. An average number like this hides a lot of detail, but it can still be helpful when comparing one charity with another. The higher cost per patient this year was due to the coronavirus lockdown.

How we calculated this

In financial year 2019-2020, the hospital saw 10,946 patients. Whisper received £224,000 in donations that were not restricted donations for non-hospital activities. To find the cost in donated funds per patient, we divided that sum by the number of patients. The startup costs for Whisper's hospital were approximately £200,000, spent during 2016 and 2018.



We estimate that Whisper **saved a life** that would not otherwise have been saved for every **£1,132** in **donated funds**, or £1,334 if the hospital's startup costs are included. Despite the higher costs this year, supporting Whisper remains a very high-impact way to promote healthcare.

COVID-19 lockdown

At the time of writing (July 2020) there have been over 1000 cases of the COVID-19 respiratory virus in Uganda, with two deaths. The Ugandan COVID-19 lockdown began on 31 March 2020 and hit the country hard, with a public transport ban and a stay at home order. Without public transport, emergency cases died before they could reach hospitals², which in any case were severely understaffed because of the lockdown³.

Whisper's hospital remained open throughout the lockdown. The hospital was well stocked with medicines, and masks and hand sanitiser for staff and patients. Healthcare workers had no general exemption from the travel restrictions, so many of Whisper's staff had to live at the hospital, while others were brought in by car. Whisper provided a fleet of 4 cars to transport emergency cases to the hospital or to any other medical facility as required. All fees were waived for malnourished children and their guardians. Thanks to a generous donation from an individual donor, Whisper was able to provide free treatment for all for 12 days from 29 April to 10 May.

Education and research

Whisper's staff receive continuing professional development training via teleconference from the Global Nurse Network and the Galen Center for Professional Development in the US. All our nurses complete Galen's Certified Pediatric Nurse programme.

Whisper has been providing practical experience for students from the nearby Kyabazinga School of Clinical Officers. A Clinical Officer in East Africa is similar to a Physician Assistant in the US, or to the recently introduced role of Physician Associate in the UK. They undertake 3 years of training followed by 2 years of internship.

Whisper occasionally funds staff to attend part-time diploma and degree courses.

Whisper's international branches

Whisper the Union for Childcare, Outreach and Education is the organisation through which Whisper provides its services in Uganda. It is registered in Uganda as an International NGO and its website is https://www.WhisperOrphans.org/ug. Veronika Cejpkova normally lives in Uganda and is employed by the NGO as its Country Director.

Nadační fond Whisper is Whisper's Czech branch and caters for the charity's growing supporter base in the Czech Republic. It is run by Markéta Malecová, a volunteer, and its website is https://www.WhisperOrphans.org/cz

The branch had an excellent first year. As well as a strong fundraising performance, it found local corporate sponsors and supplied numerous medical volunteers for the hospital in Uganda. In March 2020, Markéta was interviewed on Czech national TV⁴.

Financial review

The COVID-19 lockdown has been challenging for Whisper and we are very grateful for the extra support provided by a number of individual donors during this time. In 2019 there was £12,000 of capital spending on a site for a future hospital; this was funded by specific donations designated for that purpose. In September 2019 Whisper had a sponsored swimmer in the Swim Serpentine event. Whisper depends on continued donations and in particular there is a need for additional regular monthly donations.

Whisper's policy is that unrestricted funds that have not been designated for a specific use should be maintained at a level equivalent to between three and six months' expenditure. The Trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the Charity's current activities while consideration is given to ways in which additional funds may be raised. At the end of the year, reserves covered just one month's expenditure.

NOTES TO THE ACCOUNTS

For the year ended 30 June 2020

1 Accounting policies

1.1 Basis of accounting

These accounts have been prepared under the historical cost convention with items initially recognised at cost or transaction value unless otherwise stated in the notes to these accounts.

The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (Charities SORP FRS 102) issued on 16 July 2014, the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS 102) and the Charities Act 2011.

Whisper is a public benefit entity as defined by FRS 102.

The accounts are presented in sterling and rounded to the nearest pound.

1.2 Going concern

The trustees consider that there are no material uncertainties about Whisper's ability to continue as a going concern.

1.3 Income

Income recognition

Income is included in the Statement of Financial Activities (SoFA) when the Charity becomes entitled to the resources, it is more likely than not that the Trustees will receive the resources and the monetary value can be measured with sufficient reliability.



Offsetting

There has been no offsetting of assets and liabilities, or income and expenses, unless required or permitted by the FRS 102 SORP or FRS 102.

Donations and legacies

Grants and donations are only included in the SoFA when the general income recognition criteria are met (5.10 to 5.12 FRS 102 SORP).

Gift Aid

Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of the appeal have specified otherwise.

Volunteer help

The value of any voluntary help received is not included in the accounts but is described in the Trustees' annual report.

1.4 Expenditure

Liability recognition

Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

Governance

Governance costs comprise all costs involving public accountability of the charity and its compliance with regulation and good practice.
