

4 The Trustees have been advised by the managing agents, Marshall Clark LLP that as at 31 December 2019, sums are due from the tenants, in respect of Rent, maintenance costs and insurance.		
5 The properties at 2,4,6,8 & 10 Sea Lane Rustington were valued by the Inland Revenue on the death of Mr Humphrey in 1983. No further valuations have been obtained.
