Greenwich Parks Forum acts as an umbrella group for the Friends of Park groups in the Royal Borough of Greenwich to share information and coordinate activities in liaison with Parks, Estates and Open Spaces Department.

Objectives and activities

Summary of the objects of the charity set out in its governing document

To provide or assist in the provision of facilities for recreation and other leisure time occupation in the interests of social welfare with the object of improving the conditions of life of the public by the improvement of parks and green open spaces in the Royal Borough of Greenwich.

In furtherance of this the charity will provide an umbrella group for other interested organisations who are furthering the above objects.

Greenwich Parks Forum co-ordinates the delivery by the individual Friends of Park groups of a series of free cultural events in parks and green open spaces across the Royal Borough of Greenwich under the title PARKSfest.

The PARKSfest programme seeks to engage with local residents as audience members and participants by including local performers, community groups, businesses and schools.

PARKSfest is a local festival in three respects. Firstly, it is targeted at local people regardless of age, ethnicity, gender, sexual orientation and disability, and seeks to make the attractions of parks and green open spaces more accessible to those who live within the local area. At the same time, PARKSfest welcomes people from other parts of the Borough and, indeed, from outside the Borough. Secondly, the performers are local individuals and groups who have developed their performing skills to a high level and wish to display their talents to local audiences. Thirdly, the festival is planned, organised and delivered by local residents who are committed to the public use and enjoyment of Greenwich's much valued parks and green open spaces.

In planning our activities we have kept in mind the Charity Commission's guidance on public benefit at our trustee meetings. Our work this year has again evidenced our commitment to this.

Our current grant scheme provides for a maximum of 4 individual awards of up to £1,000 in any one calendar year (limited to no more than 25% of our reserves on an annual basis). Grants are to be used solely for the benefit of parks and green open spaces in the Royal Borough of Greenwich. In selecting an award preference is given to projects that benefit more than one group and projects where some match-funding is available.

The contribution made by all the Friends of Park groups and their members who are all volunteers is gratefully acknowledged.

Some 200 volunteers were involved in the planning and running of the various PARKSfest events this year. This also enabled groups to attract new members and build on the work they do in their local parks and green open spaces including clearing vegetation, planting and litter picks for the benefit of the general public.

Summary of the main achievements of the charity during the year

Our guest speaker at our Annual General Meeting on 27 March 2019 was Clive Efford, our local MP for Eltham, who was actively involved in a successful Heritage Lottery bid early in the new millennium to renovate Well Hall Pleasaunce in the spirit of the 1930s. Clive outlined the role of Parliament and local government in addressing issues affecting parks.

As parks are a non-statutory service the role of Friends groups has become increasingly important in recent years as budgets have been cut. They can access grants that are not available to local councils and ensure that limited funds are used efficiently. A general discussion on what grants are currently available followed.

In our 11th year of PARKSfest 11 Friends groups were responsible for running 21 events during June and July, attracting a wide age range with a total audience of over 13,000 people. The success of PARKSfest 2019 was again based on strong and vital partnerships with a variety of local partners.

PARKSfest is an integral part of Greenwich Festivals and is well and truly woven into the fabric of community life in the borough of Greenwich. This remains a remarkable achievement; given that its organisation and delivery is dependent upon voluntary effort.

Although there was no overriding theme in our discussions in 2019 these covered a wide variety of issues, from mowing practices to pond clearances; from tree wardens to dog wardens.

The Forum and individual groups attended the Council Leader's 'Business Breakfast' in March to celebrate the work undertaken by Friends groups and local interest groups in their local parks and open spaces. The contribution made by volunteers was widely acknowledged within the Council given the continuing climate of cuts to services.

In July the Council reported that the Borough had been successful in retaining our existing 12 Green Flag awards evidencing the value of teamwork between the Friends groups involved and the council's Parks, Estates and Open Spaces Department.

Several groups benefited from the Greenwich Neighbourhood Growth Fund including upgrades to park facilities, refurbished public toilets and the renovation of ball courts

2019 has seen a further growth in the number of Friends groups. Both St Alfege and Southwood have re-formed and there is a new group associated with Plumstead Gardens.

Throughout the year we received updates from various Friends groups on their activities and projects. This has enabled us to quickly identify any recurring problems and seek solution in consultation with council officers who were present at all our meetings.

Our main source of funds this year has been the grant for £30,000 received from the Royal Borough of Greenwich to provide PARKSfest 2019. In addition, the overall programme was sponsored by Tudor Barn. a local restaurant and cultural centre located in Well Hall Pleasaunce, Eltham, who provided us with £1,500.

Other businesses were sponsors of individual events, with participating groups providing some match funding.

The Trustees approved the award of 3 grants this year:

- 1. Avery Hill Park £1,000 to provide some match-funding for their £30,000 grant from the Greenwich Neighbourhood Growth Fund. The project extended and improved a children's playground and dog free community picnic area.
- 2. Queenscroft Park £700 to install a water butt and connections to water their new mini orchard. The trees were funded via a grant application by the Council from the Mayor of London's Environmental fund. Local schools assisted the Friends Group in planting the trees. Grant will be paid in 2020.
- 3. Well Hall Pleasaunce £1,000 to restore the rhododendron / azalea border in their gardens with Parks department and the Friends Group doing the hard toil. This was match funded with £1,000 from the Mayor of London's community planting scheme.
