#### Annual report for year ended 30<sup>th</sup> April 2020

3<sup>rd</sup> Harrogate Scout Group maintained steady leader numbers this year with leaders and assistant leaders continuing to provide support to each other to help cross cover of sections. The census numbers increased very slightly through the year, with individual section numbers fluctuating, again allowing the waiting list numbers to be reduced.

Bilton Gala 2019 successfully took place, but the event organisers decided for various reasons that they could not continue to operate the gala going forward. This has always been a good fundraiser and not having this income stream could impact on the Group funds. This will be monitored to determine whether any additional fund-raising measures will need to be considered. Notwithstanding the above, the Group was again able to subsidise the Group Camp, as well as maintain the premises, provide equipment and support funding for various sectional activities.

The leaders across all sections continue to work hard to provide challenging and interesting programmes for the Beavers, Cubs and Scouts and continue to help them achieve their badges.

The Explorer section has benefitted from additional help at leader level and the leaders for each Cub section have been changed around a little. The overall numbers of members has increased slightly, mainly due to Explorer numbers being slightly better than last year.

The leadership team of section leaders, assistants, young leaders and parent helpers have again worked hard throughout the year to provide an exciting and varied programme working towards the badge requirements.

As we came to the end of our financial year, we were, of course, stopped in our tracks by the Global COVID-19 pandemic.

As face to face Scouting stopped for safety reasons, a number of our sections took up online video meetings with a good deal of success. It is much more difficult to engage young people during an online meeting but it does provide a weekly chance to interact with their section friends, albeit via a screen. These online meetings are set to continue until we are able to meet up face to face.

The group was also eligible for the Government Covid support grant and we were very grateful to receive the support payment direct from the council. This grant has meant that the group is financially stable and able to withstand the absence of summer subs and any further financial issues this pandemic may pose.

The group is hugely appreciative of the amount of time and effort given by everyone involved, not only with running the sections but also with camps, trips, activities, and online meetings currently. Thank you to everyone involved for continuing to make 3<sup>rd</sup> Harrogate Scouts a happy and successful group.

The accounts have been drawn up on the receipts and payments basis, in accordance with the Association POR rules that are common to all Scouting Districts and Groups.
