## St Mary Magdalene, Enfield - Annual Report for 2019

## **Background**

St Mary Magdalene's PCC is responsible, with the incumbent, for promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. It also has maintenance responsibilities for the Church and Hall of St Mary Magdalene, Enfield and legal responsibilities as the trustees of Registered Charity No. 1133095.

The PCC has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 (duty to have due regard to House of Bishops' guidance on safeguarding children and vulnerable adults).

#### Committees

Fabric Committee: assists the PCC in managing, supervising and financing structural and building maintenance projects pertaining to the Church and Hall, backed up with a Fabric Fund.

Memorial Garden Committee: Administers and arranges the interment of ashes in the Memorial Garden.

Children and Young Persons Committee: Attends to matters relating to children and young people through Sunday School.

Stewardship Committee: Co-ordinates the annual review of the Christian Stewardship of money and other resources through planned giving and other activities.

Hall Management Team: responsible for hiring out the hall, collecting and setting rent rates and maintenance.

*Charities Champion*: monitors and promotes the various charitable activities undertaken on behalf of the church.

## **Review of the Year**

The PCC met eight times during the year. Committees met and reports were received and discussed by the PCC

There were 175 on the Electoral Roll as at 28 April 2019.

The refurbishment of the Organ was our main outgoing for 2019. We paid the first instalment of £27,970 in 2018. The 2019 payments of £69,326 were made up of £60,811 paid through the Fabric Fund and £8,515 through the Organ Fund (raised through generous donations), making a total of £97,296 for the organ rebuild. £16,216 VAT was reclaimed, and the money returned to the Fabric Fund. Added to this was the cost of maintaining and repairing the fabric of the church - wall repairs, hall repairs and decoration and other maintenance cost a further £23,607. Our Common Fund contribution of £54,000 was also paid. Other expenses incurred were for the general running of the Church – insurance, utilities, gardening etc. We saw a slight decrease in collections and donations. The Gift Aid tax rebate was £9,885 this year, the Hall was able to transfer £28,000 and rental income from Comreddy was £11,021. We have made a loss again this year, but, considering the major expenses, we have come through in reasonable shape.

Regular giving through the Stewardship scheme, as well as other one-off donations, enabled us to complete the organ restoration, repaint the hall and repair the garden wall as well as meet all our regular bills. This is only possible as a result of the continued support and generosity of the whole congregation, most of whom are in the regular giving scheme, and tax recovery is maximised either through Gift Aid or GASDS.

We had another very successful visit to Launde Abbey when 26 of us shared much fun and fellowship. Our next visit is planned for 2021.

Our harvest gifts went to the local food bank and at Christmas we gave toys to Enfield Council's Children and Families Department for distribution in the Borough. Carols were sung at several local venues and the proceeds donated Crisis. There was a house to house collection for Christian Aid plus a retiring collection for Christian Aid's appeal following Cyclone Idai. Support for Mary's Meals has been on-going through the Meals initiative and Dinner Money collections. We have also continued to raise money for important projects within the church through coffee mornings, a sponsored event and other social events. Total charitable outgoings raised for others amounted to £11,329, although this included a sum of nearly £4,798 raised at an event run by the Cordwainers.

In October The Rev Jackie fish took her last service as curate and her retirement was celebrated at a dinner in the evening. She will remain a valued member of the congregation. Four candidates (two from St Mary's) were confirmed by Bishop Rob at St Mary's in

November. There were Choral and Taizé services during the year and the church was used by other organisations to host concerts during the year. A course was organised for Lent and there were bible study meetings during the year. The Cubs, Scouts and Beavers joined us for Mothering Sunday, Harvest, Remembrance and the Toy Service in December. As always, we have welcomed several ordinands for various forms of placement from Oak Hill College. Monthly Holy Communion services were held at Springview, a local care home, where services for Easter, Harvest and Christmas were also held. The PCC agreed to a financial contribution to the Enfield Debt Centre. The Sunday School continues to run weekly and had an outing to the Pantomime and a day trip to Frinton beach. The monthly lunchtime concerts provided a varied programme from local musicians and students from local schools. The Care and Prayer Group continues to do much quiet, pastoral work behind the scenes and meets monthly, as does the Fellowship. The flower arrangers continued to provide us with beautiful displays at appropriate points in the liturgical year, and also provided for weddings.

A busy year for the bell ringers, ringing for six weddings, one funeral, four full peals (over 5000 changes each peal and lasting almost three hours) and for the blessing of the rebuilt organ by the Bishop. One of the visiting peal ringers came over from Holland and is one of the crème de la crème ringers of the 'Cumberland Youth' a very ancient order of bell ringers. Two members moved away during the year and two new ringers are in training. The year ended with a Christmas meal at a local pub and ringing in the New decade.

In November 2019 the Drama Group performed two plays in the Church Hall by Dorothy L Sayers, 'He That Should Come' and 'Kings in Judea'. The production was a very rewarding one with a total audience of circa 70 over the three nights. A good script meant thought provoking entertainment blended with humour and the simple costuming and staging put the focus on the performances. The 'in the round' production style also brought intimacy for audience and cast alike. Gordon commended the production in the subsequent Church magazine.

Co-operation with other local theatre groups continued in 2019. Throughout 2019 a variety of plays were read at the Group's regular Wednesday meetings. All members of the congregation are always very welcome to come along and join in. Members of the Group took part with other members of the congregation in the Palm Sunday gospel reading, the adult Nativity at the Christingle services and the Sunday Epiphany service at the beginning of the year. Group members also took part in the Merryhills' Nativity play. It was broadly based on the Christingle script and the Christingle costumes were used. It was performed to 100 young people in all who loved it and followed up the performances with questions to the Magi.

#### **Accounts introduction**

Our gross income is less than £250,000 therefore the accounts are worked out as Receipts and Payments as per Section 133(1) of the Charities Act 2011. Where headings differ from previous years the amounts have been re-costed as close as possible to match the 2018 figures. All monies have been rounded to the nearest £.

#### **Funds of the Church**

Funds are split into four types, Restricted, Unrestricted, Designated and Endowment funds.

#### **Restricted Funds**

These are receipts as donations or grants that must be spent on restricted purposes. Unless otherwise stated these funds remain in their respective restricted funds at year end. The funds held and restrictions provided are shown in the accounts.

#### **Unrestricted Funds**

These represent the remaining receipts of the PCC that are available for spending on the general purposes of the PCC.

## **Designated Funds**

Amounts designated by the PCC for spending on a future project and which are therefore not included in its 'free reserves' as disclosed in the report.

#### **Endowment Funds**

These are restricted funds that must be retained as trust capital either permanently or subject to a discretionary power to spend capital as income, and where the use of any receipts or other benefit derived from the capital may be restricted or unrestricted.

# **Pilgrimage Fund**

This is a Restricted Fund that constitutes Parishoners' savings towards Pilgrimages and the Launde Abbey retreat.

## **Reserves Policy**

It is the policy of the PCC to have at least two months of expenses available as Unrestricted funds in the Current Bank account (which works out at around £22,000). This is put aside for emergencies where receipts are less than payments and for general good running of the Church bank account.

## **Risk Assessment**

The two main risks that involve the finances of the Church are a) An unexpected urgent repair required for Fabric of the Church and b) A downturn in donations received whether through regular planned giving or collections received. To prepare for either of these we maintain general funds on deposit. As part of contingency planning it is our hope to gradually build these up over the coming years for resilience.

## **Budgeting**

Our finances are budgeted for based on the previous years' average receipts and payments allowing for spikes in either.

#### Notes on the accounts

- R2a We are grateful to the estate of The Late Mary Irene O'Connell for the legacy bequeathed of £1,000 in her will. This money was put towards the Organ Restoration fund.
- R2b We are grateful to The Worshipful Company of Cordwainers for their grant of £1,000 for the services of our vicar. This money has been designated towards the Vicarage Fund and set aside for future work on the Vicarage.
  - We are grateful to the Ecclesiastical Music Trust for the grant of £600 towards our Music Fund. This was put towards the costs of new storage boxes and sheet music for the Church music library.
  - We are grateful to the ON Organ Fund for the grant of £400 towards our Organ Restoration fund.
- R4a £28,000 was transferred from the Hall, £5,000 of which has been designated for the Fabric fund with a view to putting this towards the Vestry refurbishment during August 2020 unless any other emergency should arise.
- P1a Church Major Repairs. This covers the work on the Organ for which £60,811 was paid through our Fabric fund and £8,515 through the Organ Restoration fund. Other monies spent were for the wall repairs.
- P1b Hall Major Repairs. Some major repair work was needed on the hall which came to light during the time of the hall redecoration.
- P3a We are grateful to everyone who contributed to The Rev. Jackie Fish's retirement gift.
- B1a-i This year, due to bank charges and to consolidate the deposit bank accounts, we closed Barclays Bells, Fabric and Open Access accounts and CCLA Fabric, Open Access and Pilgrimage Deposit accounts. The monies from these accounts and their respective funds were transferred into Barclays General, CCLA General and CCLA Bells accounts.
- L1 Liabilities: Monies we receive from donations to Charities are referred to as Agency Collections where we act as the agent collecting on behalf of a particular charity. It is general practice to send all monies that have been collected for a specific charity to that charity by the end of year so that we are not owing anything to anyone. This year, due to the late nature of some collections this was not carried out for The Enfield Talking Newspaper and the London Diocesan assigned fees. The monies carried over were sent at the earliest possible time in January.
