Annual Treasurer's report to the PCC St Mary the Virgin - 2019

Our cash balances over the year 2019 has seen a decrease in total and the accounts show a deficiency in our income over expenditure by £35,621.08.

In 2019 the parish share payable to the diocese to cover the Rectors salary, pension and central costs increased by 13% to £66.6k (£1,250 pw) from £58.3k in 2018. The parish share will increase again in 2020 to £70k pa.

Our covenanted income was down by £4.1k compared to the previous year at £51.5k. Our money received from weekly cash giving and donations decreased by £1k from £8.3k in 2018 to 7.1k in 2019.

Overall, outgoings decreased by 18% from £178.7k in 2018 to £147.9k in 2019 resulting in our annual shortfall over £112.4k income by the above mentioned £35,621.08. This can be attributed to the increased outgoings for the buildings project on fees and surveys, some £18.4k in 2019 (down on the amount spent on survey and fees in 2018, some £77.6k).

Rental income on a net basis for the school house, which we manage for the Dioceses, brought in a further £7.3k in 2019, although we saw some expenditure of £12k spent on the refurbishment of the house, taken from the school house fund. This decreases the school house fund restricted in our balance sheet to £49k.

This leaves us with available cash balances of £65.7k after deduction of the school house fund as shown in the statement of assets. This represents a 31% reduction on the previous year (£94k).

Income received from housing a phone mast in the church tower has brought in a further £16.4k for the year (£32.9k to date).

I would like to thank Heather Melling for her work as our covenant secretary and also to Gail Phillips for helping count the weekly cash takings from our collections along with others. Also, I would like to thank Richard Selby for his on-going help and support in maintaining the parish accounts. Thanks again to Ron Neil for examining these accounts.
