Trustees Annual Report for the period 01 January 2019 to 31 December 2019

The charity is governed by its constitution as approved by the membership at an AGM and submitted to the Charity Commission.

The purpose of the charity is set out in its constitution viz.: "The object of the CIO is to educate the public in the history of Newhaven and the surrounding area."

The trustees have regard to the public benefit guidance issued by the Charity Commission. The charity runs a local museum (The Newhaven Local Museum), holds talks open to members and the general public, publishes a journal four times a year, answers queries from members of the public and liaises with television and film makers concerning the history of Newhaven.

The charity does not normally make grants and no grants were made in the year.

The trustees acknowledge the contribution of volunteers, principally as stewards in the museum but also as contributors to the journal.

The trustees do not set targets for fundraising other than aiming to 'breakeven' each financial year. Funds are raised through membership subscriptions, admissions to the museum and talks, raffles at talks, unsolicited donations and grants.

At the 31 December 2019, the charity was well placed financially, having received several donations from individuals and local businesses in the last few years. The trustees have 'ring-fenced' £5,000 against possible future expenditure related to moving the museum to a new location. The current location is provided for a nominal rent by a local company, but this concession could be withdrawn with only 6 months notice. The trustees do not see any risk of the charity not being able to continue in the foreseeable future.

Trustees are selected by recommendation from existing trustees or members. Trustees are appointed by the membership at the AGM, although casual vacancies can be filled by the trustees until the next AGM. Trustees are inducted by interview with the Chair and the provision of a copy of the constitution and appropriate Charity Commission documents.
