The aim of the Sea Cadet Corps is to help young people towards responsible adulthood by encouraging valuable personal attributes, leadership, citizenship and high standards of conduct, using a nautical theme based on the customs of the Royal Navy. Membership is open to young people aged 10-18 years regardless of gender, religion or race and, within the bounds of safety to themselves and others and in line with the DDA where reasonably practicable, to those with special needs. Normal Parade nights are Tuesday and Thursday evenings, plus weekends and holidays as appropriate. Opportunities to participate in sport, expedition type activities, sailing, powerboating on fresh or salt water, passage in sea-going boats are taken up as they arise via various organisations including the Royal and Merchant Navies and various sail training trusts.

The unit comprises buildings mainly made from wood and of some age. Maintenance continues to be an ongoing concern, along with the cost of insurance and the escalating cost of utilities and the unit has to find all the costs through fundraising activity. An ongoing programme of repair has taken place throughout the last few years. The unit receives a tiny sum each year from the MOD towards assistance with MOD owned boats, other than that it continues to survive from year to year due to the sterling efforts of everyone connected to the unit. It is harder and harder to find a way to continue providing these opportunities for the young people of Nottingham – particularly those from a disadvantaged background – however productive partnerships with other charitable youth organisations and the local statutory youth sector continue to thrive.

The unit has ambitions to redevelop the unit with buildings in modern materials and to explore strategic partnerships that will raise the profile and keep the money coming in. The strategic development of the unit has been on hold, but this year updated plans have been put to the Local Authority and a planning decision is pending. Business plans and fundraising strategies will be created, and a development board set up. The impact of Covid19 has already been felt in the temporary closure of the unit to training, but the long term ambition to create a modern facility will go ahead and post Covid there are new opportunities for the unit both from a training perspective and in terms of access to funding.
