Originally Foodbank number 188 under the umbrella of the wider Trussell Trust Charity, and registered under Churches together in Kidderminster in May 2013. Became independently registered in November 2015 as Kidderminster Foodbank. But remains under the organisational structure of the Trussell Trust policies and procedures.

The object of the CIO is to relieve persons in the district of the Wyre Forest and the surrounding areas that are in financial hardship in such ways as the Trustees from time to time think fit, in particular, but not exclusively: by providing emergency food, essential toiletries and household items to individuals and families in need of/or for distributions by charities or other organisations working in Britain to prevent or relieve poverty. Such other means, including (but not limited by) the provision or signposting to relevant information and other advisory services.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

In setting our objectives and planning our activities, Trustees have given careful consideration to the Charity Commission public benefits guidance. The foodbank is required to operate within the legal constraints commonly associated with a small business, plus those required by the Charity Commission. These include the Health & Safety at 'Work Act 1974. The storage of food as laid down by the Environmental Health and Food Standards Agency, Insurance to cover the activities of the charity, public, product and building and contents insurance. Kidderminster Foodbank is a voluntary based, Christian charity but open to all who need food, and are going through a crisis. We are open 2 days a week,, Wednesday and Friday, and we service towns throughout the Wyre Forest and outlying counties as far as Staffs and Shropshire. 90% of the food we receive is donated by the public either directly to us via churches, schools, local businesses, voluntary organisations and individuals, .or from other outlets such as donation boxes at supermarkets. The food is collected, dated and stored rotationally. Shortages are covered by buying in as necessary using the foodbanks' finances, money which has been donated by the public. 3 days food is provided for each person, using a Voucher Scheme patented by the Trussell Trust. Everyone who comes to the foodbank has been referred by a frontline care professional ensuring that the need is genuine

The food is bagged up and given to the person, using a picking system, to ensure they have a well-balanced variety of ambient food sufficient to help them through an immediate crisis. When available, they are offered fresh food, which has been stored in the correct way by Food Standards. They can be given up to 3 more vouchers by the referral agent over a 6 month period, if they are considered to be in need for longer. We have no paid staff, but all volunteers undertake a training in Health and Safety, Manual Handling and Safeguarding.

Foodbank clients are also offered the opportunity to attend a Job Club once a week, with computer help and CV writing.

Until March 2020 we had 50 volunteers, but with the Covid 19 we have had to follow Government guidelines, and to keep the social distancing, we have ceased to work face to face with the clients, and only 6 volunteers twice a week work in the foodbank, putting bags together, and the food is delivered to the clients by a team of drivers, who once again are maintaining social distancing. Going forward, in September we have returned to a reduced face to face system.

The Trussell Trust provide a data system, which provides us with the printed vouchers and enables us to keep a safe record of figures and clients details, and ensures as far as possible that the methods we use are safe and efficient according to Data Protection Services. We are registered with the ICO.

Achievements and performance

Summary of the main achievements of the charity during the year

The foodbank has been a busy as usual, Since our last report we have fed 4424 people including 2627 children. This was an increase of 25% over last year. With the Covid 19 pandemic, these numbers are increasing and since the lockdown this is now 33%, including a 50% increase to children. Low income being the main reason for the increase with Benefit problems, a continuation with the introduction of Universal Credit still being one of these. Now with the pandemic, the high level of unemployment is adding to the increase in need.

We have increased to 114 the number of referral agents, professional front-line carers who give out the vouchers, and ensure that the need is genuine Since March, as many are working from home, the introduction of electronic referrals has greatly helped to overcome the problems with communication. So we are reaching and able to help more clients. Our food donations have also increased, thanks to Tesco and Morrisons supermarkets who with the help of British Gas and other drivers have donated large amounts of food from their stores so we are able to meet this increase so far, but we are still having to buy in certain shortages. We continued to run a lunch club on a Tuesday morning for the elderly, and those on low income, but sadly that has also had to stop for the time being.

The homeless situation has not improved there were 119 vouchers giving homelessness as the reason for needing the food. We are grateful for other charities such as Nightstop, Axis and St. Basils who offer a roof over their heads.

Our donations have been fantastic this year, with the Harvest bringing in over 3 tons of food, too many baked beans and pasta as usual, and we still have to spend some money topping up with the more essential things. We had over 49 tons of food donated, but of course have given out over 40 tons, but we are keeping a good balance of stock of 23 tons at present, so that is a good position.

Financially our finances are looking stable, For the year to April 2020 there was an excess of income over expenditure of £5,239.42. Giving us a credit balance of £35,341.88 to take forward and since the lockdown financial donations continue to increase for which we are very grateful. £5260 was allocated to pay for the desperate need for more storage space and the refurbishment of the cellar of the church to allow for this. It is envisaged that we will also update another part of the church to give us more space. Costing a further £5000 in the autumn. We are seeing an increase in the amount of food we are having to buy in, with the number of needy families rising steadily each month. So this balance is very welcome.

Brief statement of the charity's policy on reserves	At present we have reserves of £35 341 But as previously mentioned £5000 of this has already been allocated to the refurbishment of the cellar to increase storage space. But the residue does provides a good cushion for the future and would probably cover costs for at least the next two years

We have applied for Grants in previous years, but this year again we were not successful. We have a website and we use social media to update our shortages and immediate needs. In order to support the key objectives of our charity, our major expenditure is on renting the premises for the foodbank and buying in food supplies when we are short. Also the cost of broadband to download the data system from the Trussell Trust to ensure the safe use of our clients details, has increased this year. Other small administrative costs are insurance, office equipment and transport expenses (as we do cover the mileage costs for picking up the food from donors.
