





### THE VICAR'S REPORT

2019 seems a long time ago, and as this meeting is happening in October, I want to spend most of this report discussing what has happened since March 2020.


It has become a clear lesson of COVID 19 that if things are not quite right in the good times, they become major problems when times are hard. 2019 was a good and relatively peaceful year. We did not do any major fabric work, nor undertake any major mission initiatives above those which have become part of our regular pattern of life. We had a few transitions in roles, which were done well, with a good handover. In hindsight if feels that we were steadying ourselves for 2020, and the steadying was deeply valuable. St Peter's has managed the storm of 2020 with strength, versatility, imagination and confidence. Tanya has taken over the finances from Richard and helped us to respond wisely and carefully to the changes in our situation. The standing committee of Graham, Vanda, Tanya and Penny have led us with enormous wisdom and care, and the impact of their discussions has reached far beyond our parish boundaries. Our pastoral team adapted immediately to supporting us through the lockdown, and as soon as it was possible Refresh swung back into action and provided a lifeline to many. Our teams of welcomers and sidespeople have adopted a new way of working brilliantly, and the new rota of people to set up the seating plan each week has made the brilliant system of booking and seating sustainable. Each of the authors of these reports has led their part of the family of St Peter's with outstanding skill, working out how to do what matters in a new way, and making the church alive, safe and welcoming.

At a diocesan training day we were asked 'what makes a flourishing church', and one answer I heard was 'a flourishing church is one which can flourish in a crisis like this'. St Peter's has shown this to be true, and I am deeply proud to be the Vicar of such a wonderful people.

I believe that the impact of St Peter's in this crisis goes beyond all that the church has achieved. Petersfield responded quickly and with enormous generosity to the crisis, with new groups and people stepping forward to look after those stuck at home. From Churchers college cooking and delivering meals each day to the Coronavirus Support Network shopping and delivering prescriptions with a pool of hundreds of volunteers, it became clear that this town has Christian values deeply embedded in it, far beyond those who come to church each week, and I believe that is a testimony to the witness and challenge offered by this church, standing and gathering at the heart of the town.

Figures only ever tell a small part of the life of St Peter's, but here are the headline figures of last year.


### SIDESPEOPLE'S REPORT & ELECTIONS

Since the last APCM I have added 5 new names and sadly we have had to say goodbye to 5 members of our Church Family.



PCC

It is a joy to see her returning to church and growing in strength.

Right at the beginning of the lockdown we were shaken by the loss of David Francombe, whose commitment to so many areas of the church and town was remarkable. We miss him hugely.

During the year the PCC voted to allow Richard Perry to finish his term as treasurer, Lynn Carter to end her term as PACT rep, and Christine Rushton to end her term on Deanery Synod. The PCC elected Lynn Carter to Deanery Synod, Madeline Kings as PACT rep and Tanya Heath as treasurer. The APCM is invited to confirm those elections.

### SAFEGUARDING

It has been another quiet year for safeguarding at parish level. Now that established systems are in place and the policies are working, my role is generally one of monitoring and advice. Online applications for DBS checks have made my life so much easier and many thanks must go to Kate for taking up the role of identity checker when I am not available. As always, the Portsmouth Diocese Safeguarding Toolkit is freely available for everyone to read online or in the Church, office and hall. This is based on the Church of England advice. 
### PCC COMMITTEE REPORTS

### **Discipleship and Spirituality**

The Vicar took the lead on this committee as the Curate prepares to leave, and the committee planned the Advent and Lent courses, and supported Penny Bell in shaping the Tuesday Night Discussion programme.

### Pastoral

The Pastoral Committee is in existence to assist and support the work of the clergy in their care for the people of the congregations of St. Peter's and the people who live in the parish or who look to St. Peter's as their parish church. The Committee meets every two months and consists of Kate Perry (Chair), Jane Fuller, Felicity Heal, Linda Lemmon (Minutes secretary), Elizabeth New, Sylvia Roberts, Jennifer Robinson. Jill Watts and Rev'd Sam Cullen have served on this committee during the past year and great thanks are due to them both



for their participation. Jill has decided to retire and Sam has been appointed to St. Mary's, Portsea from March 2020.

### The specific pastoral ministries include the following.

- Home Communion for those unable to attend church. Wendy Gillam has responsibility for organizing a rota for those with pastoral permission for this crucial ministry.
- Attending the weekly Refresh Café in order to meet, greet and be available to all who come in and enjoy this café as a regular spot in their week. At least 50% of those attending Refresh are not regular worshippers but are people of the town who consider St. Peter's their church.
- Writing and sending greetings cards to those who are ill or in hospital. Elizabeth New has been faithfully fulfilling this much welcomed ministry for several years now.

### Swift and confidential

The WhatsApp group, accessible strictly to members of the Pastoral Committee and to Will and the clergy, enables information to be shared quickly between members when a pastoral situation arises which needs attention. It has already proved invaluable as an instant addition to the regular bi-monthly information exchange at the committee meetings about members of the congregations who are in particular pastoral need at any one time.

### Particular pastoral matters this year

- Concern about gaps in our care of young people and young families.
- Three pastoral "Pop-In" sessions were tried out this year but were not well supported and so were discontinued. The committee will review the possibility of a different way of being available.
- Wearing name labels in church for the month of "Naming November" was considered a worthwhile exercise and the page in The Rock entitled "Have you met?" which highlights a few members of the congregations each month is also helping individuals to know each other a little better.


### Possible initiatives for the coming year

### **Mission Support**

Fundraising activities ceased in 2019, but other functions of Mission Support were continued by Christine Tully. These included publicising the work of missions and charities, maintaining the relationship with our link mission partners, sale of stamps for the church in Sudan and responsibility for Ride and Stride.



Penny Brackley has a particular interest in the link parishes and will work together with Christine in 2020.

### Historic Churches Ride and Stride.

Many thanks to Dickie Parsons who cycled to many churches and raised the most sponsorship money. Thanks to the four striders, Rosemary Roberts, Christine Rushton, Jill Moore and Christine Tully. We also thank the sponsors, most of whom were St Peter's members. The total raised was £917.00 of which St Peter's receives half.

**Mint postage stamps**, old designs still valid for postage, were bought from the Church Association of Sudan and South Sudan (CASSS, formerly SCA), at a value of £423.35. CASSS gets 10% of this. Most of these were sold at Christmas, but Christine Tully has them for sale throughout the year. Thank you to all those who donate their used stamps and post cards which are now are sent to Air Ambulance.

### **Publicising the Work of Missions and Charities**

This is done through Mission speakers and the article in each issue of the Rock. It was good the welcome Chris and Suzy Wilson with Abigail, Matthew and Micah in February this year and learn about their work at St Frumentius Theological College in Ethiopia.

### **Relationship with our Link Partners**

Several of us are in direct email contact with our link partners- Chris and Suzy Wilson of CMS and Tim Hyde of Church Army. Chris and Suzy send us regular updates from Ethiopia. Special prayer requests are passed on to the intercessors and reported in The Rock. The PCC giving to both Church Army and CMS is used to support our link partners. The PCC also supports the Kings Arms.



### **Community Use of the Church**

2019 saw another full and varied concert programme due to the outstanding work of David Francombe. The annual booklet showed the spread of choral and instrumental, school, local and national groups performing on what felt like a weekly basis. The programme is the fruit of relationships David built over years, and those relationships with St Peter's are now strong and embedded. While the programme has been forcibly stopped by COVID19, and we are not booking in concerts until we know what is possible, St Peter's remains deeply committed to the musical life of the town, and as soon as is possible, will be using David's meticulous records to re-establish contact with the many groups and performers.



### Fabric & Buildings

### **Church**

In 2019, only minor works were completed and the church remains in good condition. One point of note was that the wheels on the church piano were replaced,

### **Church Hall**

In 2019, there were only minor works completed on the hall. It is hoped that in 2020 funds can be raised to complete a more significant refurbishment of the hall.

### Parish Office & Curates' house

In 2019 there were no works required on the curate's house.

### Finance

A surplus this year of £98,343 compared to last year's deficit of £4,325. However, before anyone becomes too excited £87,804 of the surplus related to unrealised gains on our investments, of which £87,373 has disappeared at the time of writing based on current market fund valuations.


Leaving aside the severe fluctuations in our investment portfolio, the underlying performance for the year has resulted in a surplus of £10,539 which includes legacies of £5,000 and dividends directly reinvested of £11,513. Effectively the Church has run a small deficit of £5,974 on its day to day operations after allowing for the reinvested dividends and the individual legacies.

Planned Giving shows a small decrease which is better than I thought in the earlier months of the year but Collections are down which, arguably, is more concerning particularly in the light of the significant increase in our parish share in 2019 from £101,352 to £106,599.There were no major fabric and building repairs this year with expenditure totalling £2,264 on sink replacements and the new water boiler in the Parish Hall.

Fund raising of £26,145 continues to be a vital part of the church's income with community use providing £4,500 with significant contributions from Refresh, the 200 Club, the fete, quiz, barn dance and travel talk.

Our cash balances throughout the year have remained healthy, and sufficient to cope with any unexpected expenditure, at £102,846 compared to £100,250 at the beginning of the year.

The outstanding parish hall gas bills are properly shown in expenditure but the balance outstanding of £3,296 remains in creditors, this year offset by an overcharge on the church



gas where we were charged for another church's gas bills. Funds have been set aside to cover the eventual payment.

In summary, it has been a routine year with no major expenditure on fabric and buildings and no significant matters to report other than the fluctuations in our investment portfolio. 2020 will present its own challenges with a planned budget deficit as a result of major expenditure of £36,000 for a well overdue refurbishment of the Parish Hall. Pledges from the congregation have been made to cover the majority of the costs but a shortfall remains which may have to be covered by our reserves. The parish share is set to increase further in excess of inflation although at the time of writing the actual figure has not been finalised. I would like to thank all those concerned with the recording, monitoring and preparation of the accounts, it's a true team effort. Wendy Killick who keeps the records and deals with salaries, the Office who are so patient and helpful, particularly the weekly cash counters, Lionel Matthews for his support in compiling the monthly variance reports. Lastly but definitely not least our Independent Examiner who is so professional and helpful.

### NOTE LOCKDOWN UPDATE

The above was my original summary to be included in the Annual Report pre -lockdown prior to my retirement as Treasurer. You will all be aware of what has happened since with the lockdown. Will has reset the budget with the new finance team, staff have been furloughed and our parish share yet to be determined. Planned Giving, so far, seems to be holding up.


### **OTHER CHURCH GROUPS & ORGANISATIONS**

### Reader

I write this wearing just one of my metaphorical hats. People see me in uniform behind the till in the supermarket, in the past some have seen me in different types of clothing typing furiously in a local office, and some have seen me in yet another type of uniform – church vestments.

The role of a Reader is unique because you serve the Lord just where you are, whether in church or in the world as you take Christ's great commission to places where clergy usually do not have a foothold. I am not allowed to evangelise openly in my work, however, "It may not be appropriate but I have been praying for you" has been appreciated by some customers facing difficult situations.

I attended the Diocesan Reach Conference in October to help "us to express God's generous love for people beyond the current reach of our congregations", whilst mission was the theme of our annual Reader's Conference on the Isle of Wight. Training opportunities are offered by the Diocese and the recent one on assisting at the Eucharist was a cracker with a



lot of laughter and a deeper insight into the potential use of Readers in different liturgical settings.

I continue to lead Evening Prayer twice a week and sometimes on a Sunday; read the Gospel, preach and assist whoever is presiding. I enjoy the diversity of working alongside different members of the clergy team who God has blessed with unique talents and experience but it also means I have to be attentive to their different needs. I also led one of our Sunday Night Services which was enjoyable as it enabled me to use my creative talents.



### **Deanery Synod**

The Synod meets four times a year in parishes around the Deanery. Its role is to promote the work of the church in our area, to deal with issues raised by the PCCs to respond to consultations from Diocesan Synod and to confer with the Diocese regarding the parish share and the Diocesan budgeting process. The Area Dean is Revd Jane Ball of All Saints, East Meon, the Lay Chair is Vanda Leary of St Peter's Petersfield and the Deanery Treasurer is Mark Turner of St Mary's Liss. Elections to Deanery Synod are for three-year terms, and the next elections are due to take place at the 2020 APCM.

Deanery Synod also forms the electorate for Deanery representatives to the Diocesan Synod; these are currently Revd. Jane Ball, Revd Judith Bee (Buriton), Revd Chris Williams (Liss), Revd. Canon Will Hughes (Petersfield), Revd Helen M Mitchell (Petersfield), Neil Chrimes (Froxfield & Privett), Mary Crittenden (Hawkley & Empshott with Prior's Dean), Keith Doyle (Sheet), Jenny Hogg (Liss) and Vanda Leary.

Over the last year, the Deanery has continued to respond to the Diocesan Live Pray Serve strategy. The Deanery Prayer Diary, which encourages parishes to hold in prayer one church in the Deanery each week, is circulated to parishes quarterly. The first Deanery Prayer Day was held on Saturday 6<sup>th</sup> July 2019 at Hawkley Village Hall. Thirty people came to the day,



attending various workshops, for example Praying and Listening with Colour, Walking in Prayer, What are Intercessions? and Ignatian Prayer. Feedback from the day was positive, although numbers were lower than hoped for. Discussion and reflection on the Schools Chaplain initiative continues through the Deanery Pastoral Committee.

Speakers at Deanery Synod meetings over the past year have included Revd Andrew Goy on Schools Chaplaincy and Revd Canon Peter Hall, Diocesan Director of Ordinands, on Vocations. We also heard from Helen Jackson on The Ark Pre-School at the Church Centre, Liphook.



### Music

What a year and a half it has been. Having said farewell to Philippa Good and her family as she moved parish in 2018, having been ordained Deacon, 2019 saw us do the same to Hugo for the same reason. We have now run out of potential ordinands in the choir – I think, and for the time being! Hugo has been a tremendous team member and sung bass or tenor as necessary and if it didn't go out of his range. To the altos we have welcomed Cornelia Kenington, who has joined us following our second 'Cone & Sing Evensong' services. Aidan Phillipson, who has developed a good bass voice has taken time out for A-levels. Apart from that the membership during the year was to remain constant, with a couple of singers in training but not ready to join in general rehearsals yet.

*Or so I thought...* in March we were all knocked sideways by the unexpected death of David Francombe. David was one of the longest-standing members of St Peter's Choir – aside from everything else that he did in town and parish, of which I'm sure the Annual Report as a whole will make copious mention. He was an avid supporter of all things choral and I personally am very grateful to him for the consistent support and encouragement he gave me over the years. His was not the strongest of voices, but he was generally very accurate and the sort of voice you noticed if it *wasn't* there! He will be sorely missed.

The next calamity to hit, of course, was the Coronavirus pandemic, resulting in the shutting down of just about everything. The church choir was one of the first casualties of lockdown, for various reasons. We kept on meeting on Friday evenings, but on Zoom, not in the flesh. Choral singing is all about singing together in the same room and suddenly this was not possible. It simply isn't possible to rehearse remotely because you cannot hear your fellow singers for reasons of technological limitations. The only musical input possible until July was my recording of organ music to sit alongside the live-streamed services. The advantage of writing this report in September, however, is that I can say that after an enormous hiatus, the choir has now met and sung together in church once more, which is a cause of great rejoicing. What did we sing? *Now thank we all our God* and *I was glad*. First small steps along the road back to something approaching normality.



As ever, I should like to end by thanking the members of the choir for their individual contributions to the team effort which is choral singing at St Peter's. Thank you also to the parents of the junior members for ferrying and sitting in on rehearsals and training sessions. The support and encouragement of the clergy does not go unnoticed and is much appreciated by myself and the choir.

We were deeply saddened by Melanie's illness but now, with her improving health, we hope she may eventually resume some of her teaching - and even ring a mini-ring at ground floor level!





### **Bible Study Group**





### **Food Bank**


This is now giving £10 vouchers for fresh food rather than £5. There has been a 58% increase in referrals. In January 2018 38 individuals were being helped, in January 2019 46 individuals were helped and this year it was up to 62 individuals. The foodbank helps people over a period of crisis for up to a few weeks Food is still currently being stored at the Methodist Church; the new storage container has been installed at the rear of the Salvation Army Hall, but requires insulating and shelving. St Peter's may be asked to make a financial contribution to this along with other churches in PACT. Food is given out on Tuesdays and Fridays and sorted on Mondays and Wednesdays at the Methodist Church. There is also a Free Food Friday hub at the old parcel office at the station which is open from 10 to 12 on Fridays and Saturdays.


All elected unanimously.

### PAROCHIAL CHURCH COUNCIL OF ST PETER'S PETERSFIELD TRUSTEES REPORT

The trustees present their report together with the financial statements of the charity for the year ended 31 December 2019. The financial statements have been prepared in accordance with the Church Accounting Regulations 2006, the Financial Reporting Standard (FRS) and the Charities SORP FRS 102.

### Aim and purposes

The function of the Parochial Church Council (PCC) is to cooperate with the incumbent in promoting in the parish the whole mission of the Church: pastoral, evangelistic, social and ecumenical.

### Structure, governance and management

The appointment of PCC members is governed by the Church Representation Rules. Members of the PCC are either ex-officio, co-opted or elected by the Annual Church Meeting. New members are made aware of trustee responsibilities and individual members are appointed to ensure compliance with health and safety regulations, child protection and safeguarding policies and are encouraged to attend diocesan or deanery training courses on such matters. The PCC meets 6 times a year.

The PCC operates through the following committees which meet between and report to meetings of the PCC :-

Standing - Is the only committee required by law and acts on behalf of the PCC

Children & Young Adults - Provides for younger members of our Church community

Community Use of the Church -Is responsible for developing the non-liturgical use of the Church.

Discipleship & Spirituality -Is responsible for deepening the spirituality of the Church

Fabric and Buildings -Is responsible for the care of all parish buildings.

Finance - Manages and monitors the finances of St Peter's.

Liturgy - Is responsible for decisions about worship and services.

Mission Support - Raises funds for and publicises the work of missions and charities

Pastoral - Organises the ministry to newcomers and monitors pastoral needs.

200-Club - Organises and runs the St Peter's Church 200-Club, raising money for the PCC

**Volunteering & Fundraising** – Organises fundraising events for St Peter's and co-ordinates teams of volunteers to carry out various tasks within the church

### **Objectives and Activities**

The PCC is committed to enabling as many people as possible to worship at St Peter's and to become part of the parish community. The incumbent and the PCC are fully aware of the Charity Commission's guidance on public benefit and the specific guidance on charities for the advancement of religion, and has regard to these in planning and delivering its activities.

### Achievements and Performance

As a PCC we continue to strive for growth, both numerically and spiritually. To achieve this, a programme of work has been put in place under themes of faith exploration, community, invitation, and mission.

In terms of faith exploration and discipleship our series of discussion groups, for members of the congregation as well as those exploring faith, are now well-embedded.

The PCC has actively supported Petersfield community events as well as running some of our own, including:

- An Easter "messy church" event
- An art installation created by puipls from Petersfield Infants School (May)
- St Peter's church fete (Sept)
- A barn dance in church (Oct)
- Local hosts for the national "Big Draw" art project (Oct)
- A stall at the Petersfield Christmas lights switch on (Nov)

In support of existing work, as well as to help in achieving the growth target, St Peter's has strengthened communications through the use of the social media platforms Facebook and twitter.

The additional efforts described above build on and complement the work which was already ongoing at St Peter's.

The electoral roll, at the 2019 annual meeting, stood at 232, and the average Sunday attendance for 2019 was 149 adults and 16 children, a slight decrease on previous years.

St Peter's run a range of worship activities for children. SPY AM (age 11 to approx. 14) continues to run on Sunday mornings during the 9.30 am service, as does Junior Church, for 3 -11 year olds, that meets in the church hall and then joins the congregation in church towards the end of the service. In addition to specific activities for children, young people are actively encouraged to participate in all

In addition to specific activities for children, young people are actively encouraged to participate in all aspects of services, including as choristers, bell-ringers, readers and servers.

The pastoral team, with support from the Lay Pastoral Assistants, provides regular pastoral visits, offering communion, spiritual support and company to a wide variety of frail and house bound people in their homes and care homes.

Hugo Deadman, who trained for ordination at St Peter's was ordained in 2019 to serve in Portsmouth Diocese. Melanie Evans continues to be active as a Lay Reader in the parish.

In support of faith development within the congregation and the wider parish, St Peter's clergy and other personnel have taken regular RE lessons and collective worship in Churcher's College, Ditcham Park School and Petersfield Infants' School, and some lessons for The Petersfield School. Rev. Hughes has also provided regular 'padre's hours' for the ATC squadron and is chaplain to Petersfield District Scouts.

St. Peter's again joined with the other churches in the Deanery to prepare confirmation candidates, including those from St Peter's and also from Churcher's College, for whom Rev'd Canon Hughes had provided the preparation course.

### PAROCHIAL CHURCH COUNCIL OF ST PETER'S PETERSFIELD TRUSTEES REPORT

St Peter's ran a Lent course, and continues to be a major focus in the town during Advent. This year during Advent we had over 20 services for various schools and other local organisations. These brought about 6000 additional people into the church.

The free weekly café, Refresh, is held in church and is open to all the community. Typically it attracts between 70 -100 people.

Similarly, the weekly "Play Together" toddler group is open to all, and typically is attended by 30+ families.

2019 proved to be another exciting year for St Peter's Concerts with over 30 events held.

We have continued with the required work to maintain our buildings.

### **Donated Assets**

In 2018 we installed glazed doors inside the North porch, and donations were received to fund this work.

### **Risk Management**

The major risks to which the charity may be exposed are reviewed regularly and steps taken to mitigate any risks identified. In particular, Health & Safety matters receive regular attention and there are in force Child Protection and Safeguarding policies in accordance with Home Office and Diocesan guidelines.

The Parish Safeguarding officer, on behalf of the PCC, operates a "safer recruitment" approach including appropriate use of DBS checks and also arranges for all relevant people to undertake training in safeguarding for both adults and children. Each year the newly-elected PCC review and sign the parish safeguarding policy at their first meeting.

### **Financial Review**

The Statement of Financial Activities shows a surplus of £10,539 which, coupled with an increase in investment value of £87,804 gives a very strong bottom line, but it should be noted that the investment increase was largely wiped out in early 2020, and that there were no capital or fabric works undertaken in 2019. Considerable financial support from the congregation has been a particular feature with general legacies received of £5000.

Planned Giving, which is the regular income on which the church depends to pay towards recurring items of expenditure decreased slightly this years. Collections also decreased. Bank balances and investment reserves remain healthy.

### **Reserve Policy**

The PCC's stated aim is to maintain unrestricted fund reserves equivalent to one half of normal annual outgoings. At present, the value of our reserves is more than sufficient to meet this target.

### Investment Policy

St Peter's has a number of investment funds, both restricted and unrestricted. These are currently managed following the Diocesan guidelines.

### Note 1 ACCOUNTING POLICIES

### (a)Basis of preparation and assessment of going concern

The financial statements have been prepared in accordance with the Church Accounting Regulations 2006 together with applicable accounting standards, the Financial Reporting Standard (FRS) and the Charities SORP FRS 102.

The financial statements have been prepared under the historical cost convention except for the valuation of investment assets, which are shown at market value. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body, nor those that are informal gatherings of church members.

The PCC constitutes a public benefit entity as defined by FRS 102

The trustees consider that there are no material uncertainties about the PCC's ability to continue as a going concern.

### (b)Reconciliation with previous Generally Accepted Accounting Practice

In preparing the 2016 accounts, the trustees had considered whether in applying the accounting policies required by FRS 102 and the Charities SORP FRS 102 a restatement of comparative items was needed at 1<sup>st</sup>January 2016. No restatements were required.

### (c)Funds Structure

*Endowment funds* are funds, the capital of which must be maintained; only income arising from investment of endowment may be used either as restricted or unrestricted funds depending upon the purpose for which the endowment was established.

*Restricted funds* represent (a) income from trusts or endowments which may be expended only on those restricted objects provided in the terms of the trust or bequest, and (b) donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of each year must be carried forward as a balance on that fund. The PCC does not usually invest separately for each fund. Where there is no separate investment, interest is apportioned to individual funds on an average balance basis.

Unrestricted funds are general funds which can be used for PCC ordinary purposes.

### (d)Income Recognition

Planned giving, collections and donations are recognized when received. Tax refunds are recognized when the incoming resource to which they relate is received. Grants and legacies are accounted for when the PCC is legally entitled to the amounts due. Dividends are accounted for when receivable, interest is accrued. All other income is recognized when it is receivable. All incoming resources are accounted for gross.

### (e)Expenditure Recognition

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding or constructive obligation on the PCC. The diocesan parish share is accounted for when due. Amounts received specifically for mission are dealt with as restricted funds. All other expenditure is generally recognized when it is incurred and is accounted for gross.

### (f)Tangible Fixed assets and Depreciation

Consecrated and benefice property is not included in the accounts in accordance with s.10(2) of the Charities Act 2011.

Movable church furnishings held by the vicar and churchwardens on special trust for the PCC and which require a faculty for disposal are inalienable property, listed in the church's inventory, which can be inspected (at any reasonable time).

Equipment used within church premises is depreciated on a straight line basis over 4 years. No minimum limit for the capitalisation of equipment has been fixed and the treatment of such expenditure is decided as it arises. Furniture and equipment includes crockery and utensils at St Peter's Hall at estimated cost. These items are held on a replacement basis and are not subject to depreciation.

### (g)Fixed Asset Investments

Investments are a form of basic financial instrument and are initially recognised at their transaction value and subsequently measured at their fair value as at the balance sheet date using the closing market price. The Statement of Financial Activities includes the net gains and losses arising on revaluation and disposals throughout the year.

The PCC do not acquire put options, derivatives or other complex financial instruments.

The main form of financial risk faced by the PCC is that of volatility in investment markets due to wider economic conditions, and their attitude to investment risk.

### (h)Pensions

The PCC have registered with NEST in anticipation of offering employees entitlement to join a defined contribution "money purchase" scheme but as yet no employees are eligible.

### (i)Stocks

Stocks of stationery are valued at the lower of costs and net realisable value. Stocks of wine and wafers are estimated at an approximation of cost.
