

TRUSTEES ANNUAL REPORT – 2018

Norfolk Youth Projects is a small Inclusive Charity working with young people age 11 to 30 years old. We have a board of 5 Trustees including the chairman. Norfolk Youth Projects has a Chief Executive who is a fulltime volunteer who is responsible for the day to day running of the Charity. We also have a group of volunteers who work with the Chief Executive. Some of the young people we work with become our new volunteers.

Our main aim of Norfolk Youth Projects is to plan and organise Cultural youth exchanges both in Norfolk and around Europe. These are funded by the European Union's Youth Programme Erasmusplus. During 2018 we were only able to host 1 project this was in the city of Tula Russia with the theme being Diversity. This involved 15 young people and 2 leaders people from each of Russia, Moldova, Spain and Norfolk. We had funding for another youth exchange in Ukraine but this was being put back to May 2019. We had put applications in for other cultural youth exchanges but had been unsuccessful with the funding.

During April we host a group of young people from Ukraine this involved a cultural experience with 6 days in London with a visit to the University city of Cambridge on the way to Norwich to spend 3 more days. The group was 7 young people and 2 leaders.

We continued with our project in August again it involved our partners from Holland called Kinderdorp (Children's Village) This involved 50 young people from an area of Norwich coming together in small groups building over 2 das small houses with pallets then on the 2nd night they slept in the houses. During the early evening of the night of the sleep over the group parade round the road near the school dressed up with lights, with the local people looking on and clapping. It also involved a group of 12 young children with 3 volunteers also involved building their own houses and joining in with the Norwich children. Then was also a group of 10 volunteers from Holland also volunteering at the project. The project took place at the Catton Grove Primary School so we should thank the school for the use of the school and grounds. We also got a grant from Auguish Education Foundation

Over the year we have been very successful undertaking many activities working with around 220 different young people
