Southwold (Sole Bay) Lions Club is a member club of the International association of Lions Clubs through Lions Club International.

The membership of the Club has remained at 13 during the period of this report. However, as most members are of advanced years it is a risk that unless new members can be found the Club may suffer as current members are able to do less. To this end advertising and use of social media is being used to try to recruit. Difficulties are being felt from the declining population of the town and surrounding areas as more properties become second or holiday homes. Although a push to increase the awareness of Lions and increase possible recruitment has not to date resulted in new members, efforts will continue.

All trustees have now read the guidance document, and it will be ensured that any new trustees will do so.

The Club has carried out the following activities this year in respect of the objects of the Club.

The Club planned it's annual Music on the Green event in July, when the Club organises a local band to perform a free open air concert in the centre of Southwold. The Club provides a BBQ and carries out a bucket collection, and this would have been in aid of the RNLI. Unfortunately, on the day, a forecast of extreme weather conditions with wind and rain forced the cancellation of the event on Health & Safety grounds.

Two full members and one associate member are Directors of the Henham Steam Rally committee and take full part in the organisation of the rally which attracts in the region of 15000 visitors annually. This involvement has continued. The main function for the rally to be to raise funds for Southwold Lions and two other Local charities. On the days of the rally Lions are involved in providing stewards, taking entrance fees at the main gates, helping steward as required, cleaning up afterwards and coordinating arrival of rally participants on the days before the public attend.

The Club again attended the Southwold Town Council Xmas Lights switch on at the end of November where they provided and distributed refreshments, other items, and information, to promote and advertise Lions to the public. In addition, Club members also provided a lighted crib on the high street.

In January the Club again arranged the very popular evening performance of the local Reydon & Southwold Pantomime Group, and invited other Lions clubs in the district to attend along with their families and friends. This helps to support the local amateur pantomime group.

In March the Club repeated the annual afternoon tea dance for local seniors. Around 50 persons from local care and residential homes were provided with transport and treated to afternoon tea and music in Southwold.

As well as these main events Club members also undertook activities in the local community such as organising car parking, attending Remembrance Day services and a Holocaust Memorial Day event, and assisting with a shop clearance.

Sadly, the remaining planned activities for the year were curtailed by the effects of the COVID-19 pandemic in the UK, and the imposed restrictions. Trustees must be mindful of the ages of Club members, and the attendant risks to their health.

It had been intended to arrange the Lions Spring Bank Holiday Fete again, but after some months of organisation the event has had to be cancelled this year.

Planning was also underway for Music on the Green in July, but it is not clear whether the event will be able to go ahead, given the present Government restrictions on public gatherings.

The Club's policy on grant making is based on how the organisation has carried this out over its 45 year history before becoming a CIO. Applications from the public are heard at normal Club meetings and discussed by all members and Trustees. Based on the merits of the application the Club is invited to propose a sum and vote to accept or reject, counter proposals may also be heard. If the vote achieves a majority approval then it is then ratified by the Trustees and if approved the grant is made by the treasurer to the person or organisation requesting assistance.

Applications for funding from Commercial organisations or for Commercial or for potentially illegal purposes are automatically rejected.

The Club does not at present have any investments.

As the Club comprises of just 13 members it would not be able to function without the contribution of additional volunteers, such as partners and family members at the major fundraising events.
