jWMAHMCIO TRUSTEES REPORT to the AGM March 2020

This is the Trustee's Annual report to members for the period February to December 2019.

Since the last AGM, one Trustee has resigned so there are presently 15 sitting Trustees. In accordance with the constitution, six Trustees must resign and are eligible for re-election. The six resignations this year are Elizabeth Taylor, Tim Rushton, Robin McQuillen, Roger Rice, Jon Fisher, Maria Filby. All are standing for re-election.

The Board of Trustees has met on five occasions since the last AGM. On most occasions Jon Hinchliffe has been able to join the meeting on Skype from America. All aspects of the charity's operations have been discussed. Contact with members between general meetings was maintained through four newsletters. There are currently 47 Honorary Members and 4 Annual Non Voting Members.

Steve Taylor has continued to manage the day to day aspects of the Charity and the museum has continued to thrive and continue as a successful and stable entity thanks to the financial support from some members of the Board of Trustees. There are presently four part time staff employed by the Charity at an annual cost of approximately £35000.

During the year, further alterations have taken place providing even more exhibition space and we now have a Royal Naval display and a larger German display following the purchase of replica uniforms by the Charity. Once again thanks must go to our Chairman Tim Rushton for his time and effort in building the new areas.

Regarding the charitable aims, the Charity has continued to work with a number of local organisations and schools and has hosted a considerable number of educational visits including a second evacuation day for Northwood Primary School. On most days, volunteers are available in the arms room to show visitors some of the weapons and allow them to handle them. This provides valuable education to both young and old. Visitor numbers for 2019 continued to be strong and we achieved 8000 visitors without our coaches compared to 2018 when we achieved 7500 including 1000 coach visitors. Once again the comments in the visitors book are highly complimentary and yet again we have achieved an award from Trip Adviser for consistently receiving 4 and 5 star ratings. The use of the shooting range and rides on armoured vehicles has grown considerably from 2018 and the Trustees will need to consider how to continue to meet the increasing demand for these facilities.

We have continued in our support of a SSAFA case and still work with No Barriers providing support for those in our society less able than most.
