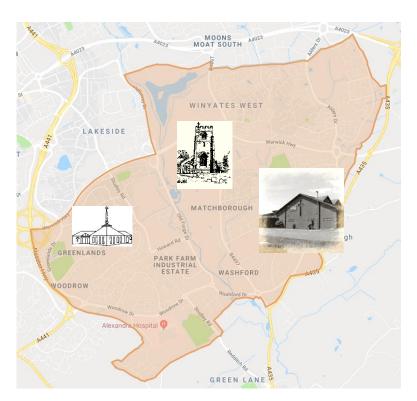


Parish of Ipsley Annual Report for the year ending 31 December 2019





Rector's Report

2019 has been a year like no other year.

Both of us stipendiary clergy went on sick leave. I was off from the end of February for six weeks, and Rev'd. Richard Harding went on sick leave for 8 weeks which was extended to the end of the year. Finally he took early retirement on the grounds of ill health. This was a difficult situation because both stipendiary priests being off sick meant that the parish would be left without any incumbent. The Rev'd. Ian Evans was coming to the end of his curacy at Christ Church, Matchborough and continued to provide pastoral care and leadership there. The Bishop asked the Rev'd Paul Lawlor, Rural Dean and Team Vicar in Holy Trinity Team to provide pastoral oversight and care at St. John's Church, Greenlands, while I recovered from surgery. The wardens and Licenced Lay Ministers very ably handled the work at St Peter's with priestly help from the Rev'd Ian Evans and the Holy Trinity team during this time.

I would like to pay tribute to the ministry of the Rev'd Richard Harding. Rev'd Harding was a hardworking priest, who puthis heart and soul into the ministry. He was a great support to me when I had surgery in 2017, and was off sick for a long period. He shouldered many of my priestly responsibilities giving me the space to recover. The Rev'd Harding was a man of prayer and deeply rooted in the Word of God. He had a vision and a desire to preach the Gospel of Jesus Christ to the lost. It was with his vision and encouragement that the Messy Church in Woodrow was started and till he fell ill he continued to provide leadership and insight. His defence of the Gospel was robust and clear encouraging and challenging all of us to live up to the fullness of the word of God. Christ Church in particular and the parish at large were concerned and saddened at his protracted illness and long absence. It was a sad day indeed when we learned of his parochial ministry being cut short and his having to take early retirement on the grounds of his continuing ill health.

On my return just after Easter, the Archdeacon decided that in view of my recovery from surgery and with Rev'd Richard Harding's extended sick leave, that Rev'd Paul Lawlor would be commissioned to continue the oversight of St John's. This was duly announced at the APCM in April of 2019. Sadly Rev'd Harding after a long leave of absence took the difficult decision to take early retirement. His last day as a stipendiary priest in the parish was the 31st of December.

I would like to thank Rev'd Ian Evans and Rev'd Paul Lawlor for the wonderful support they have given me in Christ Church and St John's respectively. The reports from the churchwardens following this will give you some more information on each church through the year.

As part of the direction given by the Archdeacon, the Ven. Nikki Groarke, the PCC and DCC began to operate differently. Where before the PCC took greater responsibility, each DCC now takes greater responsibility and did the bulk of their work. The three matters the PCC mainly dealt with over the year were Financial reporting, safeguarding and with matters of Health and Safety.

The Parish has continued to collaborate together in taking Open the Book to the schools. The four schools we have continued to visit have been, Matchborough First, Tenacres First, St. Thomas Moore, and Woodrow First schools, where they have been made very welcome. Both staff and children look forward to these presentations. At Christmas we offered them the booklets with the Christmas story printed by Bible Society. These were well received.

All three churches enjoy good relations with the local schools and continued this with visits from the schools over the year for various reasons.

The churches continued to support Messy Church held in Woodrow once a month. This has proved very popular and satisfying to both visitors and volunteers. It has not been without its challenges but has continued to be a source of witness and outreach. Reg Moore with his planning team have continued to work hard through the year as they have planned and prepared the services.

At Christmas as a parish we hosted Dougie Dug Dug for another Christmas Panto extravaganza at Christ Church. This was a sold out performance with many old and new faces in the audience. Thank you to Graham Russell community missioner at Christ Church, for his hard work and support in this.

Our buildings have been well used through the year. There is still some room for growth as we continue to seek God and His direction for the future.

St Peters Church

As wardens it is our pleasure and privilege to present you with the report for the year starting in January 2019.

Once again, we would like to thank Revd Canon Garth Nathaniel for his dedicated leadership and hard work during the year. Our services have continued well throughout the year and we also extend our thanks to those who carry out various tasks and duties week in and week out contributing to the life of the church.

Alongside our regular services there has been 24 Baptisms, 1 Thanksgiving, 11 weddings, 11 Funerals and 2 burials of ashes.

Our community based services have included, a Service of Thanksgiving, Remembrance & Hope where congregation and members of the community are invited to light a candle for a loved one who has died, the Healing Services where people can come for prayer and healing, and Christmas services, including a carol service, 2 Nativity services, Midnight Communion and Christmas morning worship.

Some special events have included the very well attended Bible course, the big story and a separate course on prayer, these both included breakfast. A successful twice a week Lent course, Lent with daylight, including lunchtime soup and roll or evening tea and biscuits.

Traditional Easter services were held at church for Ipsley CE RSA Academy, 3 separate services for 60 children at each service. Matchborough First School Academy came to church and enjoyed a pre- Easter service based on Palm Sunday.

We were pleased to welcome the 1st. Matchborough Beaver Cubs and the 1st. Birchensale Beaver Cubs to church to take their Faith badges which proved to be a heartwarming and uplifting evening.

The quinquennial inspection was carried out in September and a schedule of repairs has been drawn up, some items are still to complete. Boilers, lightning conductor and fire extinguishers have been serviced.

New projector and equipment have been fitted in the Huband Room.

The oil lamps in the church have been converted to suitable LED lighting. A thank you to Phil Wilson and the Building Management committee for the fitting of the lights and general maintenance work around the church buildings.

The Huband room and the squashy lounge have been let on a regular basis.

We thank God for his blessings and encouragement over the past year and look forward to being part of God's vision for the future.

Christ Church Matchborough Report January 2019 – December 2019

Another busy year, with weekly Support Groups, Prayer Group, Youth and Children's groups, a fortnightly Toddler Group, regular Ladies' Prayer and Men's Fellowship Breakfasts, several Fellowship Lunches following the Morning Service, and a successful summer Fun Fest for the local community.

A Worship Service for Youth began at Easter and was well received by an average of 16 young people.

Christ Church Community Project continued running the weekly Lunch Club for over-55s and facilitating the Watercolour Painting Group and Kindergym.

The Community Missioner enabled Open Door Coffee Drop In, Walking Football, and a new Walking Group. The visit of Bob Hartman to help those within the parish who teach children to effectively tell bible stories included a Storytelling session open to the wider parish, as was the brilliant Doug Horley pantomime.

Christ Church members take part in the wider parish ministries of Open the Book and Messy Church.

October saw Christian Prayer Ministries lead two days of ministry within our buildings, open to all.

Sadly, our vicar, Rev Richard Harding, was off sick for the majority of the year and took early retirement through ill health on 31st December 2019

Christ ChurchBuildings Report 2019

There were no major repairs carried out to Church or Church Hall during 2019.

The normal routine of tests (PAT, Gas, alarms) were carried out, Veolia and grounds maintenance continuing as usual.

At last, as fittings / tubes failed, lower church corridor and Church Hall coffee bar were improved in lighting terms by installation of LED units - total cost £258

Cleaning of Church Carpets (£450) and new Church Hall signage (£377) were the only large single items of expenditure to report.

Against an original Budget of £6000 for the two buildings, total spend amounted to £4562. Work to repaint external church woodwork was held over until 2020.

Health and Safety

Key document reviewed this year was the fire risk assessment which was resurveyed in October and actions from that brought to DCC's attention.

For the coming year one of the focuses needs to be ensuring compliance and health and safety checks are undertaken regularly and logged to show evidence of completion.

- Twelve accidents recorded in 2019 comprising of nine in the church building and five in the kitchen specifically, two in the church centre and one outside between the buildings. Of these accidents two required further investigation while the others were minor or related to individuals.

St John's Report 2019

Local Community

We continued our outreach to the local community through our monthly Tea Service, twice weekly Toddler Group, and weekly Short Mat Bowls sessions – all three activities proved popular, meeting a variety of needs. Some church members joined a weekly Pilates class in the church hall, which gave an opportunity to make new friends, and some of these joined us for our Christmas carol service! St John's continued to take part in parish projects such as Open the Book and Messy Church. St Johns musicians provided the music for carols organised by the Woodrow Community Group, with the local schools and other organisations contributing.

Church Hall

This building was in constant use to a variety of hirers who included Pilates, Chess Club, Belly Dancing, Brownies, Razzle Dazzle dance club and Slimming World. Special thanks must go to Philip and Annette Humphrey who managed the church hall bookings throughout the year. St John's continued to use the hall for Sunday children's groups, the Toddler group, and various other church events.

Children's Groups

Our children's work continued to be one of our strengths. Activities included games, Bible teaching and a monthly Activity Sunday (similar format to Messy Church) which also brought in families who attend the Toddler Group. In December, our children enjoyed the Doug Horley panto, and later in the month, together with their leaders, they led a fantastic Christmas service, written by one of the leaders!

Youth work for 12-16-year olds was re started in September 2019 and renamed JAM (Jesus And Me). Four youngsters and two leaders met each week in leader's homes for games, food, films, chat, a short

spiritual input, and prayer time. In August they spent an enjoyable day at Limitless youth festival in Malvern.

Clergy

In May 2019 St John's was placed under the leadership of Rural Dean, Rev Paul Lawlor. Paul helped us to evaluate all our activities, and to develop and focus on what we were doing well. Paul leads our Holy Communion Services and DCC meetings. We are blessed with a team of people who can lead services when he is elsewhere. In July, St John's were delighted to have produced a new member of the clergy! Many of us were thrilled to attend the institution of a former church member, Allison Davies, at Holy Trinity Church, Eckington!

Building and Ground Maintenance

A small team of volunteers continued to look after the church and its grounds throughout the year. This involved such jobs as keeping the lawns mowed and buildings clean. Additional maintenance jobs included repairing, stripping and varnishing church hall floorboards, painting the church hall kitchen, repairing the church roof, replacing lights and the large entrance mat.

Mission, Giving and Social

The church decided to tithe our annual income. We chose to give money to various charities including Tear Fund, The Church Army, Redditch Food Bank and Open Doors. In May we collected for Christian Aid, and in July we celebrated Sea Sunday, with donations going to support sea farers. In the summer we enjoyed barbecues in church members' gardens. In September we celebrated Harvest with a Bring and Share lunch, and in October we held The Big Quiz, with proceeds going to support Tear Fund. In November we invited a member of The Church Army to lead our Sunday morning service.

Redditch Churches Together

St John's participated in 24-hour Prayers for Redditch, the Good Friday Walk of Witness and Pentecost on the Green.

2019 proved to be another busy year at St John's!

Report of the proceedings of the deanery synod;

Deanery Synod meets three times a year, providing time and space to worship together, to share news and concerns. Small group discussion and prayer fosters good relationships between the diverse congregations of the Deanery.

Finance is always an item on the agenda, especially as the shortfall in diocesan funds became apparent.

The predominant concern of the year was Discipleship; resources, tried and tested locally, were shared which deepen the faith of believers as well as evangelistic tools.

Anne Batchelor, Mission Enabler in Holy Trinity Team, introduced her work to Synod, and Graeme Russell described his work here in Christ Church.

Archdeacon Robert Jones presented a talk about using our buildings for Mission at an Open Meeting in October 2019.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes an unincorporated charity.

The day to day management of the charity is carried out by the members of the PCC, all of whom are also trustees.

Recruitment and appointment of new trustees

Each DCC votes on its members annually at local level when they hold their individual Parish annual general meeting. New trustees are appointed by a majority vote and are given appropriate training to inform them of their duties and liabilities under Company and Charity Law.

Parochial Church Council

The Parish of St Peters Ipsley is made up of the churches of St Peters Ipsley, St John's Greenlands and Christ Church Matchborough. In addition a congregation meets at Ipsley C of E Middle School. The parish covers approximately one third of Redditch and includes the areas of Greenlands, Ipsley, Matchborough, Winyates and Winyates Green.

Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

OBJECTIVES AND ACTIVITIES

Objectives and aims

The primary objective of the charity is the promotion in the ecclesiastical parish of the whole mission of the church.

Public benefit

Thetrusteeshavecomplied with their duty to have due regard to the public benefit guidance published by the Charities Commission; the trustees consider that the charity meets the public benefit requirements of the Charities Act 2011 by carrying out its normal activities

FINANCIAL REVIEW

Reserves policy

It is the policy of this Parish to hold in reserves the equivalent of two months' general running costs and three months' salary costs. It is also our policy to hold an amount for essential building works as required, to comply with forthcoming Quinquennial inspections.

In applying these parameters, the individual situations of the three churches within the Parish have been taken into account and agreed at DCC level.

The policy will be reviewed annually as part of the Church year end accounts procedure, agreed by each DCC and consolidated into one Parish policy.

Going Concern

It is the view of the Trustees that the Parish finances are sufficient to continue activities as a going concern for the foreseeable future

REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 DECEMBER 2019

FINANCIAL REVIEW

This review is presented in the light of Covid-19 lockdown, which has precluded the normal face to face Annual Parish Meeting.

At the time of presenting this report, the Accounts have been audited and circulated electronically to PCC members. But it is not anticipated that the APCM will be achieved before deadline submission date of 31 October 2020.

The SOFA and Balance Sheet Statements summary points for the total Parish:

Income

- Total Voluntary Giving including Gift Aid remains quite static at £201.7K
- Total Income continues to be enhanced by CCM Lettings (Slimming World in particular), without which finances would be seriously affected.

Expenditure

- Total Parish Share year on year shows a £10K reduction.
- Operating Costs are £13.7K (11.2%) down year on year, reflecting economies applied throughout.
- Mission Giving has increased, notably at St Johns
- Mission / Evangelism at £6.7K equates to 3.3% of Total Giving

Funds

Overall Funds have improved across 2019 by £17K. Cash Funds have increase by £22K overall

General Comment

As always, we do need to address Giving levels. The Parish Giving Scheme has been introduced and is proving effective in assisting cash situation, with Gift Aid being claimed on a monthly basis. Moving from Envelope scheme to PGS is beginning to pay real benefits in both cash flow and administration terms.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2019

1. ACCOUNTINGPOLICIES

Accountingconvention

These financial statements have been prepared in compliance with FRS 102 Section 1A, the Financial Reporting Standard applicable to the UK and Republic of Ireland, the Charities Act 2011 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

The diocesan parish share is accounted for when paid. Any parish share unpaid at the year end is provided for in these accounts as an operational liability.

Other expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Freehold property not provided Plant andmachinery 10 -20% on cost

Consecrated and beneficed property of any kind is excluded from the accounts by section 10 of the Charities Act 2011.

Moveable church furnishings held by the Vicar and Churchwardens on special trust for the PCC, and which require a faculty for disposal, are accounted as inalienable property unless consecrated. For inalienable property acquired prior to 2001 there is insufficient cost information available and therefore such assets are not valued in the accounts.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
