We had a fantastic day at the tri-annual SCRAM event. This is a large county events seeing thousands of cubs coming together for the day enjoying a wide variety of activities. We had nerf wars, horse racing, rope making, sling shots and more on offer in the Spelthorne areas as well as hundreds of other activities and inflatables across the site. We even had cubs going live on the radio.

District camp took us on a road trip to the USA. Each pack took on a different state from America and devised their base based on it. We also held our inter pack competition. This year, each pack had to decorate a star to represent their state. We had mud, marshmallows, hula skirts and more. The voting took place at camp and also via Facebook which led to 8th Ashford winning. The bases were amazing- lassoing, dressing up as presidents, inflatable bucking bronco and more was on offer. Our road trip was amazing seeing what a diverse place America is.

Something that is becoming a regular event is our district summer camp. A longer, smaller camp than district camp this camp aims to help cubs really get the hang of camping and developing a love of being out and about. This year we headed off, by train, to Littlehampton and enjoyed some seaside fun. We entered the towns sandcastle competition, went to a real castle and found our how the RNLI help to keep us safe. Our swimming gala is always a fun event. It's great to see lots of cubs having a go either in the smaller pool, for less confident swimmers or the main pool for length swimmers. Both pools help to generate points towards the winning team. 1st Sunbury were our winning team this year.

We held a new, one off event, just before Christmas. Each pack was challenged to decorate a Christmas tree to form part of a tree festival. The packs also selected a charity to collected for as the best tree was voted for through donations. Hengrove looked amazing with hundreds of twinkling lights, 15 amazing trees (including Elvis, the tree) and a visit from Santa to check up on who had been good. Altogether, we raised over £300 for the different charities which will go towards their hard work. It was a great way to bring the line in our promise about helping other people to life.

Spring term saw another camp. Our Bi-annual camp to PGL in Hindhead. The weather was rather wet and windy but it didn't stop our action packed weekend. We enjoyed climbing, archery, zip wire and much more. It was proof that there is no such thing as bad weather, it's just not being prepared that stops you. The cubs (and leaders) love the camp as it is action packed, you get loads of food and the rooms have underfloor heating!

Each pack held their annual quiz at the start of the term with the winning teams coming together for the district final. There are some very brainy cubs and the results were close. Spelthorne District Scouts Annual Report

This year saw us bring in one new event our District 5-A-Side Football competition and our triannual District Camp. We also held our annual Bivvy night with our Master of Arms badge event postponed. James (ADC) and Seb (DSL) have been busy visiting different troops to hand out badges achieved from our camp and to also hear from the Scouts how they would like the district programme to evolve. Our plan is always to ensure our programme is accessible to all and 'youth led'. So with last year done, how did all the events go?

Our **District 5 a side football competition** was held in May. The entered teams (3rd Ashford, 3rd Staines, 5th Sunbury and 6th Staines), took part in a head to head mini league before the grand finale match between the league champions 5th Sunbury and league runners up 3rd Staines, the latter winning a tense penalty shoot out 4-3 to win the tournament and lift the trophy. Well done to 3rd Staines!

Our triannual **District Scout Camp** was held in June in the glorious sunshine at Tolmers Scout camp in Hertfordshire. 10 of our 13 troops attended our biggest District camp to date with well over 200 Scouts and leaders on site enjoying an exciting mix of the onsite activities (rafting, rifle shooting, climbing, land zorbs etc) and group led Scout skills bases (fire lighting, pioneering, challenges etc). Our Explorers - Scott Unit also attended, assisting with the bases, running the Sunday BBQ for all attendees and enjoying some of the onsite activities and a hike too.

Bivvy Night in November which is our post popular event of the year was attended by over 100 Scouts, 25 leaders and 14 Explorers. The weather was very mild this year meaning there were plenty of open shelters, but that didn't stop a supply of wood in demand to keep the fires going. Those midnight burgers and casserole go down a treat!

Our usual **Master of Arms badge event** was cancelled in March 2020 due to the growing concerns around Covid19.

Chief Scout Gold awards are an important milestone in the Scouting Calendar. This is the highest award to achieve in Scouts and is awarded through a county event throughout the year. Spelthorne had Scouts attend three of four events with 46 badges awarded and 31 members attend the ceremony. This is a great achievement which we thank all leaders and Parents for supporting their members through.

Planning was also underway for **Scoutabout 2020**^{*} in June where we have all troops signed up. Spelthorne have been supporting the plans for its growth and change with exciting new activities planned in. *Please note whilst planning was underway in January - March with all troops this has now been postponed until 2021.

As always our thanks go to all our leaders, volunteers and young leaders for continuing to deliver an active and engaging programme to all their members. Ours numbers continue to be strong with waiting lists seen in several groups. Here is to 2020 and beyond....

As we moved into the Summer term we continued to teach the Explorers valuable skills for life. They were split into groups and given a challenge to buy and cook a three course meal for under £5. During the Summer holidays we took the Explorers to Great Tower activity center in the Lake District for a week. This was a good evening outline the generosity of the residents of Spelthorne. The Explorers also took part in Winter Camp at Gilwell Park in January. We started using Booking Bug via the County Training Website for the courses from March 2020; however again because of COVID this was paused. Going forward this will be the way that people will book on to courses be it face to face or online.

There has been a compliance campaign from Headquarters, supported by the County and District to ensure all members are up to date with GDPR, Safety and Safeguarding. I would like to thank everyone who has taken it on board and completed the relevant e-learning. There are still people outstanding and this is gradually being picked up.

Carol and Oliver Davies have decided to step away from the training team and I would like to thank them for everything they have done over the years, and they will be greatly missed.

Section B

Risk and internal control

The District Executive Committee has identified the major risks to which it believes the District is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

Damage to property and equipment. The District has sufficient insurance in place to mitigate against permanent loss.

Injury to Leaders, helpers, supporters and members. The District through the capitation fees, contributes to The Scout Association's national accident insurance policy. Risk Assessments are undertaken before activities.

Reduced income from fund raising. The District is primarily reliant upon income from subscriptions and fund raising. The District does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The District Executive Committee could raise the value of subscriptions to increase the income to the District on an ongoing basis, either temporarily or permanently.

Reduction or loss of Leaders. The District Executive Committee is totally reliant upon volunteers to run and administer the activities of the District. If there was a reduction in the number of Leaders to an unacceptable level in a particular Group or Unit then there would have to be a contraction, consolidation or closure of a Group or Unit. In the worst case scenario the complete closure or amalgamation of the District.

Reduction or loss of members. The District supports activities for all young people aged 6 to 18. If there was a reduction in membership in a particular Group or Unit then there would have to be a contraction, consolidation or closure of a Group or Unit. In the worst case scenario the complete closure or amalgamation of the District.

The District has in place systems of *internal controls* that are designed to provide reasonable assurance against material mismanagement or loss, these include 2 signatories for all payments and comprehensive insurance policies to ensure that insurable risks are covered.

Summary of the objects of the charity set out in its governing document

The objective of the District is to support 13 Groups, 1 Explorer Scout Unit, and 1 Scout Active Support Unit with activities that are in accord with the aims of The Scout Association.

The Aim of The Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible citizens and as members of their local national and international communities. The method of achieving the Aim of the Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

Subscriptions are charged for membership to cover immediate running costs of the District and these do not unduly restrict membership. The District follows the principle that no one should be excluded because of their inability to pay membership subscriptions.

Two key principles demonstrate that Scouting's aims are for the public benefit.

1. Through the Scout method young people develop towards their full potential.

2. There is a clear link between the benefits for young people and the purpose of Scouting.

The safety of young people is taken very seriously and the benefits of Scouting activities provided far outweigh the risks.

All sections take part in regular camping activities, nights away, and outings. There are various programmes of fund raising across the Groups for both the Group itself and local and Scouting charities. The Sectional Leadership teams ensure that balanced programmes are planned to provide a suitable balance of activities.
