About Youth Sailing Charity London

What We Do

The Trustees confirm that they have complied with the duty in section 4 of the Charities Act 2006 to have due regard to public benefit guidance published by the Charity Commission.

Youth Sailing Charity London was established and gained charitable recognition on the 11th June 2019 as a watersports charitable trust based in the greater London area.

The primary objective of the Charitable Trust is:

To promote community participation in healthy recreation for the public benefit by organising or providing or assisting in the organisation or provision of facilities and access to sailing and water-Sports within London.

Who Benefits?

We are part of a living community within the greater London area and whilst our charitable activities are for young people and we also plan to encourage their families to get involved, taking a whole family approach to supporting young people. Our aim is to bring this living community together for the benefit of young people, who benefit from the skills, experiences, opportunities and in-kind support of older volunteers.

Who We Are?

We are a group of volunteers who are involved in watersports at various levels for many years throughout Greater London.

Our Resources and Working in partnership

We do not own and or lease any property or equipment but have develop extensive working relationships and partnerships with many watersport centres around London who will support out charitable activities for young people.

How Is This Financed?

The charity will endeavour to generate income as follows:

- Revenue from watersports activities
- Sponsorship

Funding Compliance Reports

Funding brings with it the necessity to produce compliance reports to the funders. All reports required were submitted in full and within the required deadlines.

Risks

As identified by the Trustees, the major risks to which the Trust is exposed will be under constant review and discussed at each and every quarterly board meeting; systems and procedures have been established and updated to manage any risks.

Financial Risks

Implications of Covid 19 and its negative impact on possible fundraising opportunities and general outdoor activities are a concern and constantly under review.

Financial Accounts

As the charity gained recognition in June 2019, we could not commence any prior fundraising and organise any watersports activities. Therefore, we missed many opportunities, and we are now concentrating our efforts for 2021. However, in the Autumn we did receive donations of £760 towards watersports activities and a loan of £1,000 from the Chair of the trustees towards the development of the website.

The charities' only expense during this period is as follows:

£1,000 initial cost towards the development of the website and CRM database systems

£278.92 to set up hosting of the website, domain and e-mail addresses and annual maintenance costs.

As of the 31st March 2020, the charity has a surplus of £431.08 in its current bank account.
