As of 31st March 2020, the charity has funds totalling £39,235 (2019: £33,265). The main account had a total income of £25,551 and expenditure of £27,580 (£8,000 moved to reserve account plus £19,580 normal expenditure). As of 31st March 2020, the Main account has funds totalling £15,583 (2019: £17,613) The reserve account had a total income of £8,000 (transferred from the main account) and expenditure of £0, leaving a net income of £8,000. As of 31st March 2020, the reserve account has funds totalling £23,652 (2019: £15,652) The charity's aim is to continue to operate within its income, as well as build reserves for any maintenance of the building which may be
