REPORT OF THE TRUSTEES OF TELFORD UNIT 405 (T S WREKIN) OF THE SEA CADET CORPS

The Charity Trustees present their report together with the financial statements of the charity for the year ended 31st March 2020. The financial statements comply with both the Charity's Constitution and the Charities Act 2011.

Aim of the Sea Cadet Corps

The aim of the Sea Cadets Corps is to give young people the best possible head start in life, through nautical adventure and fun, based on the customs and traditions of the Royal Navy. Our aim is to develop young people and support them towards responsible adulthood.

Charitable Purpose

The charitable purpose of the Unit is to promote the development of young people in achieving their physical, intellectual and social potential as individuals and as responsible citizens. This is achieved by the provision of education and leisure time activities using a nautical theme, based on the traditions of the Royal Navy and in accordance with the principles, ethos and practices of the Marine Society & Sea Cadets (MSSC).

In furtherance of the Purpose, the Unit offers young people a structured environment in which to develop; provides access to education and training including sailing, rowing, windsurfing, paddle sports, power boating, seamanship, navigation, marine engineering, cooking, music, first aid, drill, piping, and public services; it provides opportunities for young people to obtain a range of qualifications and a wide range of opportunities for community involvement.

Public Benefit

The trustees continue to give regard to the Charity Commission's general guidance on public benefit 'Charities and Public Benefit' provided by the Unit in relation to the charitable purpose of the Sea Cadets movement as set out in the activities and achievements as outlined in this report.

To achieve its aim the Unit encourages recruitment of young people from all backgrounds and abilities including where possible, and within the realms of Health and Safety, those with disabilities and develops their skills and abilities by:

- · Regular structured activities with a nautical theme
- Enabling young people to take part in activities connected with the wider Sea Cadet Corps
- Movement such as waterborne activities, events and competitions at district, area and national levels
- Availability of formal achievements whilst completing courses to earn badges and promotions

As the only Sea Cadet Unit in Shropshire, we offer opportunities which are unique within the county. The number of cadets currently on the books of T S Wrekin, and the number of adult volunteers suggests that people of all ages, abilities and from all sections of society are keen to take advantage of these opportunities. Contributions are kept low in order to ensure all those who wish to take part in the activities of the Unit may do so.

Covid-19

Following government announcements on 16th March, we made the difficult decision to close the Unit with immediate effect. At that point we did not envisage being closed for 6 months and the impact that the pandemic would have on all aspects of our lives.

Telford Sea Cadets have been very lucky. We have made attempts over the past few years to accumulate a safety net of approximately £5,000 which we keep in case of emergencies. If the need had arisen, we could have survived on that money for the period that we were closed: however, we did not need to touch this as the majority of our parents/carers continued to pay subs during this period. As utility bills were minimal, and bills such as insurance and rates are on direct debit, we knew what our outgoings were going to be and our Treasurer has managed our accounts to ensure that we still have a safety net.

The Unit has now returned to parading (briefly) and hope to do so again once the current lockdown ends. We have put in place a raft to measures to ensure that the Unit is Covid 19 secure, and these will remain in place until such time as the government deems it safe to remove all such restrictions.

We have not been able to do any fundraising for the unit since March but once the restrictions are relaxed, we shall have to start new fundraising campaigns and look for new grants to apply for.

Committee Meetings have continued during lockdown, with most happening virtually, as Telford Sea Cadets is a charity, and continues to be bound by both Charity Commission and MSSC governance regulations.

Achievements 2019/2020

Between April 2019 and March 2020 Telford Sea Cadets achieved the following:

- A successful Unit Review resulting in a Burgee being awarded again
- Attendance at local events including RBL parades, a St. Georges Day event and a WW2 event
- We have entered Drill and Piping Events, Football Competitions, Sailing and Paddlesport regattas and done well in all.
- Increased fundraising with Craft Fairs being added to our list of events
- Took part in a Swimathon
- A Presentation Evening saw many trophies, awards and certificates handed out.

Plans for 2020/2021

Due to the Covid 19 outbreak in 2020, most of the planned activities have been cancelled and there were no face to face activities at all between 16th March and 27th October. During this period some cadets chose to take part in On-Line Sea Cadet activities, with the delivery of sessions mostly being done by Telford staff, although some cadets did choose to do Area or National on-line courses.

We appreciate that not all cadets would wish to take part in yet more IT based learning, and that school work would have to take priority, but we wanted cadets to be aware that the staff and their friends within cadets were here for them. The unit in Donnington remained secure all

through lockdown, with only 2 people, CPO Tunks and PO Fowler, being allowed to enter the building for several months. This made cleaning the unit when lockdown measures were eased a lot simpler as we know the building had remained Covid 19 secure at all times. Following the submission of paperwork to South West Area, we have been given permission to re-open, albeit with many conditions in place.

Financial Review

Reserves Policy

The trustees continue to review the charity's requirements for reserves in light of the main risk to the organisation, that being a reduction of income. The trustees have established a policy whereby the reserves in total that are not invested in tangible fixed assets held by the Unit, should be up to the equivalent to 6 months overhead costs of the charity.

The level of these reserves has been determined by the need to meet the working capital requirements of the charity and also for the charity to carry out all of its legal obligations.

At the end of March 2020, the total of the charity's reserves stood at £8,996 of which £8,996 was unrestricted and there were no restricted funds.

The financial strategy of the trustees continues to be that of building the reserves which will be achieved by continually reviewing overheads, exploring additional means of income and further fundraising. The trustees will continue to take all necessary actions with regard to the prevailing economic climate.

Structure, Governance and Management

Units of the SCC are formed solely by volunteers in local communities. Each Unit is a self-supporting youth organisation and an independent charity with a central support management and training structure provided primarily by the Marine Society and Sea Cadets (MSSC). The unit becomes a part of the SCC by virtue of its' affiliation to the MSSC, the parent body of the SCC. In accepting this affiliation, the unit undertakes to comply with all regulations issued by, or on behalf of, the MSSC Council.

The Unit was registered as an unincorporated charity on 16th September 1963 and is governed by a constitution approved by the Charity Commission of England and Wales. A revised constitution issued by the Marine Society and Sea Cadets was ratified by the Board of Trustees between meetings in December 2017 in order to meet the deadline of 31st December 2017.

Recruitment and Appointment of the Trustees

Trustees serve and are re-elected on an annual basis. A minimum of 4 office holders: Chair, Secretary, Treasurer and Commanding Officer. UMT office holders are elected at the first meeting following the Annual General Meeting (AGM). UMT members are elected from the membership of the Sea Cadets Unit which is drawn loosely as being those with an interest in the unit. The constitution lays down specific controls for UMT membership and will be observed for all future recruitment.

In the event of a vacancy arising during the year (known as a casual vacancy), the trustees have the power to appoint new trustees. A trustee will serve until the date of the next AGM, after which the post will be filled by election.

The trustees are represented by a wide range of individuals drawn from the local community. Trustees have the power to appoint additional trustees to act jointly with them for all purposes. A trustee whose term of office has expired can be appointed for a further term of office.

Responsibilities of the Trustees

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charity (Accounts Reports) Regulations 2008. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.
