For the year ended 31 December 2019

The Trustees present their report and the financial statements for the year ended 31 December 2019. The trustees who served during the year and up to the date of this report are set out on page 1.

Structure, governance and management

The Charity is managed by trustees who are appointed by the church leadership. The board of trustees will consist of members equally representing the church leadership and church attendees.

Governing Document

The charity is governed by its Memorandum and Articles of Association as a Company Limited by Guarantee.

Objectives and activities / Public Benefit

The main purpose and objects of the charity are set out in the Memorandum of Association as follows:

- 1.1 to advance the Christian faith in accordance with the Statement of Belief in Carmarthenshire and in such other parts of the United Kingdom or the world as the Leadership Team may from time to time think fit and to fulfil such other purposes which are exclusively charitable according to the law of England and Wales and are connected with the charitable work of the Church;
- 1.2 to relieve persons who are in conditions of need or hardship or who are aged or sick and to relieve the distress caused thereby in the said location and in such other parts of the United Kingdom or the world as the Leadership Team may from time to time think fit;
- 1.3 to benefit the local community of Carmarthenshire and the neighbourhood by associating together with the said local community and the local authorities, voluntary and other organisations in a common effort to advance education and/or to provide facilities in the interests of social welfare for healthy recreation and leisure time occupation with the objective of improving conditions of life for the residents.

Achievements and performance

The year started with a team from the church presenting the GSUS Live experience at two local comprehensive schools, covering the life issues of fear, forgiveness and rejection. Over one thousand pupils attended the presentation, which was well received, and plans are underway to bring the exhibition back in early 2021.

Our Sunday morning meetings continue to be held at Queen Elizabeth High School in Johnstown. The venue is very accessible to the public with many families attending our Sunday morning meetings numbering around 150 people. We continue to run various children's clubs from nursery age to year 9 in High School. Our older young people meet on Wednesday nights, which encourages them and offers them the opportunity of attending various events. On Fridays, our young people "Tribe" group meet at Xcel for fun games and great bible teaching on life situations. Our "Life Groups" which meet mid-week continue to be well attended along with a bible school called "Rooted" with teaching from Rob Jones, which ran from January to May. In addition to all this, a Sunday evening "Encounter" service was launched and continues to be well attended.

In February, our women held their annual conference "Called to be whole" with visiting speakers Cath Woolridge and Gaynor Jones. The senior leadership also attended a conference at Revive church Hull and Soul Survivor church Watford. The women also had a weekend away at Hebron Hall in Dinas Powys joined by visiting speaker Lyra Vaz. Once again, we continued to support some overseas missions in Malawi, through "Fisherman's Rest" supporting in a food program and schools work in Blantyre. We also continue to support building an Education Centre in Keko, Dar Es Salaam. Many of the youth also attended an annual event called "Soul Survivor" at Peterborough.

A number were baptised during the year and there were seven babies dedicated during the year, which was wonderful. There was also a BBQ to thank all the Xcel Project staff and volunteers. This was our opportunity to thank everyone for the amazing job they do serving and meeting the needs of our community. We also had a few picnic lunches down at Pembrey enjoying the lovely warm weather together.

In July, we took part in our weeklong church mission with the great life-changing message that "God loves us and has a plan for our lives" this involved a team going out each day to bless their neighborhood by doing a litter pick. Throughout the year, we continued to run the Alpha course in partnership with Bethel Church and the Salvation Army, which is a great expression of unity for the churches in Carmarthen. Such was the success that it will be launched again in January. We also had an invitation to attend the Alpha conference in London.

Our annual Harvest Service took place in October where we encouraged everyone to bring items for Carmarthen Foodbank. The men of the church have met up a number of times during the year for breakfast, "Christian in sport"

evenings and a day conference with Chris Vaz as a visiting speaker. This was a great success. The Eldership of the church was increased and three were added to the team, which was well received by everyone.

This year we had two Carol Services one at Xcel Bowl led by the band of the Carmarthenshire music service and also a more traditional service at QE High with many members of the church taking part. Alongside the Carol services there was also the Carmarthen Foodbank Christmas event at Xcel Bowl where many who are in need in our community were able to come and enjoy a fun filled evening. There, they were able to meet Father Christmas, bowl and receive a Christmas hamper, perhaps one of the most emotional evenings of the year.

So again, a very busy year, for Towy Community Church and alongside the Xcel Project, all areas continue to grow from strength to strength, enabling the church to serve Carmarthen in practical and spiritual ways, helping us show God's love to our community and serving our vision of "Reaching people and Changing lives".

Xcel Bowl

Throughout the year, the bowling alley has partnered with local and national organisations through events and fundraising, engaging with Carmarthen Town council, Social Business Wales, Trinity St. Davids University, Carmarthen Round Table. In conjunction with Business Wales and South Wales Chamber, we hosted the Carmarthenshire Breakfast Cereal Drive raising funds for the Foodbank.

We also hosted a Careers Wales event, and the Bro Myrddin suppliers Fayre, which was attended by Welsh First Minister Mark Drakeford. Site tours were also held for a number of organisations, including Welsh Assembly members, local colleges and the Big Lottery Fund.

During 2019, we have welcomed Film Crews from the following organisations, wishing to showcase the Xcel model of Social Enterprise to promote community engagement, with over 30K views on social media channels. Development Trust Association Wales, Business Wales, Kingdom at Work (Texas USA), Big Lottery Fund and Wales Co-op.

Xcel Bowl have also been able to support a number of local charities by offering free or concessionary rates on bowling including McMillan Cancer support Cupcake Day, Purple Tuesday, Carmarthenshire Youth Service, Mencap and the Council Fostering Services. Additionally, we contribute £100 a month to local youth charity, Dr. M'z. Over the summer, Xcel supported various community events, making our portable bowling alley available for people to play on at Llandovery Motorbike weekend, Carmarthen River Festival, Leukaemia research charity day and 2 local school events.

Xcel Bowl continues to see a large number of local groups using the venue and facilities throughout 2019, namely Cartref Cynnes, Young Farmers Clubs, W.I groups, Cymraeg i blant, , Carmarthenshire County Council - Grwp Cefn Gwlad, LAC Team – Swansea, Centre for Business & Social Action, Church in Wales, Carmarthenshire Tourism Association, Sons & Daughters of foster carers, CVM, Swansea Social Services, Carmarthenshire Tourism Association, Barod, , CCC - Regional Learning, Wales Co-op, Rural Regeneration Officer, Chaos Theatre, Splatt, Family & Fostering Partners, Messy Church , Wales Wide meeting, Nolan UPVC Ltd, YBC - Young Bowlers Club. During the Easter period this year, our café provided a hot meals service for around 40 elderly residents of Cartref Cynnes for a period of 3 weeks whilst their kitchens were out of service.

New for 2019 was a Childminders pass for soft play, and the launch of Little Skittles Mom's and Toddlers playgroup which has over 50 children and their parents attend on Thursdays.

A number of local businesses have used our venue for team building events including McDonalds, Vue cinema, H.G. Bryer, Chwarae Teg and A & E Engineering.

We continue to have the support of Mencap again this year, which together with our relationship with Remploy has enabled us to offer employment and works experience to a number of disabled persons. We have been recognised as a 'Disability Employer' Company and have made several presentations on behalf of the DWP as an exemplar in Carmarthenshire and Pembrokeshire. Our Director, David Insull sits on the Disability Employer Engagement Group for South West Wales.

Additionally, our Directors are contributors to the Carmarthenshire CC Local Action Group, Carmarthenshire County Council Tourism, Leisure and Retail Cluster Group, Regional Skills and Learning Partnership and continue supporting QE High School Young Dragons.

We regularly have volunteers on placement including students and pupils from schools and colleges in both Carmarthenshire and Pembrokeshire, setting goals for their Business Studies and explaining Social Enterprise.

Once again, this year we hosted a brilliant evening of 'Carols at the Bowl' where we had a fabulous performance from the Carmarthen Wind Orchestra.

Foodbank

This year, we have worked with 50 active referral agencies in and around Carmarthen to identify those in need of the support of Carmarthen Foodbank. As a result, 1,355 three-day emergency food supplies were given out. A total of 3,172 people were fed, of which 1,246 went to children.

The community has been very generous donating a total of 39,851.40Kg to the foodbank over the year, which is an increase over the year before by almost 8,000Kg. Due to the increase in donations, we were delighted to receive a cost free lease of a unit in Merlin's Walk Carmarthen for storage as part of a national agreement between Trussell Trust and New River Retail.

The main donation periods in the year continue to be Easter, Harvest and Christmas, as well as two collections in the local Tesco Store during June and November/December.

We have continued to build stronger links into our community through sharing information and talks with our support agencies, particularly with Jobcentre Plus, who are our main referring partner, Carmarthenshire Housing, NACRO and the Salvation Army.

There have been opportunities and invitations to talk about the work of the Foodbank in local schools, through being invited to speak to the children and parents and also to carry out assemblies. We continue to host regular group talks in the foodbank for local clubs and organisations and the foodbank has had frequent coverage in the local newspapers for the work that we do which has helped to raise awareness.

This year again the foodbank supported the annual Christmas Family Event held in Xcel Bowl. Over 30 families were invited to an evening to celebrate Christmas. There was free bowling, food and drink, a Santa's grotto, face painting, free children's clothes and beauty treatments on offer. All children went away with a gift from Santa and each family received a Christmas Day food hamper.

Community Shop,

During a very busy year, we have increased our Volunteers to 25 and have employed a person who is responsible for running the expanded warehouse.

We continue to donate to other organisations in the area, including local schools, supporting them with families who find it difficult to supply the extra items needed for their children, for example, wet weather wear for outdoor play, and extra clothes for children who do not have the basics.

Another addition was the opening of our Pop- up Christmas Shop. This opened in October and ran until Dec. It was very successful taking over £3,000 over this period.

Customers and staff loved it and again it was our joy and privilege to donate Christmas trees and Decorations to families who were struggling over this Christmas time.

We also have donated to the Salvation Army, with sleeping bags for the homeless, toys to the Entertainer Toy Shop for their toy collection, and the Foodbank through the voucher system we have in place.

Xcel Recycled Furniture

2019 has seen continued community use of the recycled furniture project. Our free collection service has meant that throughout the year the project has collected and recycled 6132 pieces of furniture, including 134 large electrical items. That is 111 tonnes of unwanted furniture and white goods, which would have otherwise gone to landfill.

As well as selling low cost furniture, we have also donated to local people in crisis through organisations such as Women's Aid, Hafod Care and Carmarthen Social Services, giving away 9.29 tonnes of goods, being 138 items to a bottom book value of £7687, helping 68 individuals and families. We have also partnered with Elite, to provide work placement opportunities for 2 disadvantaged under 25's, as well as offering works experience to candidates from the Probation Service.

Financial review

Policy on reserves

The Charity's policy is to keep a minimum in general funds to run the organisation for 3 months.

Statement of trustees' responsibilities

The trustees are responsible for preparing the annual report and the financial statements in accordance with applicable law and United Kingdom Generally Accepted Accounting Practice.

Law applicable to charities in England and Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of charity's financial

activities during the year and of its financial position at the end of the year. In preparing financial statements giving a true and fair view, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011. Trustees are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1. Basis of preparation

1.1. Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charitles: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Financial reporting standard 102 - reduced disclosure exemptions

The charity has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland':

- the requirements of Section 7 Statement of Cash Flows;
- the requirement of Section 3 Financial Statement Presentation paragraph 3.17(d);
- the requirements of Section 11 Financial Instruments paragraphs 11.41(b), 11.41(c), 11.41(e), 11.41(f), 11.42, 11.44, 11.45, 11.47, 11.48(a)(iii), 11.48(a)(iv), 11.48(b) and 11.48(c);
- the requirements of Section 12 Other Financial Instruments paragraphs 12.26, 12.27, 12.29(a), 12.29(b) and 12.29A;
- the requirement of Section 33 Related Party Disclosure paragraph 33.7.

1.2. Change in Basis of Accounting

There has been no change to the accounting policies (valuation rules and methods of accounting) since last year.

1.3. Changes to previous Accounts

No changes have been made to accounts for the previous years.

2. Accounting policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year.

2.1 Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of donations and gifts and is included in full in the Statement of Financial Activities when receivable. Gifts donated for resale are included as income when they are sold. Donated assets are included at the value to the charity where this can be quantified and a third party is bearing the cost. The value of services provided by volunteers has not been included.

Tax Reclaims are included in the SoFA at the same time as the gift to which they relate.

Grants, including grants for the purchase of fixed assets, are recognised in full in the Statement of Financial Activities in the year in which they are receivable.

Income from investments is included in the year in which it is receivable.

Legacies are included when the charity is advised by the personal representative of an estate that payment will be made or property transferred and the amount involved can be quantified.

2.2 Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered and is reported as part of the expenditure to which it relates.

Resources expended are recognised in the year in which they are incurred. Support costs are those costs incurred directly in support of expenditure on the objects of the charity and include project management.

2.3 Tangible fixed assets and depreciation

Expenditure is capitalised if the asset has a useful life of more than 1 year and its cost exceeds £500.

Tangible fixed assets are stated at cost less accumulated depreciation. Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, on a straight line basis as follows:

Office Furniture and equipment	25%
Equipment, Fittings	10% (changed from 25% effective 1.1.16)
Bowling Lanes	10% (changed from 25% effective 1.1.16)
Buildings	2%

2.4 Stocks

These are valued at the lower of cost and market value.

3. Analysis of Incoming Resources

Donations income consists of regular giving by church members in tithes and offerings, plus "one off" gifts or donations. Where these gifts are given for a specific purpose they are held in a restricted fund. This includes gifts received under the gift aid scheme.

The incoming resources include the following Grants into restricted funds: None

4. Analysis of Resources Expended

Grants awarded – Grants are given in accordance with the objectives of the charity. All decisions on grant awards are considered and decided upon by the trustees.

The financial value of volunteer time has not been included in the financial statements but forms a crucial part of the success of the organisation.
