Report of the Trustees for the period 1st July 2019 – 30th June 2020

Aims of the Club

People and Communities

- 3. Organising and financing a Seniors outing to a pantomime at the Brewhouse, Burton upon Trent.
- 4. Maintaining a watching brief on progress with a project to improve the appearance of Burton railway station and surroundings.
- 5. Tidying the garden of a family that included a boy supported by The Donna Louise.
- 6. Initiating a hospital packs project.
- 7. Donations to: Foodbanks run by YMCA, Central Mosque, Caribbean Association, Salvation Army and Rotary Foundation; Hearing Dogs; Burton Addiction Centre; Macmillan Cancer Support; Midlands Air Ambulance; St. Giles Hospice; Red Lion House Community Centre; Burton Albion Community Trust; Staffs Wildlife; YMCA sleepout; Hearing Ambassadors; Derek's Tree; Star Award sponsorship; Speakability; Wheelchair Football; Speaking Machine; DEBRA; Guide Dogs for the Blind; St. Chad's Community Centre.
