Review of Activities and Achievements

The Charity does not operate any Homeshare projects but seeks to disseminate information to organisations who operate, or wish to, schemes of their own. It provides this information through its own website www.homeshare.org The charity also operates a Network for organisations, for a subscription, which provides help for those joining the organisation.

During the year the Charity searched for a partner to assist in administration. A Memorandum of Understanding was entered into with Shared Lives Plus, a registered charity.

In March 2019, the Charity participated in its 6th International Conference in Brusells organised by colleagues form 1Toit 2 Ages.

Board meetings are held using conference telephone calls and four such calls were held during the year. In addition the Management Team, a subcommittee of the Board, meet more frequently.

Future Plans

Our new relationship with Shared Lives Plus will mean changing the ways in which we operate. Our next International Conference is planned for 2021 in Liverpool.

Financial Review

Income for the year was £878 and expenditure was £4.023 a deficit of £3,145

Total reserves at 31 July 2019 were £5,683. The Board believe this is reasonable.
