Report of the Managing Committee for the year ended 31 July 2018

The members of the Managing Committee present their report along with the Financial Statements of the Charity for the year ended 31 July 2018.

The financial statements have been prepared in accordance with the accounting policies set out on page 8 and comply with the Charity's Constitution, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16 July 2014.

Structure, Governance and Management

The Charity is governed by its constitution and was registered with the Charity Commission in 1980. The constitution was reviewed and amended on 10 February 2011.

Managing Committee members are elected for a three year term at the Annual General Meeting which is usually held in October/November. The Managing Committee normally meets six times per year to consider the Charity's affairs.

New Committee Members are appointed from amongst the membership of the chorus.

Objects, Organisation and Activities

The Charity is established to advance, improve, develop and maintain public education in, and foster appreciation of the art and science of music in all its aspects by any means the trustees see fit, including through the presentation of public concerts and recitals in the Cathedral Church of Lichfield and elsewhere.

Members of the chorus comprise:

- a) Active members, who take part in the performance of choral works;
- b) Patrons, who do not take part in performances.

All members pay the annual subscription. The rates for 2017/2018 were as follows:

Full subscription	£90.00
Senior Citizens	£77.00
Students	£20.00
Patrons	£20.00 minimum

Ben Lamb, Director of Music at the Cathedral, is the Musical Director. Alex Woodrow, head of choral music, Solihull School is the accompanist.

In recognition of the free use of the Cathedral for practices and performances, the Dean and Canons of the Cathedral are entitled to membership of the Association without payment of any subscription.

In the event of winding up of the Chorus any surplus assets shall be given or transferred to an organisation having similar objects to those of the Chorus.

Achievements and Performances

The 2017/2018 season opening concert, Messiah was a total success, financially and artistically. A full house attended a magnificent concert that made a £2,934 profit.

The Annual Carol concert was popular, with a profit on retiring collection of £579. We are grateful to the Salvation Army Cannock Citadel Band for, once again, joining us.

The April concert, a performance of Dvorak's eloquently heart rending Stabat Mater, performance required large orchestral forces and with a disappointing ticket sale resulted in a loss of £2,396.

In May the Chorus put on a shorter performance of the Music of Parry, accompanied by the Cathedral's magnificent Hills Organ. This concert made a slight loss of £146

The Chorus controlled its costs whilst extending its Scholarship scheme, supporting 3 young people with their musical studies

The Chorus acknowledges, with thanks, free use of the Cathedral for rehearsals and concerts and was pleased to donate £4,000 during the year to the Cathedral. The chorus wishes to thank the Dean and Chapter for their continued support.

Due to officer illness, the chorus has been unable to provide accounts suitable for independent examination for 2 years. This has now been remedied and full statement of accounts has been reviewed independently.

Financial Review

The attached financial statements show the current state of the finances, which the Committee consider to be sound. Free reserves at 31 July 2018 totalled £19,517.

This falls within the range agreed by the Managing Committee and is held to finance working capital requirements and cover any future shortfall in income.

Public Benefit

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives and have complied with their duties under the Charities Act 2011.

Trustees Responsibilities in Relation to the Financial Statements

The trustees are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (UK Generally Accepted Accounting Practice).

The law applicable to charities in England and Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP ;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in operation.

The trustees are responsible for keeping accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Charities Act 2011. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.


