#### Updates:-

We discussed about last year achievements that our students this year 2019 achieved high grade in GCSE Continuously with the past 5 years our GCSE results have been a constant string of A\* and A's.

We reviewed our relationship with the college letting office to strength the way of communication and we appointed a delegate such as Ms Huda Mohammed to be in charge of communication in regard of advance booking or to sort problems should arise occasionally with the college.
