(1) TO PREVENT AND RELIEVE POVERTY BY PROVIDING FINANCIAL SUPPORT TO CHILDREN AND YOUNG ADULTS ANYWHERE IN THE WORLD WHO ARE THE VICTIMS OF WAR OR CIVIL DISTURBANCE, BREACH OF HUMAN RIGHTS, ANY PUBLIC CALAMITY (INCLUDING FAMINE, EARTHQUAKE OR PESTILENCE), THE IMMEDIATE OR CONTINUING EFFECTS OF LACK OF NATURAL OR OTHER RESOURCES, ANY OTHER CAUSE OF PROPERTY DISTRESS OR SUFFERING. THIS INCLUDES BY MAKING DONATIONS TO CHARITIES OR NOT-FOR-PROFIT ORGANISATIONS IN THE UK OR OVERSEAS.

UNDER THE NAME OF CLUB RANDO, THE CHARITY ORGANISES WEEKLY GUIDED WALKS FOR WHICH IT CHARGES A FEE. THE WALKS CURRENTLY RAISE AN INCOME OF APPROXIMATELY £7,000-£8,000/YEAR.

THE CHARITY MAKES REGULAR DONATIONS TO A FRENCH ASSOCIATION CALLED SOLEIL D'ETHIOPIE WHICH OPERATES IN ETHIOPIA. EDMUK'S DONATIONS ARE CURRENTLY FOCUSSED ON THE DJIMMA SCHOOL PROJECT. IN THE YEAR ENDED 31 AUGUST 2020, EDMUK MADE DONATIONS TOTALLING £6,000 TO SOLEIL D'ETHIOPIE. THE DJIMMA SCHOOL CONTINUES TO NEED FINANCIAL HELP TO COVER ITS OPERATING COSTS, TO PURCHASE BOOKS. WITH COVID AND DISTANCING IN CLASSROOMS IT NEEDS TO BUID 2 ADDITIONAL CLASSROOMS.

SOLEIL D'ETHIOPIE IS A REGISTERED FRENCH NON-PROFIT ORGANISATION (ŒUVRE D'INTÉRÊT GENERAL). IT PROVIDES THE CHARITY TRUSTEES WITH ANNUAL REPORTS ON THE DJIMMA SCHOOL SETTING OUT THE APPLICATION OF DONATIONS RECEIVED. SOLEIL D'ETHOIPIE HAVE A LOCAL REPRESENTATIVE IN ETHIOPIA AND ALSO VISIT THE SCHOOL ONCE A YEAR (LAST REPORT RECEIVED FROM SOLEIL D'ETHIOPIE ON 18/10/2020).

IN ACCORDANCE WITH EDMUK'S DONATIONS POLICY (INCLUDING OVERSEAS DONATIONS), AND CONSIDERING THE NEEDS OF THE DJIMMA SCHOOL, THE TRUSTEES INTEND TO CONTINUE TO ASSIST THE DJIMMA SCHOOL (VIA SOLEIL D'ETHIOPE) FOR THE FORSEABLE FUTURE.
