The Charity Committee is made up of an elected representative from each Lodge within the Province. The Chairman of the Committee is elected from within the Committee membership and serves a one year term of office. The Secretary to the Committee is appointed by the President of the Charity and also acts as treasurer.

To raise income from Mark Lodges within the Province for the relief of poor and distressed Mark Masons and their dependents and to support the Grand Mark Benevolent Fund and non-masonic charities within the Mark Province of North & East Yorkshire.

The Charity does not raise funds from the general public.

The Charity awards grants to non-masonic charities in the Province. These may be one-off grants or spread over a 5 year period.

Summary of the main achievements of the charity during the year

To be eligible for a grant from the Charity, non-masonic charities must be registered with the Charity Commission and either wholly based within the Province or ring fence any grant for use only within the Province, for the benefit of the local community.

The Charity has adopted a policy that 4 larger eligible Charities would be selected to be beneficiaries over a 5 year period. Other charities are eligible for one-off grants.

The Charity Committee meets twice a year and determines which charities should be awarded grants, and how much, having regard to the available funds.

In this financial year the Charity raised over £27,000 from within the Mark membership of the Province.

Grants were awarded to 12 non-masonic charities including the 4 in the 5 year programme. The total amount awarded was £19,000.

In addition the Charity supported the work of the Grand Mark Benevolent Fund with donations totalling £12,141.
