Achievements and Performance

The Lottery Project: Reaching Young People

This reporting period saw the end of our Lottery funded project: ESY Reaching Young People. Through this project we ran various activities.

Saturday Sessions continued to be offered on a weekly basis in term time providing activities such as cooking, various arts and crafts and sports. We also continued our Life Skills awards for young people at sessions.

Our second Drop-In ran at the Youth Hub at the Sir Robert Woodard Academy (SRWA) and we offered cooking activities, craft activities, homework support and also chill out spaces.

We continued our young carers support work at SRWA and this service continued to be popular with the young carers and once more we received requests for more of this provision.

Our detached youth work continued at Beach Green Skate Park and other locations around Lancing and Sompting, and in summer, we once more ran a Skate Jam event with the local council which was hugely popular.

Our Duke of Edinburgh (DofE) programme continued to run and we were able to offer "in house" expeditions for the first time and the majority of candidates were able to complete their awards.

As mentioned earlier, August 2019 saw the end of the Lottery Project Reaching Young People and working closely with young people, we came up with a new project which built on the work from last project. In addition to those original elements, the new project proposal saw the inclusion of a mental health element of the project with our own counselling provision, an increase in young carers provision and more after school drop-in sessions.

We submitted our application to Reaching Communities and were successful in attaining funding. The new project, ESY Supporting Young People, began in January 2020 and a new team of youth work staff have joined us for this project. We have also engaged the services of Your Space to provide the mental health support element of our project.

Unfortunately, as of the 17th March 2020, in line with government guidelines, we closed all face-to-face youth provision in response to the Covid-19 situation. Since then, the Charity has been using our Mobile Provision Van to work with the Lancing and Sompting Food Bank to transport donations and deliver food packages to people in need.

Other Charity Business

- In April, we started our practise expeditions for DofE, with the main qualifying expeditions taking place in June 2019.
- In July, our Coop Local Cause project, Space at the Table (SATT) began. The SATT project is delivered by several community organisations including local churches, ESY and the Lancing and Sompting Lions. This scheme provides two hot meals a week during school holidays for young people and their families who would normally rely on free school meals during term time. When we were awarded the final Coop Local Causes payment for this project, we were overjoyed to see fundraising had exceeded our initial expectations and we were awarded £6639.09. This has meant that the scheme can continue to run for at least

another 2 years. Meals were run over the summer holidays in 2019, at Christmas and were also planned for Easter 2020.

NOTE: When the Covid-19 lockdown began on 23rd March 2020, the plans for the Easter meal had to be cancelled, however SATT and the foodbank have been working closely together to ensure families who rely on free school meals and the food bank are still being provided with support and food at this time, and ESY staff have been delivering meals and supplies to help with this.

- In August 2019, in partnership with the Parish Council, we ran another Skate Jam event at the Beach Green Skate Park and we also took part in other local community activity days.
- During the summer we ran our usual summer activity programme which included a trip to Thorpe Park, Laser Tag, a trip to Flip Out Trampoline Park and a visit to The Base Skate Park. We also ran a work experience programme through our charity shop, allowing young people to gain experience of retail and customer service.
- Ongoing training for trustees, volunteers and staff has continued with a yearly update training on safeguarding.
- This year we also held a meal for all staff and volunteers for ESY, both shop and youth work, at a local restaurant to thank everyone for their hard work.
- Our charity shop in North Road, Lancing continues to provide a source of income for the charity. It is also useful as a physical expression of the charity's work within the community.
- Fundraising events have continued as a useful tool for generating income and awareness
 of the charity. This year these have included a car boot sale and we were lucky enough to
 be chosen as The Chair of Adur District Council's charity for the year. This has seen several
 fundraising events organised to support ESY including two Christmas concert events and a
 race night, and we are incredibly grateful to Councillor George Barton for his support.

Statement of Trustees' Responsibilities

Law requires the Directors for the purposes of the Companies Act 2006, to prepare Financial Statements for each financial year, which give a true and fair view of the state of affairs of the Charitable Company and of the net incoming and outgoing resources of the Charitable Company for that period. In preparing those Financial Statements, the Directors are required to: -

- Select suitable accounting policies and then apply them consistently.
- Make Judgements and estimates that are reasonable and prudent; and
- Prepare the Financial Statements on the going concern basis unless it is inappropriate to presume that the Charitable Company will continue to operate.

The Directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charitable Company and enable them to ensure that the Financial Statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Charitable Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Constitution

The Company was incorporated on 21st August 2007 and registered with the Charity Commission on 9th October 2007 (registration number 1121106).

<u>Objects</u>

The objects of the Charitable Company are to advance life and relieve the needs of young people. This will be achieved by providing recreational and leisure time activities and support which aims to develop skills, capacities and capabilities to enable young people to participate in society as mature and responsible individuals. The charity will be promoting education and looking for ways to relieve unemployment. This is summed up in our mission statement "Supporting teenagers now, laying foundations for the future".

Public Benefit

Electric Storm Youth Limited welcomes all young people (aged 11-18) on an equal opportunities basis (regardless of faith, gender or personal circumstances). We believe in encouraging young people to belong to a community by developing their self-confidence and helping them aspire to achieve in life.

Tangible fixed asset and depreciation

No tangible fixed assets are held which require depreciation.

Reserves Policy

The Directors are keeping reserves for the company in order to finance the necessary activities of the company in accordance with its objects.

Risk Management

The trustees are accountable under the Articles of Association, which incorporates company and charity law. The financial liability of individual members of the Charity is limited to the £1 membership contribution. The Directors will prepare and / or approve all relevant policies as becomes necessary as the charity achieves its objectives.

Appointment of Trustees

The Articles of Association provide for a minimum of two and no maximum number of Directors. Directors do not have a specified time-limit on their appointment.

This report has been prepared in accordance with the special provisions for small companies under Part 15 of the Companies Act 2006 and was approved by the Board of Directors on 28 May 2020

1 Accounting policies

Basis of accounting

The financial statements have been prepared under the historical costs convention and in accordance with the Companies Act 2006 and in accordance with the Statement of Recommended Practice on Accounting and Reporting by Charities issued in March 2005.

Company status

The charity is a company limited by guarantee. In the events of the charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the charity.

Fund accounting

Unrestricted funds are available for use at the discretion of the directors in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Designated funds are unrestricted funds earmarked by the directors for particular purposes.

Restricted funds are subjected to specific restrictions on their expenditure imposed by the donors or through the terms of an appeal.

Incoming resources

Incoming resources are accounted for on an accurals basis, being mainly donated income.

Resources expended

Expenditure is recognised on an accurals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Governance costs are those expended on the governance of the charity rather than those associated with the general running of fundraising activities.

Tangible fixed asset and depreciation

Tangible fixed assets consist of one laptop computer and Wii (depreciated from 2013 onwards at the rate of 33.33% per annum) skate ramps and sports equipment (depreciated from 2013 onwards at the rate of 25% per annum) on a straight line basis.
