## Manager's Report

There was no indication at the time when my report begins just what would lie at the other end. Back in April 2019 DAG embarked upon the new financial year in the same way that it had done for the past three decades: looking to maintain and develop its disability information and advice service in the face of ever increasing demand and, of course, constantly on the look out for new sources of funding. yet... twelve months later the group found itself confronting a totally unprecedented and unforeseeable set of circumstances, created by national lockdown in response to the coronavirus pandemic, which would cause it to re-focus and re-shape its service delivery. But for now, this still lies a little off way in the future and 2019-20 saw DAG busier than ever; responding to a greater number of requests for help with key disability issues and offering a wider range of Treats activities than ever before.

Increasing numbers using our service, combined with the ever dwindling availability of resources that offer sustainability, are an ever present pressure on the group; yet last year we responded to over 6000 enquiries for support from local disabled people and their families. Alongside DAG's work with members of the public, it continued to campaign for a more just benefit system for disabled people, yet despite it's direct protestations to DWP in this period, the latter continued to sanction a plethora of particularly inconsistent health assessments and to preside over generally flawed decision making in its execution of the qualifying criteria for disability benefits. In consequence significant numbers of disability benefit claimants, who found themselves in desperate plight having experienced reduced or lost benefit entitlement, sought our help. We found that in too many cases loss or reduction of benefit was often accompanied by an inability to meet the costs of basic living needs, the threat of imminent homelessness and a loss of access to a variety of statutory services. Even those managing, albeit without any sort of permanent assurance, to "scrape by" confided in us their feelings of increasing isolation and oppression as well as a rapidly diminishing ability to find their own way out of desperate circumstances.

Our help always seeks to ensure a much smoother, better informed and ultimately successful passage through the benefit system for our service users, as well as to provide an increased awareness of and access to other services for disabled people.
Furthermore, through its popular Treats project, the group offers the opportunity for many local disabled people to overcome social isolation by pursuing a variety of free leisure activities in a warm and supportive environment.

In this way, DAG continues to occupy a vital role in the local community at a time when disabled people throughout the nation feel increasingly dislocated from avenues to social inclusion. The group is widely perceived as champion of disability and indeed is unshaken its expressed aim of seeking to empower the disabled people by the provision of services that are geared to helping this sector of the community achieve equality and social justice. I find it to be particularly gratifying, therefore, that those who offer our services, the majority of whom are volunteers, show such skill, dedication and empathy by providing vital help and support to all those who seek DAG's support.

## Independent Examiner's Report to the Trustees of Scarborough \& District Disablement Action Group, Charity Number 703172

I report on the accounts of the Charity for the year ended 31 March 2020, which are set out on pages 2 to 10 .
