REFERENCE AND ADMINISTRATION

The Shiloh Pentecostal Church (Dalston Branch) is registered with the Charity Commissioners (number 270261) and constituted by a Deed of Trust dated 22 July 1968. The principal place of business is Shiloh Pentecostal Church, Ashwin Street, Dalston, London E8 3DL.

The society is administered by charity trustees comprising:

STRUCTURE, GOVERNANCE AND MANAGEMENT

The society is constituted and governed by a Deed of Trust dated 22 July 1968 and trustees are appointed or reappointed annually at the Annual General Meeting.

OBJECTIVES AND ACTIVITIES

The objectives of the Shiloh Pentecostal Church, Dalston, are the furtherance of the gospel of Jesus Christ and to provide a place of worship and spiritual guidance to the community.

ACHIEVEMENTS AND PERFORMANCE

Shiloh Pentecostal Church (Dalston Branch) continues to be a place of worship in the community under the leadership of a Pastor and Assistant Pastor.

The church supports a number of overseas churches in India, Indonesia and Uganda through its missionary grant fund. Grants are made on a regular basis to overseas missionary outreach work. Support is given to a number of overseas orphanages in India, Indonesia and Uganda. This year grants of £4,833 (2019: £5,500) were awarded.

FINANCIAL REVIEW

The society only has unrestricted funds and there is no particular policy on reserves. The reserves are used towards the maintenance of the properties (vicarage and church buildings) and to provide sufficient funds to cover Pastors' salaries and administrative costs for twenty-four months. The principal funding sources are church offerings and rent received.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF THE SHILOH

PENTECOSTAL CHURCH (DALSTON BRANCH)

We report on the accounts of the Trust for the year ended 5 April 2020 which are set out on pages 3 to 6.

Respective responsibilities of trustees and examiner
