# M.VER (M.LHR - Mission Life and Hope Restored) Annual Report 01/06/2019 – 01/05/2020

#### A) The work in Ceará in the Northeast of Brazil

Last year Proclamation Church built a wall around the new plot of land but as yet has not had the funds to start building the Community Centre. A project to try and raise funds has just been launched called DigDog using a Hot Dog Delivery service during the COVID. So far this is going really well and the DigDog hopes to open a small snack bar area in town when things get back to functioning better!

During this crazy time of lock downs the church has kept its doors open for counselling, distributing food parcels and masks and online services. The community of Cariré have benefited from this and hopefully the church will see new faces coming to the services once it reopens.

The Missionaries Izaias and Ruth leading the M.LHR base in Ceará have now started the beginnings of a second church in Reriutaba, a 40 min drive away. The House group is growing rapidly as the couples and families coming along are more mature in their faith and some have moved there from bigger states like Rio de Janeiro and therefore have a broader outlook on what they can do for the community.

Their goal for the next year is to get both churches with enough leaders trained up to lead well so that Izaias and Ruth can supervise more instead of hands on ministry.

#### (B) M.LHR projects in Belo Horizonte

Christian College LHR has not stopped earning the seal of being one of the best schools in Brazil even through it has had some tough times especially during the COVID. The College is functioning well online from 7:30 – 17:30 with digital lessons for the students of all ages. Unfortunately many parents have lost their jobs so the College I relying on donations to complete the teachers salaries. They are waiting for the ok from the local government to be able to return to lessons at the college.

A Small report on each class...

**The 1st year class** is composed of 20 children. The children are curious, hardworking, loving and have corresponded to online classes very well. All the children managed to advance in reading and writing in their digital class.

**The 2nd year class** is composed of 22 children 7 years old. The children surprised their teacher with their commitment to adapt to digital classes.

**The 3rd year class** is composed of 21 children 8 years old. The children are cheerful and spontaneous. The effort of these students to participate in digital classes is contagious!

The 4th year class is composed of 28 children 9 years old. They are a very studious and dedicated class.

**The 5th year class** consists of 27 children aged 10 years old. They miss school a lot, but even so, they strive to participate in digital classes.

The 6th grade class is composed of 25 teenagers. Friendly, studious and cheerful, they are being excellent students in digital class.

**The 7th grade class** is composed of 20 teenagers of 12 years. The class is well cheerful and restless. The digital classes have been challenging.

The 8th grade class is composed of 13 teenagers. They are a class that has many difficulties in adapting to digital classes. The teachers have endeavoured to pray and help the class. They are really missing school and their peers!

**The 9th grade class** has 11 teenagers in their last year at school. They can't wait to return to school to organize their Graduation and say their goodbyes.
