TRUSTEES ANNUAL REPORT 6th JUNE 2019 TO 31ST MARCH 2020

Objectives and Activities

The objects of Children's Charity Merseyside are to improve the conditions of the life of children and young people in Merseyside and surrounding areas who are in need as a result of ill health, disability, financial hardship or other disadvantages. This will be achieved by assisting in the provision of specialist sensory or recreational equipment and the provision of recreational and leisure time activities provided in the interest of social welfare, designed to improve the conditions of their life.

We will endeavour to arrange fund raising activities including Afternoon Teas, Christmas Lunches and a Golf Day. We will also arrange a Christmas party at the Hilton Hotel with children from schools in the Merseyside area.

Achievements and Performance

Our main fundraiser was the successful Carvers Lunch event which attracted 300 guests at the Hilton Hotel, Liverpool One in December 2019. The preparation commenced in September culminating with the Lunch held in December. This event is the cornerstone of our fundraising with events for the coming year announced to guests, Afternoon Teas and a Golf Day were planned for the next year but unfortunately most events were subsequently cancelled due to the pandemic. We have commenced providing assistance where requested with Appeals and Donations totalling £604 in this period.

Appeals met: Bedding for autistic child in Southport £104

Costs of outing to Chester Zoo £500

A Christmas party was held for 150 children from local inner city schools at the Hilton Hotel, Liverpool One in December 2019. This is to become an annual event.

Financial Review

Total receipts of unrestricted funds during the accounting period 6th June 2019 to 31st Match 2020 were £54676. The bulk of these funds was the transfer of £33824 from Merseyside Children's Fund, an account used prior to obtaining full charity status with the Charity Commission. Donations amounting to £1803 were received, mostly sourced by Trustees. The Carvers Lunch in December 2019 was our main fundraiser with a profit of £18652. Unfortunately our planned events for the early part of 2020 had to be cancelled due to the pandemic.

The net result for this period was an excess of receipts over payments of£46991 as evidenced with the bank statement showing a balance £46991.03. This amount is carried forward to the beginning of the next reporting year. An Independent Examiners Report was conducted by Mrs Katrina Kenny who has examined the accounts and procedures and has no concerns regarding the accounts and accounting records. Statement of account exhibited and balance confirmed. See accounts and balances listed below.

Structure, Governance and Management

The Trustee Board still maintains the original 6 Trustees who, although not meeting every month in person, have maintained regular contact with each other during the lockdown periods in order to make decisions and to evidence the financial accounts. Full minutes have been taken at meetings.
