## THE OBJECTS OF THE CHARITY

To further or benefit the residents of Tur Langton, Church Langton, West Langton, East Langton and Thorpe Langton and the neighbourhood, in the county of Leicestershire — without the distinction of sex, sexual orientation, race or of political, religious or other opinions — by associating together the said residents and the local authorities, voluntary and other organisations in a common effort to advance education and provide facilities in the interests of social welfare for recreation leisure time occupation with the objective of improving the conditions of life for residents.

In furtherance of these objects, but not otherwise, the trustees have power to establish or secure the establishment of a community centre and to maintain or manage or co-operate with any statutory authority in the maintenance and management of such a centre for activities promoted by the charity in furtherance of the above objects.

## SUMMARY OF ACTIVITIES FOR THE YEAR

### Church Langton Primary School Clubs & Classes

The hall is used by Church Langton Primary School for a number of activities including a Breakfast Club and an After-School Club.

### Sport / Fitness

Activities by user groups including: Market Harborough Table Tennis Club, New Age Kurling, Tae Kwon Do and the Welland Valley Cycle Club. Fitness activities include: yoga, general keep fit, pilates and dance.

### Clubs / Societies

Groups that meet in the Hall include the Langtons Art Group, Great Bowden Recital Trust and Harborough Big Band.

### Social Events

The hall is a popular venue for children's parties; a number of weddings and wakes were also held during the year; and films are screened for the community from time to time in association with the Phoenix Cinema.

### Other Activities

There are ante-natal classes, and East Langton Parish Council meets in the Hall. The Charity publishes a community newsletter approximately four times a year which is distributed to local villages.
