1. Our collaboration and members exhibitions in Mill Bridge Gallery continues successfully. New exhibitions are planned.

10 artist members exhibited during 2019-2020.

Collaboration continues with a new year long series of 10 exhibitions with even more integrated collaboration with Mill Bridge Gallery. Our greatest Thanks and gratitude for the amazing support of local artist and Craven Arts to owner Carina Wardle.

2. Our CA Studio became one year old in June 2019 on 7a Otley St. Skipton

4 artist members have worked in the premises during April 2019 - March 2020. 5 artists have exhibited on the Members CA-Wall during this time and sales

from the space are up every month along with the increasing number of Workshops hosted in the Studio space.

Visitors numbers are steady and there are about 5 people visiting every week day and about 12 people every Saturday.

3. Craven Arts Membership has grown to 75 from previous years 65.

Even if we have lost few members on the way we have gained many more and have some returning members too.

Craven Arts hosted two events in 2019: 1. Craven Arts Weekend: Summer Arts Trail Successful event on August 24th and 25th 2019 in multiple locations in Skipton. Featuring 15 Craven Arts Members.

Successful event on 29th Nov - 8th Dec 2019 in Craven Arts Studio. Featuring 16 CA Members. Great comments, good response from local press. Good sales ~£500.

Craven Arts Exhibition Openings in Mill Bridge Gallery have been a successfull social regular get-together for artists members/ non-members and general public.

We made connection with The Yorkshire press and Art Shop Skipton for sponsorship and discounts.

- Carven Arts has plans for expansion of studio spaces. Plans on the way with local councils; Craven Arts House as a community group is created for the project with a trustee board.
