The charity has continued to supply parcels of tinned, dried and fresh food to ensure a balanced and nutritious diet sufficient for 3-days upon presentation of an appropriate voucher.

The charity has also tried to assist through other means including money advice and sign posting to support and advisory services.

#### Additional details of objectives and activities (Optional information)

Blackburn Foodbank does not currently issue grants.

There is no policy on programme related investments. However, our grant aided programmes are aimed at improving facilities and services.

Programme investments include:

- Installing an additional kitchen to help feed guests and perform cooking demonstrations; and
- Replacing inefficient underfloor heating with electric heaters to reduce electricity costs.

Foodbank could not function without our volunteers continued generous donation of their time. Roles include:

- Reception;
- Cleaning;
- Kitchens:
- Café:
- Pantries;
- Various guest facing roles;
- Driving; and
- Warehouse.

## Achievements and performance

Summary of the main achievements of the charity during the year

The Trustees continue to be pleased with the progress being made.

The fund-raising team have had success in raising funds. Their success secured our continued operation for this and the next financial year.

Their efforts enabled the continued employment of 4 part-time staff, and has run a number of projects relating to our core activities. We will be seeking grants to enable us to move from 18-hours (3-days) per week operations to 5-days a week.

The budgeting team have continued to optimise fiscal control.

We currently have around 50 volunteers, and we are seeking funding to employ a Benefits Advisor, Volunteer Co-ordinator and Project Manager.

For the year 2019-2020 Blackburn Foodbank provided assistance to the people of Blackburn with Darwen in the following areas:

- 11,791 individual 3-day food parcels (2018-19 10,186);
- Food donated 94,410kg;
- Food supplied 94,585kg;
- Money Advice £536,080 of debt managed to date;
- Computing facilities and assistance with computing skills;
- CVs, job searches etc;
- Eat well for less cooking classes;
- Make and mend drop-in workshops; and
- Sign posting to other organisations who may help.

It should be noted that the COVID-19 pandemic has greatly affected out operations in the final quarter of our year.

To minimise the risk of bring infection into Foodbank, we moved to a contactless delivery model. In this endeavour we received generous help from other companies and charities.

This model and the compartmenting of roles within Foodbank greatly reduced the number of volunteers that could be accommodated. And all face-to-face activities with guests had to stop.

Additionally, around the time of lockdown our food donations collapsed. This was mostly countered by additional one-off grants and other monetary donations. These allowed us to bulk buy food to cover shortages.

The Trustees will then seek permission from the members to dissolve this trust and transfer its assets to the CIO.

The reason for the change. We have been advised that donors prefer to deal with an incorporated body rather than with trustees.
