Minutes of the District Annual General Meeting Held at Ross Wood on Wednesday 10th July, 2019

1. Welcome by the District Chairman

Russell Feast welcomed everyone to the meeting, especially the Lord Mayor Councillor Terry Westgate and the Demelza House representative Claire Battersby. There was no County Representative. A total of 29 persons attended the meeting and apologies were received from Jack Dale, Elaine Oakley, Sylvia Carter and Pay Wells.

2. Approval of Minutes

Minutes of the 2018 AGM were distributed last year and are also included within this year's Annual Report, available prior to the start of the meeting. There were no errors or omissions reported. Proposed as a true record by James Oakley, seconded by Lynette Smith and agreed. Signed by Russell Feast.

3. Trustees Annual Report

Russell Feast informed the meeting that a primary aim of Scouting is to be able to offer opportunity to young people. Ever conscious that camping and outdoor activity are important elements of a young person's development, the Trustees continue to support plans to enhance the District Camp Site at Ross Wood and have financed the provision of more facilities and improved activities. We are pleased to note that the number of young people in our District has increased greater than in many other Districts and we feel this growth in membership is due to the hard work put in by our enthusiastic leaders. Our concern about being able to get new helpers through the appointment process quickly and fully integrated into Scouting remains, but we are pleased to note the progress being made in this area.

4. District Treasurer's Report

Mary Bentley presented the accounts as detailed in the Annual Report, showing a net profit of £8,271.68. The District has maintained its capital investment position and continued to support the maintenance and development of the Ross Wood Campsite and other Scouting activities. The District retains its substantial level of reserves held in investment accounts. Although most interest rates remain low, our investment in the M and G Charifund has performed well and been a big source of income over the two past years. We also continue to allow for the creation of a development strategy into sustainable Scouting activities and benefits. The main capital expense was for the construction of the Climbing Wall which has already proved to be a great enhancement to the campsite. We have also built a Bike Shed complete with workshop where we have 25 mountain bikes for use in the surrounding area and woodland.

Members of the District Team have been allocated a budget of £250 per year to aid in the promotion of Scouting and this can be used for advertising, admin, or putting on special events.

The Executive Committee believe it is important to review the choice of examiner regularly and this year, changed our independent examiner to Jane Neame of Whitstable. Mary also reported that the District meets the Charity Commission's Public Benefit criteria under both the Advancement of Education and Advancement of Citizenship or Community Development headings. Proposed Wendy Miller, seconded Brian Buggins, approved.

5. District Chair's Report

I seem to recall that family comes first, then work, then activities such as Scouting, but I know we often juggle these to meet demands and pressures. Clearly, our District Commissioner Jamie Bentley has become quite proficient at juggling over the past year! His family life and new baby, professional studies and exams, and his role as DC have demanded much more than should reasonably be expected of anyone, so I congratulate him on what he has managed to achieve and look forward to a closer working relationship in the future.
