Objectives and activities

The charity's objects

To promote, for the public benefit, the preservation, care and improvement of Farsley Rehoboth Burial Ground as a place of historic and ecological interest.

To advance the education of the public through the preservation and maintenance of Farsley Rehoboth Burial Ground.

The charity's main activities

Following 11 years of neglect and locked gates we were established to purchase, reclaim and maintain the Farsley Rehoboth Burial Ground as a public open space and community asset.

Public benefit statement

In setting our objectives and planning our activities our trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular the establishment of a community owned asset.

Achievements and performance

A key aim from the first day of the reclamation has been to make the Rehoboth fully accessible inside the site; in particular to ensure the main road and tracks are wheelchair compliant. We have constructed a flood proof entrance and created a Groundguard to link in the gates to the Victorian Carriage Road.

We have 140 registered supporters and 74 inducted volunteers who have taken part in our thrice weekly working sessions as well as partnerships such as Co-op Academy Priesthorpe (Pudsey).

Our Leeds Civic Trust supported Heritage Open Day on Sunday 22nd September 2019 had over 140 attendees taking part in five tours. Additional "overflow" tours are taking part on Saturdays and Sundays during the weeks up to and including Sunday 27th October 2019.

Building work has now extended to creating a newly surfaced track across the full width of the Rehoboth, around 150 yards with the first section completed in November 2019. This work has been funded by Wade's Charity and the work and commitment undertaken by our volunteers.

Financial review

The net receipts for the period were £12,332, including net receipts of £10,116 on unrestricted funds and net receipts of £2,216 on restricted funds.

Reserves policy

The charity's free reserves, excluding fixed assets, at the period end were £10,116.

There is no written reserves policy; however we operate in practice with a minimum of £1,000 allocated to reserves.

At the time of signing these accounts the charity has been impacted by the global Covid-19 virus. The trustees have reassessed the charity's ability to continue for at least 12 months from the date that the accounts are approved and conclude that no material uncertainties exist that cast significant doubt on the charity's ability to meet its liabilities as they fall due.
