Achievements and performance Summary of the main achievements of the charity The financial year 2019-2020 again saw an increase in the trust's during the year activities, mainly funded by grants obtained from funding bodies and from Cardiff University for our programme of excavations. Our main achievements were 1. The continuing partnership with the Nene Park Trust in the 'Walking in Time' project funded through the Nenescape Landscape partnership scheme by the National Heritage Lottery fund. The trust's major contribution to this were the work of Dr SG Upex of the NVAT's Research committee, including Continuing work on the future production of a volume recording the historic fieldwork on the Roman town of Durobrivae and its environs The production of a 'Heritage Audit' of the archaeological features within the Nene Park as a guide for that organisation's future safeguarding of its estate and its historic sites. The production of the text and illustrations of a book '*Romans*' in the Nene Valley' which is intended as a guide to the local area for the general public 2. A programme of archaeological excavation within the Roman town of Durobrivae during July 2019 involving a team of undergraduate students from Cardiff university. This work was then written up and shared on the NVAT's website. The information was also shared with the local community through a number of 'open days' on site and an evening lecture. 3. The **production of a short film** about the excavations was funded and will be used by the trust for educational purposes. 4. A feasibility study was funded by the NVAT and produced by Dr J Hall, examining the evidence from a number of historic excavations in the area around Peterborough cathedral. The study will enable the NVAT to better understand the amount and nature of the work required to bring this important work to publication in the form of a 'Town volume', adding to knowledge about the early history of Peterborough Abbey and the medieval town. 5. The trust continued to update and record all important developments relating to local archaeology on its Website.

6. Although our **conference** that was due to be held in March 2020 was cancelled due to the Covid-19 situation, we now have a database of supporters with whom we can communicate regularly about matters of interest. We will be planning to hold another conference in 2021 if the situation allows.
