### **Section C**

### **Objectives and activities**

Summary of the objects of the charity set out in its governing document

To advance the Christian religion, in particular in the UK, particularly by means of the medium of music and song and through the assisting of Christian musicians engaged in charitable activities promoting the said objects.

The trustees have had regard to the Charity Commission's guidance on public benefit.

Through salaries and grants, the Trust supports Christian workers who visit schools, churches and community groups to provide assemblies, lessons, workshops and performances, running both one-off and ongoing art-based projects. Our workers also run a series of events throughout the year to which school groups and others are invited. Through this work, the Trust supports schools, churches, and community groups in exploring questions of faith, and helping to build understanding and community cohesion. The work in schools directly assists schools in meeting the requirements of the national curriculum, both to provide an act of collective worship and to involve members of the local faith communities in their RE provision. The Trust provides access to the arts regardless of the ability of organisations or participants to pay a fee.

Our workers visit wherever they are invited regardless of social, economic or ethnic background, or the ability to pay, and our events are inclusive of those of all faiths and none. We make every effort to run events which are accessible to all, respecting individual needs.

In addition to supporting our own staff and associates, the Trust makes occasional, small, one-off grants to individuals and organisations engaged in activities working towards our aims, based in the UK. The Trust has a written policy on grant making that is sent to all applicants.

We work regularly with other organisations, churches and individuals to meet our aims in a variety of contexts. We have a significant number of volunteers who support us and enable events to take place.

### Achievements and performance

Summary of the main achievements of the charity during the year

In 2019/2020 the Trust has employed five keyworkers: a part-time singer/songwriter, a part-time storyteller, and one full- and two part-time keyworkers. A new part-time keyworker joined us in September 2019 with the aim of continuing the work previously done by the Spen Valley Faith in Schools Trust. Our full-time keyworker left the Trust in December 2019. The team make regular visits to around 60 schools in the Bradford and Spen Valley areas of West Yorkshire, and occasional visits to schools in other parts of the country. Their work is supported by a dedicated part-time administrator.

The **assemblies**, **lessons** and **workshops** provided throughout the school term support schools in meeting the requirements of the National Curriculum, build understanding of the Christian faith, contribute to social cohesion, and allow students to experience the creative arts. Such enrichment of the school curriculum improves pupil enjoyment of school and can have a direct impact on attainment. The Trust's policy of making these available regardless of the ability to pay is of importance as schools face increasing budgetary pressures.

In addition to this work the team have been involved in the following ongoing and one-off projects during the year:

**Re:wind and Fast Forward**, a programme linked to the RE curriculum and transition, is well established in Shipley and the Spen Valley. These free sessions are attended by Years 5 and 6. They increase understanding of major Christian festivals and assist with the transition to secondary school.

**The Bible Times Exhibition** plays a regular part in the life of both schools and churches as it makes annual visits across the Bradford. This helps schools to build relationships with places of worship. The exhibition itself includes both Jewish and Christian exhibits, building understanding between faiths. Bibles in different languages encourage inclusivity.

**Refugee Week 2019** involvement included a Refugee Voices drama project at a local school, contributions to a local art exhibition, and an Open Mic night in collaboration with Bradford Refugee Forum. Through its activities, the Trust uses the arts to engage, communicate and inform about issues surrounding refugees and asylum seekers.

**BIASAN** is a weekly support group for refugees and asylum seekers in Bradford. Our worker provides activities for the children, including craft and games, while their parents access the support provided.

**Holiday Club** was an original programme called 'Under Construction'. We were able to provide the programme free of charge, providing holiday activities that were open to all. 75 children attended during the week. For the first time we provided a sensory room for those children who may find such a club overwhelming, including children with autism and other additional needs.

**The Big Light Party** provided an alternative to traditional Halloween activities. As with the holiday club, the event was provided free and was open to all. The theme was superheroes, and how we all have the power to make the world better. We also provided a sensory room following the success at Holiday Club

The Rock Solid youth group project has continued in Wilsden and

continued at Northcliffe, Shipley until the departure of our full-time worker.

**Prayer Spaces** are a way of engaging school-aged children with prayer in a creative and fun way. As the activities don't conform to the 'normal' patterns of Christian prayer, they cross cultural and religious boundaries. This year they have been held at schools in both Bradford and the Spen Valley

**Open the Book** is a national project through which small teams of storytellers take Bible stories into school assemblies, bringing them to life with props and costumes. The Trust has been responsible for the coordination of the six local storytelling teams, visiting eight schools.

**Church youth work** continued at Shipley Baptist Church until the departure of our worker in December. This included a weekly Sunday night youth group, as well as contributions to Sunday mornings. During the year links were formed with other local church youth groups for larger gatherings.

**Cake Club**, run in collaboration with St Cuthbert's Church, aims to provide a space for children to have fun, and to build confidence and community. The weekly after-school club provides a range of activities, including craft and Lego building.

**ZephFamily** was launched as part of our birthday celebrations in February. This is intended to be the first of a regular series of worship events developing and demonstrating good practice of inclusive, all-age worship.

**Zeph@10am** was launched at the start of lockdown in March. It was a daily online gathering, via Facebook, that provided a time of reflection, prayer and community during the first months of the pandemic.

The Covid-19 pandemic started to impact on our work during the final month of our reporting year. In these initial stages of the pandemic we were unable to visit schools, who were restricting visitors, and we had to cancel our Re:wind to Easter event, as it fell after the start of the first national lockdown. All face-to-face activity was paused during the final few weeks of the year covered by this report, in line with government lockdown restrictions.

Grant making activity is a minor part of our work. During 2019-20 three grants were made: Immanuel College  $(\mathfrak{L}50)$  for an annual prize for Christian music. Inspiration Steelband  $(\mathfrak{L}250)$  towards the cost of new pans. Live@Costa  $(\mathfrak{L}100)$  to assist in financing future acts.

The charity's principle source of funds are donations (both regular and one-off) from individual supporters, and the resulting Gift Aid, and from churches and schools who support our aims. This is augmented by small grants and small fundraising activities and events. The employment of our full-time keyworker was enabled by significant 'buy-in' funding from local churches paying for specific services from the Trust. A small proportion of our other work is paid, but not dependent upon payment for its delivery.

All fundraising activity is managed within the Trust, with no part being contracted out to a third party. The majority of fundraising communications are made through our termly newsletter or social media. Both of these are 'opt-in'. We do not send unsolicited mail or carry out telephone fundraising. Our mailing lists and contact details of supporters are never sold or divulged to third parties.

The appointment of an additional worker in September 2019 gave rise to a potential conflict of interest. The Trustees confirmed that all appropriate steps had been taken to ensure transparency in this appointment given that the appointee was related by marriage to the Director. Trustees had been fully apprised of this situation, had exercised due diligence and had conducted the interview according to our normal standards.
