Para 1.20	<p>The number of available facilities for cricket in the locality has reduced over recent years. Teversal remains one of only a handful of clubs in the district of Ashfield. The majority of members are drawn from the immediate locality which has some of the most deprived super output areas in the county, the region, and indeed the country. 41 players registered batting statistics in 2019.</p> <p>We had 4 teams in 2019 who played a total of 50 games for Teversal CC.</p> <p>We had 1 softball youth team with approximately 12 youngsters playing on a rota.</p> <p>The majority of work on the ground is undertaken on a voluntary basis by club members, as are the provision of teas and the running of the refreshment stall.</p> <p>We have worked with the local Visitors Centre in order to use their facilities for teas at Saturday matches.</p> <p>We have undertaken the usual servicing of machinery and purchase of seed, loam, and fuel, as listed in our balance accounts for that year.</p> <p>Our AGM was held on 7th February 2019 and 10 Trustees Meetings were held in the year.</p>
