#### Chairman's Report – 2019/2020

Twelve months on from last year's AGM, we are all living in a World that none of us could have imagined. We have all had to adapt to new ways of conducting everything we do, to keep ourselves and everyone we may come into contact with as safe as possible. This has caused anguish, confusion and frustration in not being able to do those things that we take for granted, such as meeting family and friends, and not being able to give our loved ones the contact we humans crave for our own wellbeing.

All of us at the North West Kent Volunteer Centre have also adapted to the conditions surrounding us. We have ensured that our paid staff are socially distanced from each other, and we have kept visits to the office to an absolute minimum.

Our befrienders carry on doing sterling work keeping in touch with the people that they befriend. This help for some of our community's most vulnerable people has been more crucial than ever this year. It would be wonderful if we could keep having face to face visits, but for the safety of all, our preferred contact is now by telephone. If isolation is a big concern, which it most certainly can be in some cases, the befriender can be included as part of the "bubble" of people that the individual chooses to have. The safety of our befrienders and the people they befriend is always at the forefront of any decisions regarding contact.

Our drivers have been keeping drives down to a minimum, which has been easier to maintain due to the amount of G.P and Hospital appointments being cancelled. Some of our drivers are over 70, so we have asked them to shield during this time too. The use of antibacterial wipes, disposable gloves and the wearing of masks is now an essential part of daily life for all our drivers, and we ask that the people we drive wear masks too, when they travel unaccompanied and sit in the rear passenger seat, as far away from the driver as possible.

All of our in-person Group Meetings, Trustee Meetings included, have ceased and we have been having Zoom meetings instead so that we keep everyone as safe as possible.

I am extremely proud of every single volunteer within NWKVC who have continued to show care, support and empathy to others during this increasingly difficult period that we find ourselves in.

We are grateful to the Gravesham Covid-19 Project, Kent Community Foundation and Stronger Kent Communities to have been in receipt of emergency funding to assist with loss of funding from elsewhere during this time. I would also like to thank Kent County Council and Sevenoaks Council for their continued financial support.

I cannot speak highly enough of every member of the office staff, who have tirelessly continued to work to the best of their abilities, and in every case given more than I would dare to ask of them. Nicky Smith runs this charity with so much skill and devotion that she makes my life as a chairman a very straight forward one. The team of Sam Fonseka, Jill Burns, Vicky Youseman-Sancto, Jayne Harrison and Sam Clarke have my utmost respect and thanks, and they carry out their duties in a thoughtful, caring and empathetic way. I am more than grateful for how you have worked and conducted yourselves throughout such a trying time, and I know Nicky feels the same way I do. We work as a team, and that teamwork has shone through this year. I will never forget what you have done for this charity.

I have been the Chairperson of the Board of Trustees for over three and a half years now, but during this period of lockdown, the demands on my time of family, friends and neighbours has brought me to the decision to stand down as soon as a new Chairperson is in place. Whereas there may be some things in my private life only I can do for others, the position of Chairperson is something that can be done by someone else other than me. If the Board allows, I would like to be Vice-Chair to assist in the handover of responsibilities, and therefore continue to be a Board member for this charity, which I believe in whole-heartedly.

# Centre Manager Report Annual Report 2019/2020

North West Kent's financial year 2019/2020 started with some stability, excitement, and another year of services as we had known for many years and ended with something that no one had expected to have

happen. Let us start with the positives, our befriending services were growing, and our groups were being attended by increased numbers. Victoria, Jill, and Sam were all working to achieve our objectives and goals by ensuring that all our clients and volunteers were supported. It really highlighted to us all in the office that people were feeling lonely and isolated, communities did not have the same feel and that the spirit had been lost. We saw an increase in referrals and people being directed to our services from multiple agencies.

Our transport service continued to thrive, seeing hospital appointments being attended and even clients having their hair cut or their eyes tested. Nothing was too much trouble for our volunteers, they would go over and above what was asked of them to make sure their clients were safe and were able to attend appointments with confidence. We had some staff changes and lost our Transport coordinator Bev, but we were joined by Sam who took to the role like a duck to water.

Our gardening service saw a rise in the numbers of people who have wanted their garden completed, and even our blitz team with their garden S.O.S hats on, have made some remarkable changes to people's lives. A wonderful quote that was used by a client following a blitz of their garden was 'Alan Titchmarsh couldn't have done a better job'!! This shows the absolute joy that this has bought to many people's gardens. Jayne and her team of volunteers have shown real dedication throughout some typical English weather to make sure the job was done to the best of their ability.

Then out of nowhere (or so it feels), COVID-19 hit. Following government advice and guidelines our services were put into question of our sustainability throughout lockdown. With the team of staff, we looked closely at what would need to close. Groups were closed with government advice and people over 70 were told to 'stay indoors'. Where did that leave us? Our service users and some volunteers are over 70, and many in the 'vulnerable group' that were required to shield. It was agreed that all the staff would still come into the office to work, we all wanted to be here for those clients (and volunteers by this point) who may struggle with lockdown. We kept our same hours and worked to ensure that those volunteers who wanted to move over to telephone befriending were able to, for those who could not, we made phone calls to any clients who would not be receiving some contact from a volunteer. Some of our transport volunteers were happy to collect shopping for their regular drives and one in particular was happy to still take a client to her dialysis appointments as both the driver and client had no outside contact but both felt it was safest for all involved.

When the word on the street was that lockdown would begin to be lifted, risk assessments, action plans, Covid 19 policy, staff and social distancing and PPE was all introduced to enable our services to resume. Throughout the next 6 months and beyond, we have continued to work to support those in the community. We have been proud to work in partnership with Gravesham Borough Council on their Covid 19 support which has been amazing, seeing the large numbers of volunteers coming through to help those most in need.

If we could find any positivity to come out of Covid, it would be the return of the community spirit, the making sure neighbors are ok, checking on those who would perhaps be a little more independent and clapping along with others in their streets who are always in a rush to and from their daily lives and making new friends.

Sadly for some charities Covid has meant that they have had to close, we are fortunate to have received some funding through our Covid response but with the funding streams being very competitive and difficult we are hoping that we can continue to serve our local communities for many years to come. Our services may need to look a little different in the following year or even years to come but the main objective will be that with the help of our wonderful volunteers our community will benefit from their work and time that kindly give.

I am personally grateful to all the staff, volunteers and our funders for all their support and for making my job just that little bit easier through something that will go down in history and be remembered for ever.
