#### Resignation

#### **Hortus Road**

We are seeking to rent the building. Attempts to rent the building have been unsuccessful.

#### **New Building**

We firmly believe we are strategically placed in this multi-cultural location to assist with spreading the gospel of the Kingdom of God. However, with the closure of churches instituted by the Government's lockdowns, we were unable to fulfil many of the our goals.

#### Challenges

Rough sleepers, as well as young people, who are involved in illegal drug practices, and drinking of alcohol in front of the building at nights are still proving to be extremely challenging. We are constantly cleaning in front of the building from the litter left by these groups. Referrals have been made to the Street link who have provided some support for rough sleepers, however, the problem remains ongoing.

#### **Church Closed**

The government instituted lock down resulted in the closure of our church on three occasions: 22/3/2020 - 31/7/2020Church Reopened on 2/8/2020Church closed 2/10/2020Church reopened 15/11/2020Closed 21/12/20 - January 2021

#### **Departments**

Because of the Pandemic, the departments have not been active.

The Ladies ministry led by Sis Brenda, Sis. Marilyn and Sister Mary hosted a conference on Saturday 27th June on Zoom. We thank God for Minister Denise O'Neal who ministered powerfully to the 76 ladies from different countries who tuned in to this conference.

#### Prayer and Bible study

We strongly believe in the power of prayer. Prayer will always be an essential part of this ministry. Prayer sessions were held on Zoom every Tuesday and Thursday from 12md and

occasionally on Fridays evenings. We thank all who have been praying for this ministry, especially individuals who have joined us from other countries for these prayer sessions.

We thank God for the opportunity to study His word on Zoom. We were able to explore a variety of topics, by speakers from our church and abroad. Bible study sessions continue every Wednesday evening from 8pm.

We are truly grateful to Sis. Marilyn who co-ordinated the worship team and all those who assisted in leading worship; Sis. Amryl, Dawn Kimberly, and Liliane. Since March 2020 congregational singing in church has been forbidden. Most of our worship sessions have been through music on YouTube. We are grateful for Sis Mary and family who continue to minister in song from time to time.

We are thankful for the support of musicians, Marquis and Tyson.

#### **Technical support**

We would like to thank the Media Team who has been working profusely over the past year, ensuring the church can continue worshipping and staying connected remotely.

Due to the pandemic all our weekly services have been streaming via our website and via Zoom platform.

The team is responsible for the church publications, sound system, social media platforms; Facebook, Instagram, twitter, website, YouTube. We would like to encourage individuals to like, share and subscribe to our platforms.
