During the year Halima Hussain (Chair) was paid a Salary of £14,403 and reimbursed expenses of £600. This was when Halima Hussain acted in the capacity of Programmes Manager, and the payment was not linked to her position of Trustee.

During the year Tamsila Tauqir (Trustee) was paid reimbursed expenses of £290.

- 4) To teach the spirit, culture, philosophy, ethics and fundamentals of Islam, with a view to improving the moral, intellectual and social condition of Muslims in their community;
- 5) To expand the knowledge of Islam through discussions and Islamic literature by means of publishing and distributing such literature electronically and physically, and provide an Islamic resource facility for communities at large;
- 6) To engage nationally and internationally with issues of social, economic and political justice, to promote the welfare of all living beings.

During the period 1 April 2019 to 31 March 2020, Inclusive Mosque Initiative (IMI) have continued to provide safe and inclusive places of worship and spiritual practice, centring and uplifting the voices and experiences of marginalised people within our communities. To this end, we have run a range of spiritual events, social justice programmes, consultations and promoted our work with various media outlets and journalists that we trust.

IMI has delivered free and regular Jummah (Friday) prayers, Ramadan programmes including Iftars and Taraweh, as well as Muharram reflections and Eid events. We have continued our 'Inclusive Halaqa' event that brings together inclusive theology and spiritual practice. IMI has continued to build capacity, including the recruiting and training of imams to deliver religious services, conduct Islamic (often same sex) marriages and deliver blessings. This recruitment and training have meant additional revenue for the organisation and supported the leadership of marginalised Muslims.

The Programmes Manager position, funded by Joseph Rowntree Charitable Trust (JRCT), has enabled us to deliver much higher quality work and allow our events to reach a much wider audience.

#### Achievements and performance

Summary of the main achievements of the charity during the year

Our standout event of the period was "Queer and Muslim: A critical reading with Amina Wadud." This 2-day critical reading course on Queer-centric readings of the Qur'an and introduced a methodology to help attendees:

- a.) understand how patriarchal interpretations of the text have been used to oppress cis women and LGBT+ communities, and
- b.) how to counter these interpretations by drawing on their own agency and critical thinking skills.

We also held a sold-out panel discussion called 'Feminist Perspectives on Islamic Sacred Text' with renowned academics Amina Wadud, Ziba Mir-Hosseini and Suhraiya Jivraj. This event was held in partnership with the British Library and Maslaha and opened up female-led discussion on works of female Muslim scholars to a new audience.

In the months prior, we held the second of our 'Our Ummah' support groups which provides a space for the families of LGBT+ Muslims to understand ways of supporting their LGBT+ family members.

We ran a total of 9 feminist halaqas, our Qur'an discussion groups which democratise knowledge about the Qur'an. These discussions centre the voices and perspectives of women, genderqueer, nonbinary Muslims as well as Muslims who are marginalised because of race and (dis)ability.

In Ramadan we ran a programme of Iftars (communal breaking of the fast) and evening prayers that culminated in a community Eid celebration. Attendees of the events reflected the breadth of the Inclusive Mosque Community which is made up of those who are usually unable to access regular mosque spaces. We also saw an increase in interfaith families and couples attending our Ramadan events.

We continued to run our fortnightly Friday prayers, paid for by public donations. Our Friday prayers are feminist spaces of worship and reflection where the leadership, perspectives and experiences of women, genderqueer and nonbinary people are centred. We've had fantastic feedback on the Friday prayers including this one from one new attendee:

"Thank you so much for creating such a beautiful space at Jummah today. It was my first time and I was so touched, I couldn't help but cry at the beauty of what you have brought together."

The charity's principal source of funds is the Joseph Rowntree Charitable Trust (JRCT). Income from JRCT accounted for over 80% of the total income received by the Inclusive Mosque Initiative (IMI) from 1 April 2019 to 31 March 2020.  On 19 March 2019, the Trustees of JRCT agreed to offer IMI a grant of £133,728 for a period of 36 months (3 years). This equates to £44,576 per year, and £11,144 per quarter. This is the quarterly amount that IMI has been receiving from JRCT for the period 1 April 2019 to 31 March 2020.  IMI's unrestricted income is driven by donations and by income received from community services, such as marriage officiations. IMI started conducting marriage ceremonies from July 2019, and therefore this is a new stream of income for the organisation.
