Greetings in the wonderful name of our Lord Jesus Christ. GRACE AND PEACE be multiplied to you, in the knowledge of God and of Jesus our LORD. Please read this letter slowly and carefully in every service during 10 days of Prayer and Fasting, so

that everyone clearly understands what God is saving tousthrough the Holy Spirit.

The year 2020 is different from all the other years. We need to be strong as never before, because there are things in the spiritual world that I cannot be able to explain. Except that I encourage everyone to make sure that your relationship with Godis right. We know that some of uswe didn't finish praying for spiritual ears and eyes leading to the genuine fear of God. We need to continue.

The year 2020 the foundation of everything is Love of God in the church, which will create prayer and fellowshipping together, with one another, bringing food and eating together Acts 2:42 and 46. The Bible calls this fellowship "Love Feast" Jude 12.

The foundation of Love of God will create praying, fellowshipping, inviting friends and eating together the food we bring. This will help when the period of spiritual drought in some places comes. I am speaking to the mixed generation, but my message is to the emerging generation who are coming into leadership.

Love and fellowship will cause the church to grow and cause joy in people. Acts 8:8, Acts 13:52. We wont lose people in the time of spiritual dryness when the Love of God is full in the church. Be not afraid when you see ungodly coming to your fellowship. Wherever there is eating it invites even wrong people. When Jesus saw wrong people coming, He warned the disciples. Luke 12 v 1-5. READ.

People do not stay in church because of anointing only and preaching, but because of the love of God in the church. The key is the Love of God. Love never fails. 1 Corinthians 13:13.

Continue in the teaching of FIF, fellowshipping, eating together and in prayers.

As always in the 10 days of prayer and fasting, prayer bands and conventions are very important. Prayer conventions 2nd to 5thJanuary 2020.

Warning to those who are at work. Be alert. Reminding the pregnant women, we don't want you to be sick. Don't fast.

Thank you for praying for me as I pray for you. God bless you and strengthen you.

EXECUTIVE OVERVIEW REPORT (by the Bishops & National Administrator)

Introduction

God spoke to our father, His Servant Apostle Prof. Ezekiel H. Guti in November 2019 concerning the year 2020. This led him to write the "Ten Days of Prayer and Fasting" letter to the Church as preparation to enter the New Year.

The letter clearly states that "The year 2020 is different from all the other years. We need to be strong as never before because there are things in the spiritual world that I cannot be able to explain. Except that I encourage everyone to make sure that your relationship with God is right. We know that some of us didn't finish praying for spiritual ears and eyes leading to the genuine fear of God. We need to continue.....". We therefore began the year on a cautious note, following this prophetic declaration and an unprecedented warning concerning 2020, which had things that our father was not able to explain except for everyone to be strong as never before.

The nation went into TEN DAYS of PRAYER and FASTING as usual, with a difference that our mother, Apostle Dr Eunor Guti came with her team to pray with the Female Pastors and the Male Pastors who joined in at the end. We now appreciate that this could only be by divine appointment, to cover the nation as the pandemic was looming.

Though the church had been prophetically warned and the Pastors' Deeper life Conference held in January 2020, the sudden and devastating break out of COVID-19 had serious negative repercussions on the operations of the entire church. Like the rest of the world, we went into lock down which affected all our public gatherings from March, our places of worship with all services and meetings moving to electronic platforms. The Europe Leaders' Deeper life Conference (29th July – 2nd August 2020) had to be cancelled.

Despite these difficult conditions, God continued to show His faithfulness to His Servant and His people. This was evident through the following: -

- a) a great wave of individual and corporate prayer at every level; an increase in the spirit of prayer as Pastors, leaders and saints meet virtually to pray,
- b) high attendances for online prayers and services with an increase in tithes and offerings.

In July, the Executive then established a National Covid-19 Task Force, as a sub-committee of the Management Board, with a mandate to guide the nation in the interpretation of government guidelines, risk assessment and preparation for return to places of worship. The Task Force

structure was replicated to the provinces, instrumental in ensuring compliance to health and safety, also making it possible for practical concerns like fear to be dealt with appropriately.

Different ministries and groups were able to hold online conferences, conventions, seminars and meetings. Most scheduled calendar events, whether provincial, regional or assembly have been successfully taking place, including National Council meetings. It was not possible to proceed with the Bishop's rotation although some Provinces and Regions managed to host them through virtual platforms.

Missions Project 2020

Probably the most notable achievement of the year was the working of Missions and raising £1m+ in just 2 months of June and July!! This was indeed great grace bestowed upon the nation, being able to partner with the Servant & Apostle of God towards the "Go Yee Therefore" mandate during such challenging times.

International Sunday Services

These came as the pandemic and its challenges was beginning to surface and allowed the nation to keep focussed. We highly appreciate the love from our father the Apostle & Servant of God, for facilitating these special morning and evening services for His children.

Though the morning services have stopped, we have gone back to having virtual local services. This is in preparation for return to places of worship, which will eventually come with continued intensified prayers and the lifting of the third lockdown on 2nd December 2020.

Kingdom Wealth Creation

After a successful Missions Project 2020, we continued working Home Talents, with amazing results throughout the UK and Ireland. We witnessed the demonstration of God's grace as every province surpassed all their expectations. Surely the lives of people will never be the same going forward, as the vision of the school of talents continues to be fulfilled.

Conclusion

The Church in the United Kingdom truly witnessed the unmerited favour of the God of our father, as lives are being preserved despite the nation being ravaged by Covid-19. We highly appreciate the Executive for putting in place the National and Provincial Covid-19 Task Forces which are assisting the nation with interpretation of government guidelines, to ensuring compliance for health safety.

PROVINCIAL SUMMARY REPORTS

GREATER MIDLANDS PROVINCE



Executive Summary

We thank the God of our father, Apostle Dr Ezekiel H Guti who has kept His church through the Covid-19 pandemic and lock down. He favoured us with a good team of Pastors, Elders and Deacons; our Province of 7 regions continued to be stable during these unprecedented times. Programmes & Activities PC & Seminars

Kingdom Wealth Creation

Home Talents continued being worked miraculously as some businesses were not affected by the pandemic. Many have built houses and the majority saving money, surpassing the provincial target of £1m.

Ministries

Regardless of the lockdown, we saw the divine hand of God, with every ministry up and running, holding prayer sessions and retreats, services and seminars. They also participated in their ministerial national conferences. Some notable activities are as follows:-

Child Evangelism

They undoubtedly became the pace setters, with weekly services, two business seminars and a talent show themed "We are Gifted", where all participants were appreciated with a token gift. The children were kept engaged during lockdown, learning new skills up until opening of schools.

Youth

They managed to put their structures in place in accordance with the youth calendar, began monthly provincial events and actively participated during the working of Missions. They have also begun Monday to Friday prayer sessions, morning and evening.

Go Quickly & Tell

They continued to conduct themselves as the backbone of prayer and a force in the working of Home Talents. Virtual High Teas were held, as well as fellowship meetings for Elders and Deacons respectively.

Conclusion

As a way of responding to those that have been affected by Covid-19, alms have been put in place to offer local support. We appreciate the setting up of a Provincial Task Force, to spear head the safe return to churches, working as a subcommittee of the National Task Force.

NORTH LONDON PROVINCE



Overseer's Executive Summary

Home Cell Groups meet midweek; Home Visitation to pray, meet the needs of believers and create opportunity to reach those living alone.

Events

Seminars & Conferences

The year started with extraordinary ten days of prayer and fasting, then moved to virtual conferencing for conferences, seminars and ministerial gatherings after lockdown. Everyone greatly benefited from the various speakers from across the globe who delivered life changing teachings.

Kingdom Wealth Creation

Families are gathering a lot of money through working of Home Talents and the anointing of the season. Regions have created group links that include Buying & Selling, Properties, Farming, Health & Home Care, Stocks & Forex Markets. Experts are giving mentorship and guidance to those who register interest, so they can venture into different projects. Great testimonies are being shared and we believe more businesses shall be birthed in NLP.

Ministries & Testimonies

1. Ministries

Regardless of the lockdown, all ministries demonstrated a hunger for staying connected, maximised efforts to receive online teachings and praying for the work of God. The youth are preaching on social media platforms and did some street witnessing when the lockdown rules were eased. Youna Generation & Child briefly Evangelism faced enormous disruptions when they couldn't go to school until their Pastors and Sunday School Teachers started various activities through zoom video conferencing. Many have grown spiritually, and confidence is soaring. We give glory to God for allowing them to stay focused and finding more joy through the International Children's' Sunday Services.

2. Testimonies

God created incredible opportunities for members during lockdown, including buying of properties, restoration of lost jobs and creation of new business projects. The God of our father Ezekiel is awesome and so faithful, fulfilling His word and its purpose. Many saints were healed from Covid-19 and other illnesses, as shared through some of the testimonies received: -

(a) Testimony 1

A mother of two boys, nurse by profession and a believer at Luton Mega church contracted Covid-9 early this year. It was difficult but I saw the hand of God through prayer support which sustained me even when I could feel my breath going. The God of our Father Ezekiel Guti is alive and faithful, is above every sickness or any mountain. My wonderful family of God were calling, daily checking on me, taking turns to cook and shopping for daily needs. I urge my fellow brethren to trust in this God of Father Ezekiel. Glory be to God!!

(b) Testimony 2

My son lost his company manager job due to the pandemic. After being reminded of his situation on 2ndJune, I was strongly persuaded to give to Missions and continued throughout the project period. My son called to say he has been reinstated on the same conditions, but his counterparts given a choice of junior positions with reduced income. I thank the leaders for encouragement on prayer and partnering with God. These Missions are not ordinary and such favour can only be the doing of the Lord. May He be glorified forever for His faithfulness.

(c) Testimony 3

In August I fell 3 times within my house, could not get up without help and was admitted to hospital after calling for an ambulance after the 3rd fall. Nothing wrong could be found, was overwhelmed with fear, lost all confidence to stand, walk or use my walking stick. I received full support from my church through prayers & visitations until discharge. I was house bound, in a wheelchair and using a taxi to and from church until virtual services started.

After the physiotherapist visit on 19thSeptember and being asked to stand on my stick, I continued doing the same for some days, taking steps forward and back. I said, "Lord thank you for the 5 steps today and a thousand more tomorrow"!! I then managed walk to the toilet, then to the kitchen which I had not seen for some time. I haven't stopped walking since and it is the doing of the God of Ezekiel Guti. I was never without food during lockdown as the brethren took turns to minister.

Conclusion

We thank our father and mother Apostles Dr Ezekiel H Guti and Dr Eunor Guti for prayers and what their God is doing in our Province. We have remained standing despite the challenges caused by the Covid-19 pandemic, fulfilling scripture that says, "For we walk by faith and not by sight" (2 Corinthians 5:7).

We are so thankful to God for His love and kindness that has brought peace in our province and allowing His children to thrive financially through their faithfulness in tithes and offerings. We are confident that we will have a wonderful 2021, as we continue to operate under the anointing of the Apostles of Jesus Christ.

South Bank Region were privileged to receive teachings from international speakers, 'Discipleship' by Bishop Rupapa and 'Salvation' by Dr D Simango.

Activities

Missions – We give praise to the God of our father as we saw His hand in the working of Missions in June and July. It was a remarkable performance of "firsts" over the whole nation, from South Bank Region, our Pastors C & M Mhlanga then the Province. Even though we were in a pandemic, people gave whole heartedly to their God and South Bank Region even superseded their target. Special thanks go to the Pastoral Board, who prayed with us at every level and arranged international speakers to charge us with inspiring teachings.

Ministries

Child Evangelism & Young Generation teachers continued facilitating children's church as per the vision given to the Servant and Apostle E H Guti. Virtual local services graduated to joining the international services through YouTube/Facebook, a channel which the Superintendents had already started using.

Go Quickly & Tell held Big Chinas and High Teas across the province, over and above the female Elders and Deacons seminars with international speakers. They joined in the 2 international Big Tuesdays addressed by our mother apostle Dr Eunor Guti and South Bank have started home makers services, sharing teachings that include families, children, working and running businesses.

Men of Integrity birthed a male Elders and Pastors midnight prayer group from Monday to Thursday in South Bank Region, extended to all the men on Fridays. Willing hearts and a hunger to earnestly fellowship with God are the main motivation. Like other ministries, they were also ministered to by international speakers in their conferences across the province.

Single Women are a ministry of vibrant members who meet regularly to fellowship and pray; they worked Missions in March. Through the Overseer's office, they had a well-attended interactive meeting with Pastor C Zezani, a keep fit event where they received teachings from a professional coach on how to exercise and many more empowering speakers.

Couples Fellowship has solidified over the years as a powerful pillar of soul winning to non FIFM members. Beyond local, regional and provincial events, they participated at the most recent National Couples Conference themed "Lets Chat Love" held in August.

General Remarks & 2021 Projections

We look forward to having every ministry exceling in their vision and projects, including Families Builder Ministry (FAMB) who aim to go beyond family fun days but to organise fellowship activities at local assemblies that will nurture family cohesion and growth.

Some of our projections are: -

- Embarking on reaching out to the indigenous people and other nationalities.
- Soul winning by all age groups
- Engaging all ministries and groups in prayer retreats
- · Maintain our membership strength
- To teach the word as written in the bible scriptures with the additional support from the books of the Servant and Apostle of God.

MINISTERIAL AND DEPARTMENTAL REPORTS

CHILD EVANGELISM MINISTRY



Introduction

The head is National Director Pastor Phyllis Burke, assisted by Pastor Kay Chibwana. Elder Shepherd Shumirai is the current Chairman, working with vibrant pastors, teachers and friends of the Ministry.

Because of the global pandemic, 2020 has been a challenging year all round, yet managed to switch to online activities and children's church', with children and their teachers always glued to their gadgets. We saw the hand of God as interactive meetings and sharing of the most wonderful experiences were facilitated through these gadgets. Our extensive report intends to allow the readers to capture and share with us, the progress we made and the excitement about the growth of our ministry.

Our presentation is of a successful and fruitful engaging year, through the support of parents, guardians, teachers and leaders. It starts with the national overview, then the more detailed provincial events and plans.

National Overview

2020 has been tremendous by way of commitment from teachers and parents despite being restricted from meeting physically because of lockdown. The board did not stop hosting a national seminar in May, with the International Director Pastor Dope as speaker, as well as a successful meeting in August to plan children's learning activities. It is exciting to note that Provinces and regions are also planning Christmas parties for the children.

The teachers and parent sessions were held in May during a week of prayer and fasting. They were well attended and filled all the available spaces on the platform. The high-powered sessions majored on training up a child and how to conduct children's church effectively, attended by children from as far as Dubai, South Africa, Mozambique and Zimbabwe. The teachings invited positive comments from parents and the critical areas covered include: -

1. Training up a child in the way they should go (*Proverbs 22 vs 6*).

For behavioural change and to prepare them for a responsible future

Ushering them into a guided system, using child centred approaches

- 2. How to communicate effectively with children, the different methods and their values.
- 3. How to avoid the common mistakes we make when communicating with children.
- 4. The importance of games and music as part of lesson development.
- 5. The importance of applying correct teacher/child ratios and rota systems for teachers.
- 6. Identifying child needs and communicating effectively with parents.

These teachings emphasise that "ANYTHING FOR THE CHILDREN WITHOUT THE CHILDREN IS NOT FOR THE CHILDREN". As such, every province, region and assembly have launched their weekly children's church and establishment of a Kingdom Music & Dance (KMD) structure, with Elder Obert Mazivisa as national leader. Their future plans include learning from the Zimbabwe KMD experience, to encourage children to compose songs, enter song writing competitions and running of workshops.

Provincial Activities

Notably, every province has a provincial board in place to guide the ministry, but teacher availability is varied for different reasons, e.g. work commitments. Most regions are holding as many services as possible for the respective groups, inviting different speakers and encouraging the children to watch the online international services from when they started.

Over and above bible study classes, memory verses and watching video clips, children are benefiting from various interactive activities that keep them engaged. CE classes cover wide ranging topics that have brought tremendous growth in the knowledge of the word and have equipped the children to lead services extremely well.

Some activity highlights that the children are enjoying including cooking & baking, dancing & drama, exercise routines, indoor games, bible quizzes and playing musical instruments. Greater Midlands showcased a talent show, with every participant being appreciated with a reward by a donor parent and two Business Seminars were addressed by young businesspersons from Youth Ministry. South East England encourage children to

share their future professional aspirations and call them by those titles to keep them motivated e.g. Evangelist, Doctor, Biologist, Prime Minister to name but a few. They also had a session on child inventors, and some have already started working on different projects.

Kingdom Music & Dance (KMD) is surely catching on and every province has positively responded to the call of electing a leader. North London managed to hold a KMD launch and invited Pastor Madhoyo. The nation held their first meeting on 6th December and agreed on a plan of action, which encourages coordination (learning the same song across the nation), without restricting the children (options to do a lot of dances). Only meaningful songs with the word of God will be used, children encouraged to compose songs and enter song writing competitions.

Closing Remarks

The diligence of the teachers who faithfully availed themselves is producing great work at every level, with the support of parents and guardians as well. We saw successful and fruitful engagement with every activity, with a lot of the children learning new skills during the lockdown.

We thank God for all the local speakers and our Pastorate who tirelessly support, guide and pray for us

We thank God for His faithfulness, sufficient grace upon our ministry and look forward to continuing to doing greater exploits in 2021.



GIRLS MINISTRY



We are so thankful to God for the substantial growth we experienced in 2020. Our National Girls Director, the Pastorate, Advisors and girls' leadership worked tirelessly to plan programmes and ensure the functioning of ministry. 1. Introduction

The following are some of the highlights from the sessions that leaned heavily on testimonial teaching: -

b) Gracious Ms Single (Rubies)

Previously married, widowed or divorced and are meeting monthly specifically to pray.

Married Women - 2 Groups

Gracious Young Wives (Sapphires)

Women who have been in marriage for 0-20 years meet weekly.

b) <u>Gracious Gems</u> Women who have been married for 21+ years are meeting alternate Thursdays.

Future Plans

We plan to groom board members and to continue praying for the registration of the ministry as a charity organisation. We prayerfully look forward to the official launch with Husbands Agape.

School Centres & Teaching Staff

Our total student enrolment of 132 is spread out in 15 centres, which cover the whole nation and happy to report the extension to Republic of Ireland, mainland Europe (Switzerland, Germany, France). The teaching staff is made up of a team of 20 Pastors, 17 Elders and 4 Deacons.

Note: Currently we have two online classes that are running concurrently, graduating class and beginners' class.

Note: School fees has not been revised since the inception of UKMFCC for easy accessibility and to accommodate all, without costs being a hinderance.

Overall Summary Report

1. Aug 2019 - October 2020

We witnessed a dynamic shift which embraces diversity and encourages the youth to participate, hence the rise in the number of youth registrations in the year. The online classes are one of the achievements that brought us together with mainland Europe (including the Schengen Region), Belfast & Republic of Ireland. We recorder the highest attendance ever, with students receiving teachings in the comfort of their homes without distance as a barrier.

2. Dr Mbisa's Visit

We were privileged to host the International Coordinator for AMFCC Part-time Bible School programme in April 2020; both teachers and students gained tremendously from his profound teachings and wisdom. His passion for the School was witnessed across the nation.

3. Challenges

Impact of Covid-19

The graduation class of 2020 meant to have taken place during the 14th Europe Deeper Life was affected.

Face-to-face interaction with students has been compromised.

However, on a positive note, Schengen Region has been incorporated via online classes. Students have also been allowed flexibility to learn from wherever they are, regardless of differences in working patterns.

4. Director's Desk

We thank the God of our father Apostle Dr Ezekiel H Guti for yet another successful academic year. We had the Training of Teachers in April and a training session for all Home Cell Group and Sunday Adult

Bible Study teachers in our nations. This was well received by all the provinces, regions and assemblies; participants have demanded more of such trainings to equip and ground the teachers with church doctrine and the Word of God. The School is considering having such trainings every year.

The School continues to upgrade itself, to remain relevant to the emerging generation as it discharges its training mandate to leaders and believers for ministry and service.

We thank God for the School Councillors who continue to volunteer and dedicate their time to the successful running of the School. We thank our father the President and Founder of the college, for his prayers as the bible school extends its presence into mainland Europe.

Progress Update

There has not been any construction works on the site in 2020 except to repair some defects on a few items that had been identified through snagging, on completion of Phase 2A of the project.

During the year several of the defect's liability periods for the contractors' work ended and the money (retention sums) that we were holding back to cover any defects had to be paid to the contractors.

Use of the Facility

Use of the National Centre is being managed by the Ezekiel Guti Conference Centre Management Board, which is separate from the Building Committee.

It was a joy to have our very own mother Apostle Eunor Guti in the National Centre over the 10 days prayer and fasting with the female pastors.

During the early part of the year, the Secondary Hall was being used regularly by the local Forward in Faith church. Unfortunately, the building has not been in use since March, when physical gatherings of churches were stopped due to the Covid-19 pandemic.

Look Ahead to Project Delivery Strategy

As has been reported in previous years, we divided the project into a few phases as follows:

Phase 1 - Construction of Main Auditorium

Demolition of existing structure
Foundation Construction for main auditorium
Drainage construction
Steelwork, Wall cladding and roofing
Floor Slab Construction

Phase 2 - Partitioning & Services Fitting

Internal brickwork and room partitioning Install Lighting, Heating & Ventilation Install plumbing Install Audio & Visual Equipment Complete other internal fittings & fixtures

Phase 3 - Landscaping

Complete tarmac in parking areas
Paint parking bays
External site finishing and other landscaping

So far we have completed Phase 1 and are about 60% through Phase 2. This This was most of the work and it enabled us to obtain the building control approval from Sandwell Council, to use parts of the building from August 2019. As and when funding becomes available, we aim to complete the rest of the project as soon as possible.

Closing Remarks

It is our hope that the Covid-19 restrictions will be lifted soon and that the church will have the funds to enable us to complete the rest of this wonderful project.

We request that you continue to pray for us to work on this project with wisdom and guidance that comes from God.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements
