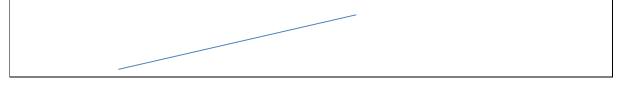

INCOMING RESOURCES

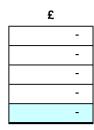
