Minutes

Apologies None

The AGM started at 8pm. Sarah George opened the meeting and welcomed attendees. This AGM (convened to fulfil Charity Commission obligations) was attended only by the Executive Committee and DC Anthony Morris.

Minutes from the last AGM (18th June 2019) were accepted as accurate. Anthony advised removal of 'AOB' from future AGM agendas; AOB should be dealt with separately after the AGM is closed.

Section Reports

Tim Greaves delivered the GSL Report, Sue Springett delivered the Beavers Report, Rachel Vallance delivered the Cubs Report & Linda Philips delivered the Scouts Report. All were agreed unanimously and are attached. Sarah thanked all Leaders, making special note Tim's first full year as GSL, of Sue's ongoing success running Beavers with her established team, of what good shape Rachel's Cubs team is in and of the wonderful Scout Zoom meetings run by Linda and her team. Special thanks to Matthew Jordan who is leaving the Scouts team.

Treasurer's Report & Adoption of Accounts

Stephanie Sparkes gave her report (attached) noting that the 2019-2020 accounts, having been audited and agreed by Duncan Bowler (35th Oxford), will soon be submitted to the Charity Commission. The accounts were adopted. Duncan has kindly agreed to audit next year's accounts and was duly appointed. Given the imminent and significant rise in capitation fees, Steph recommended ring-fencing funds for capitation in future. Sarah George thanked Steph for her diligence.

Executive Committee Election

Chair: Sarah, Steph and James Brown stepped down and the meeting was taken over by Tim. Tim nominated Sarah and Mark Rowe as Co-Chairs, seconded by Sue Springett & Anthony.

Treasurer: Steph happy continue; nominated by Sarah, seconded by Linda and Rachel.

Secretary: James happy to continue; nominated by Sarah, seconded by Steph and Mark.

Executive Members: Section Leaders, Becca Lynch and Emma Millet-Clay all willing to continue. All nominations were accepted without objection. It was noted that we do not have a Parish Rep but have enquired with the Vicar and Curate of St Nicholas Church.

Housekeeping – Group Archive

To comply with GDPR the group archive will be checked when we return to indoor meetings. Hard copies of minutes will be added to the group archive; Anthony noted that banks now commonly ask to see minutes before agreeing to make changes to signatories.

Anthony thanked Leaders, their teams and the Executive Committee for all that they do, noting with gratitude that most Spires District groups are doing well despite difficult circumstances. Anthony stressed that whilst it is great to see Scouting activities continue, the health and well-being of volunteers and their families must be prioritised above Scouting, echoing the message from Tim Kidd/Scouts HQ. Anthony noted that the impending rise in capitation is partly due to a rise in the County charge, emphasising that this is crucial to retain valuable County employees. Finally, Anthony was delighted to announce 5 Year Service certificates for Steph and Sarah and the Wood Badge for Phil Earp, which he will deliver to Tim for distribution.

Sarah thanked Anthony and all at Spires District, with particular appreciation of District support approving our Return-to-Scouting risk assessments.

The next AGM will be held on Tuesday 22nd June 2022. The meeting closed at 9.10pm.

43rd Oxford Scout Group Annual General Meeting 2020 GSL Report



The 2019/20 year has been somewhat unusual at 43rd Oxford Scout Group, both for the things that happened and the things that did not happen.

A chapter ended at 43rd with the closure of our SAS section in 2019, after many years of service to the group. I would like to thank all involved with the SAS who have volunteered so much of their time in the service of Scouting, both at 43rd and across the district.

Our remaining three sections met actively through 2019 and the early months of 2020, young people in all sections being supported by a full team of both adult and young leaders. A huge thank you to our fantastic team of volunteers in the sections and on exec who do so much to make sure that our young people have an exciting, fulfilling, and safe time in Scouting.

As changes in our volunteer team, we congratulated Stacey McGowen on her appointment as Cubs Assistant Section Leader, and thanked Mark Gill who stepped down from his Cubs leader position in Autumn 2020. We welcomed Matt Kennedy (from 10th Oxford) and Alfie Baker, who have joined our Cubs leader team at 43rd, and welcomed Becca Lynch onto exec as parent rep from Beavers.

Unfortunately our planned Group Camp in spring 2020 was cancelled as a result of COVID-19 lockdown, and the ongoing national crisis affected the group as a whole with the move to online instead of in-person scouting. We were fortunate to receive a substantial grant from Oxford City Council which supported the group financially whilst income from subs was significantly reduced.

Whilst it is hard to foresee what the coming year will bring, we can be proud as a group that we have got through many very difficult months to date with all our sections active and thriving, and look forward with optimism to easier times ahead and hope for a return to 'normal scouting' again soon.

43rd Oxford Scout Group Annual General Meeting 2020 Beaver Section Report



When I was asked to do a report I thought "...well what have we done since last AGM?" It seems so long ago since had 'normal' Beavers, so I asked the Beavers for some memories and went on OSM to look at programme headings and realised we have had a fantastic year!

"'A' really enjoyed the fireworks evening last Nov where you had a campfire and jacket potatoes. We also thought the fundraising/spending their tokens activity was inspired and on Zoom he most liked the star (and particularly marshmallow!) activity."

The fundraising night mentioned above was a very unusual night. Over half-term, the Beavers did "Jobs" for payment, Then, at our meeting, the Beavers swapped money for a block of tickets (max 10) and went round and spending their tickets on crafts, activities and snacks/goods at various stalls. They raised £120 for ShelterBox (whose team was supposed to visit us before lockdown struck, so that's an activity still to do in future).

Other guest speakers included Nick, who taught us sign language; this year he put the Beavers in groups and we pretended to be in restaurant and order our favourite food using sign language. Gareth from RNLI did a brilliant evening on water safety; he was fairly new to the job and engaged with Beavers at just the right level, including getting them to dress up in all the gear. One of our mums (who is a dance instructor) led an evening on Dance & Fitness, which the Beavers enjoyed.

Last Autumn we did our photography badge in very different way to normal. One of the dads brought in his classic VW Beetle and the Beavers took pictures of it from various angles, including the engine "in the boot"!

I think my most memorable /favourite night was just before lockdown. We had Spy Night set up by Tigger, where Beavers sent in photos in advance of them in disguise and gave themselves a spy name. On the night, they worked in lodges they tried to guess who all the photos were. We had forensic evidence shoe prints and a laser framework to tackle before entering HQ (ropes criss-crossing), invisible writing and spy codes.

In September '19 we had a colony sleepover with 16 Beavers and help from Tim, several parents and my Beaver Leader daughter-in-law. It was straight after a District Sports Day at 28th Oxford HQ in Littlemore. We covered several badge parts including camp craft, cooking and international. Some plans had to change on Sunday due to very wet weather but it was a brilliant weekend with some very well-behaved Beavers who slept well and "gelled" well as a group.

In November 19 we took 13 beavers and some parents to Horley Scout Campsite for the County Winter Wonderland, It was first event for the newly formed events team and the Beavers had a fantastic time, especially not picking up on the stresses of all leaders (County-wide) who were used to better organised events. Shall we just say It can only get better! It was much too long a day for November and some of activities more suitable for a summer event. The activities were good, if you could find them!

We have had between 21and 28 Beavers on register (lower numbers when first allowed back and some opted to remain on the waiting list until we're back to normal).

We have had 9 Beaver investitures, 2 of which were very weird due to social distancing with only half of the colony present.

We have presented 6 Bronze Awards (and 1 more due this term). One was presented over Zoom with careful planning so it looked like I actually handed to him!

We have awarded over 230 badges since our last AGM and still have nearly 30 more to deliver.

The team remains the same Sue, Nathalie, Neale & James, aka Kanga, Tigger, Christopher Robin and Owl respectively. During our 3 sessions of outdoor face-to-face Tim Greaves also became a valued member of team as Wozzel a lesser known Winnie the Pooh character. We also have 2 fabulous Young Leaders, Will, and Saffy, aka Rabbit and Roo, who we are really grateful for.

Like all scouting sections we are currently not allowed to meet face-to-face. We did run 3 outdoor sessions which, although good, were hard work due to social distancing and darker nights. Still, we did actually manage part of the Outdoor Challenge, some International Badge, some Health & Fitness badge and plenty of team work.

We are currently meeting in 2 bubbles, doing a 35 min Zoom session for each - just long enough for Beavers to keep focussed! We've done games, mug cakes, Constellations & Planets and Remembrance Day (where Beavers collected red, black and green items and made poppy collages with some amazing results).

Despite that... roll on normality! I'd much rather have 24 noisy beavers in the hut than see 10-12 Beavers on Zoom. Thanks Parents for all your support before, during and after lockdown. You are all fantastic. Thanks brilliant team - couldn't do any of this without you.

43rd Oxford Scout Group Annual General Meeting 2020 Cub Section Report



June 2019 feels a lifetime away, so much has changed since then.

At the end of June 2019 ten Cubs attended the annual District boating event and spent a happy half day kayaking and canoeing. In July twenty-one Cubs spent two nights at CubWorld County camp at Berinsfield Lakes. This was busy, crowded, exhausting and altogether wonderful. A highlight was our session on the "Wet n Wild" water obstacle course. Attendance at camp was made possible by parents who helped out, including two who drove out from Oxford each day because there was no space for their tents, former GSLs Rob & Lisa Pocock who brought much needed experience as this was only my second big camp with Cubs, and Petronella, Mike & Jack Spivey who catered for us and took down all our tents on the last morning.

September 2019 to March 2020 we had 33 Cubs and a leadership team of four: myself, Stacey McGowen, Matt Kennedy and Mark Gill. Memorable evenings included learning about how bodies work using sheep organs from the butchers, and an evening of science experiments including making 'elephants' toothpaste' in a paddling pool and a very loud accidental bang involving dry ice and a cola bottle. In November we attended both the Remembrance Day parade in the city centre and our annual church service at St Nicholas Church. In February Matt and I took five Cubs to the District Sixer and Seconder Camp held at the 33rd in Kidlington. On the 13th of March we spent our meeting working on our Communication Badge. We learnt some phrases in Latin from Stacey and made some stinky Roman ink which we used to send messages on thin strips of paper wrapped around pencils like Roman scytale and then it was lockdown and everything stopped.

During lockdown I posted out all owed badges to Cubs and they continued to work on new ones including a couple of Cubs who completed their Silver Awards. I also did one other mail drop of activities for the Cubs.

In late September we resumed face-to-face Cubs with two groups of fifteen Cubs meeting simultaneously outdoors in separate locations. Keeping physical distance between everyone is even harder than I imagined but we quickly learned how to run activities under the new rules. We had six face-to-face meetings before the start of lockdown 2.0. We now have 28 Cubs and our leadership team is myself, Stacey McGowan, Matt Kennedy and Alfie Baker – a first year university student from Cornwall who has nearly finished his wood award. Stacey has taken the lead in running Cubs digitally via Zoom. Our first Zoom Cubs was November 13th and we feel this will work well until it is safe and practical for us to meet face-to-face again.

The Scouts have had another busy year since the last AGM. The Leaders are currently myself, Richard Harwen, Matthew Jordan and Phil Earp (and Graham Drabble often joining us for camps), along with our young leader Tom. Thanks to them for all their hard work. A special thanks to Matthew who has now moved away from Oxfordshire, but is still doing the Zoom meetings with us.

2020 has been an unusual year. With summer camp cancelled plus other camps and face-to-face scouting cancelled during lockdown periods, we have still been lucky enough to get plenty of things in. We went to the New Forest for a New Year hiking camp, along with 28th and 2nd Oxford, where we stayed at Burley Scout hut, and did a day hike, the a day geocaching challenge. Then a couple of weeks later a few of the older Scouts went to District Patrol leaders training camp at Youlbury, where they got to meet and work with Scouts from many other troops. We had the Winter Challenge where lots of Scouts completed the 18 mile walk along the Ridgeway, often as part of their personal challenge badge. And we did a night hike and sleepover to Witney Buttercross hut the weekend before lockdown.

Once lockdown hit we had a couple of weeks break for everyone to get their heads round doing work, school, etc online, and then we started Zoom Scouts. We had a group of regulars attending every week, where we did a variety of badgework, quizzes and a bit of just chat. We took the opportunity to do some of the things that can be hard to fit in on regular scout nights like things needing computers and the internet, and presentations for things like the hobbies and sports enthusiast badges for those who wanted to complete them. (It's much easier for them to show us their collections on line rather than trying to bring everything to Scouts). Plus cooking seems to have been a favourite (and we don't have to clean up after them!)

We did lose a few Scouts through the first lockdown, some becoming too old, others who didn't like Zoom, and others who just found it a convenient time to stop. So we have slightly lower numbers at the moment (although we aren't taking anyone other than our own cubs at the moment due to restrictions on group size, and how it will work when we go indoors socially distanced). The lower numbers have given us the chance to spend more time on things like axe and saw work where we need small numbers to allow everyone to have turns safely without having to wait for too long.

Some Scouts also got involved with the national and county virtual events and camps, or have worked through badges that have interested them at home.

And although we would prefer to be face-to-face all the time, we will keep doing Zoom for now, and may even continue using it for occasional nights in the future, especially where using technology may be useful.

Thanks to all the Scouts, parents and leaders for all their hard work last year, and let's hope the next one is just as good or better.

The accounts for the period 2019-20 are available for review and have been audited by Duncan Bowler from 35th Oxford Scout Group. The Charity Commission return for 2019 will be submitted before the deadline.

Following completion of the 2019-20 accounts, the group continues to be in good financial health. Two jumble sales were held in the year and the group received a number of donations. Many thanks to those people, organisations and all those involved. The funds received have been used to replace and purchase equipment for use on camps and at other group events.

The group did not apply for a grant from the Old Marston Parish Council in the year 2019-20.

Our receipts were up on the previous year (£28,156.26 from £12,400), much of which was due to organised events which is evident in the increased expenditure which was also up (£20452.65 from £9,478)

There was an overall profit of £3,083.33, compared with last year's £2,920.46. Cash reserves are up from the previous year (£16,177.40 from £13,094.07).

The group no longer holds a ring fenced sum for the SAS. The treasurer wishes to express thanks to the SAS for a donation of £155, the remaining money held has been returned to the SAS which has now disbanded.

The treasurer would like to express special thanks to James Brown as counter signatory, Duncan Bowler as auditor and the executive for their continued support.
