## Structure, governance and management

The charity is a Charitable Incorporated Organisation (CIO) formed on 22 August 2013.

## Trustees' report (continued) for the year ended 31 March 2020

#### Objectives and activities

### The charity's objects

To develop the capacity and skills of the members of the socially and economically disadvantaged community of West Bowling in such a way that they are better able to identify, and help address their needs and to participate more fully in society.

## The charity's main activities

Shine delivers a range of community services to bring renewal to one of the UK's most deprived neighbourhoods. These include Job Clubs, Life Skills courses, a Children's Clothes Bank, parenting groups and family support, art and creative activities, wellbeing groups, youth work, care of the homeless and support for the marginalised, asylum seeker and refugee support, English Classes, community events and the provision of a large community green space.

#### **Public benefit statement**

In setting our objectives and planning our activities our Trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular the improvement in community wellbeing.

## Achievements and performance

On an average month Shine helps over 130 individuals who attend activities over 250 hours; some coming every day to drop in and socialise, others to specific groups. These people are from over 40 different ethnicities, and span all ages and faith groups.

At the end of December 2018 the church where Shine operated many of its activities closed while a new heating system was installed. All activities and office space during this time operated from the smaller church hall, which impacted on the number of larger groups that could be undertaken. Staff and volunteers worked hard to manage under these circumstances and continue the majority of services provided.

The church building reopened in July 2019, offering a warm and welcoming area and capacity for large gatherings. There are now fewer small rooms which has led to some reconfiguring of where the varying services take place but has enabled celebrations at key moments such as Christmas to happen in a warm and inviting building.

We have developed a woodland wild area with our gardening group and young people through the National Citizenship Service scheme and have created plans for a further nature area within the churchyard.

The Eden bus has been for 5 days over the year, offering activities for young people close to their homes. In November there was a restructure of the management of Shine with the creation of an Operations Manager post, and the present Manager moving to the position of Charity Lead.

We retained one of our ILM placements on a sessional basis to help with English Chat and Little Dots. We had one final ILM placement before the scheme came to an end.

We joined with women from Madni Centre to form a group 'Together We Can' to speak out and highlight the issues of drug dealing and littering in West Bowling.

We hosted a visit from the Chief Superintendent of the Police as he began his role in the area.

In January two members of staff plus some Little Dots families and a volunteer joined Better Start Bradford in meeting the Duke and Duchess of Cambridge during their visit to Bradford.

The Charity Lead was asked by Better Start Bradford to help lead a community group to look at Adverse Childhood Experiences.

Shine operated under government guidelines for Covid 19 and stopped all groupwork in March. It has continued to support the community through phone calls, social media and the distribution of food (meals and parcels) and activities to individuals and families in the area.

The Trustees met 5 times during the year.

## Trustees' report (continued) for the year ended 31 March 2020

## Objectives and activities

### COVID-19

The coronavirus pandemic has impacted the way Shine operates but has not changed it supporting the community, resources moving to providing telephone calls, online activities and ideas, and delivering food and activities out to the most vulnerable. Grant providers have been happy to continue funding Shine for these activities and consequently no staff have been furloughed. We have received extra grants to provide food and activities etc.

The trustees have reassessed the charity's ability to continue for at least 12 months from the date that the accounts are approved and conclude that no material uncertainties exist that cast significant doubt on the charity's ability to meet its liabilities as they fall due.

#### **Financial review**

The net income for the year was £20,042, including net income of £13,471 on unrestricted funds and net income of £6,571 on restricted funds (after transfers).

## Reserves policy

The charity's free reserves at the year end were £93,112.

The Trustees have reviewed the charity's need for reserves in line with guidance issued by the Charities Commission and consider it prudent that free, unrestricted reserves need to be sufficient to meet four to six months running costs. This policy is reviewed by the Trustees annually in line with the risk analysis and financial management situation.

The Trustees are aware the reserves held at present are above the amount in our policy. Since the renovations in the main building used for Shine purposes there is a need for a new office to be erected and it is our expectation that we will use reserves money on this in the year ahead.

# Shine (West Bowling) Notes to the accounts for the year ended 31 March 2020

## 1 Accounting policies

## **Basis of accounting**

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) and with the Charities Act 2011.

The charity constitutes a public benefit entity as defined by FRS 102.

There has been no change to the accounting policies since last year.

No changes have been made to the accounts for previous years.

## Going concern

The trustees are satisfied that there are no material uncertainties about the charity's ability to continue.

### **Incoming resources**

All incoming resources are included in the Statement of Financial Activities (SOFA) when the charity becomes entitled to the resources, it is more likely than not that the trustees will receive the resources and the monetary value can be measured with sufficient reliability.

#### **Grants and donations**

Grants and donations are only included in the SOFA when the charity has unconditional entitlement to the resources.

Where grants are related to performance and specific deliverables, they are accounted for as the charity earns the right to consideration by its performance.

### **Expenditure and liabilities**

Expenditure is recognised on an accrual basis as a liability is incurred. Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out the resources and the amount of the obligation can be measured with reasonable certainty.

#### **Taxation**

As a charity the organisation benefits from rates relief and is generally exempt from income tax and capital gains tax but not from VAT. Irrecoverable VAT is included in the cost of those items to which it relates.

#### **Pensions**

The charity operates a defined contribution scheme for the benefit of its employees. The costs of contributions are recognised in the year they are payable.

### **Fund accounting**

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

Further explanation of the nature and purpose of each fund is included in the notes to the accounts.
